- 3 Controlling Risks:** Evaluating risk using a risk matrix and choosing the right methods for your business.
- 4 Understanding Responsibilities:** Navigating civil and criminal law without the jargon.
- 5 Identifying Hazards:** Recognising common workplace issues, including fire, noise, manual handling, chemicals, stress, and physical abuse.
- 6 Investigating Accidents and Incidents:** Understanding root causes, the benefits of investigating, and how to carry out a structured investigation.
- 7 Measuring Performance:** Using proactive and reactive data, performance indicators, and auditing to drive continuous improvement.

Upon successful completion of both assessments, delegates will be awarded the internationally respected IOSH Managing Safely® Certificate. This is an RQF Level 2, SQF Level 5, and NQF Level 3 qualification. The certificate does not expire, though a one-day refresher course is highly recommended every three to five years to stay current with best practices.
