We use game-like mechanics to make charitable giving engaging, but **we are NOT a video game** - we are a fundraising platform for real-world humanitarian and environmental projects across 8 countries.

Fund Allocation Discretion:

We reserve full discretion to allocate funds based on urgent needs, field conditions, and maximum impact potential, regardless of hero selection or initial mission descriptions.

7. Your Rights & Responsibilities

Eligibility:

You must be 18+ (or age of majority) with legal capacity to make charitable donations. Minors need parent/guardian consent.

Prohibited Activities:

Do NOT: (1) use the platform for fraud or money laundering, (2) harass staff or supporters, (3) hack or compromise security, (4) commercially exploit hero characters, or (5) misrepresent affiliation.

Your Privacy:

We collect personal and payment info to process donations and provide updates. We do NOT sell your data. See our full Privacy Policy for GDPR rights and data protection details.
