MONS MAPS COMMISSION TERMS

Thank you for considering a custom fantasy map. These terms are intended to ensure a smooth and enjoyable collaboration for both of us. If you have any questions before commissioning a map, please don't hesitate to get in touch.

WHAT YOU CAN EXPECT

Every map is hand-drawn and created specifically for your world. Whether you're an author, worldbuilder, game master, or simply bringing an imagined place to life, each commission is crafted with care and tailored to your vision.

THE COMMISSION PROCESS

Once your commission is confirmed, I'll begin by creating an initial sketch based on the information you provide.

You'll have the opportunity to review the sketch and request reasonable revisions during this stage to ensure the map reflects your vision.

After you approve the sketch, I'll move on to inking the artwork in.

Because significant changes become much more time-consuming after the final rendering has begun, revisions beyond the approved sketch stage may incur additional fees and may extend the delivery timeline.

PAYMENT

A 50% non-refundable deposit is required before work begins. This secures your place in my commission schedule and allows work on your map to commence.

The remaining balance is payable upon completion of the artwork and before the final high-resolution files are delivered.

Payments can be made via:

- Stripe (credit/debit card and supported payment methods)
- PayPal

- Bank transfer to my designated bank account

Payment details and invoices will be provided before payment is due.

Please note that any transaction fees charged by your payment provider or financial institution are the responsibility of the Client.

DELIVERY

Completed maps are delivered digitally as high-resolution, print-ready files, to your designated email address.

Estimated delivery times will be agreed upon before the commission begins. While every effort is made to meet the agreed deadline, unexpected circumstances may occasionally require adjustments. If this happens, I will communicate any changes as early as possible.

COPYRIGHT & LICENSING

The artwork remains the intellectual property of the Artist.

Commissioning a map does not transfer copyright ownership.

Upon full payment, you receive a perpetual licence to use the commissioned map for the purposes agreed upon in your individual commission agreement.

Any uses outside those agreed terms—including unrelated commercial projects, licensing to third parties, film or television productions, or other commercial exploitation—require prior written permission by Mons Maps.

COMMERCIAL USE

If your commission is intended for commercial publication, merchandise, crowdfunding campaigns, games, or other commercial projects, the appropriate licence will be discussed and included in your commission agreement.

Every project is different, and commercial rights are tailored accordingly.

PORTFOLIO & PROMOTION

Unless otherwise agreed in writing, I reserve the right to display the finished artwork in my portfolio, on my website, and across my social media channels as part of my professional work.

If your project has not yet been announced or published, I will happily wait until its public release before sharing the artwork.

CLIENT RESPONSIBILITIES

To help create the best possible map, please provide clear descriptions, reference materials, and any important details before work begins.

You confirm that any reference materials you provide may be lawfully used for the commission.

ARTIFICIAL INTELLIGENCE

The commissioned artwork, including sketches, drafts, and final files, may not be used for training, developing, or improving artificial intelligence or machine-learning models without my prior written permission.

CANCELLATION

If you choose to cancel your commission after work has begun, the initial deposit is non-refundable and covers the work completed up to that point.

If I am unable to complete the commission for reasons within my control, any payments made beyond the value of completed work will be refunded.

GOVERNING LAW

These terms are governed by the laws of the Republic of Croatia.

Individual commission agreements may contain additional terms specific to each project.
