- **Evidence:** Step-by-step walkthroughs, exact entry/exit times, and real-world trade examples with supporting charts and logic flowcharts.

4. Risk Management & Psychological Framework: 10/10

- **Strengths:** The "Bias Trust Ladder" is an elegant solution for dynamic position sizing based on conviction scores. The system's core philosophy of "One Trade Focus" and "Law of Large Numbers (LLN)" instills a disciplined, probabilistic mindset crucial for long-term survival and success. It directly combats overtrading and emotional decision-making.
- **Evidence:** Detailed in 2_Main_Guide.pdf (Section 6) and reinforced in the "GERMS TO ALWAYS REMEMBER" (Section 15).

5. Proof & Performance Verification: 8/10
