

Proclamation of Self Determination and Standing in Sovereign State as an Association of Sovereigns in Alignment with Proclaimed Hapu.

In Natural and Ordinary English Language.

*To ALL and SINGULAR; Hereto on the 8th day of April in the year Two Thousand and Twenty-Six CE, We the People of **Te Rōpū Tautoko Collective**, enacting Our Creator given Right of Self Determination, being Our indefeasible Right as living Souls embodied in Human Vessels to determine Our own affairs whilst causing no harm, and to live together peacefully and harmoniously in Our chosen Order. Also, Our Standing in Sovereign State, being Our Covenant with the Creator committing mind, body and Soul in Honour of the Creator and in service to ALL Humanity, most especially the children.*

Do hereby with One Voice and Consent of Tongue and Heart Promulgate, Publish and Proclaim Our enacting Our Self Determination and Our Sovereign State through Our Ancestral Right and Our Customs and Usage, Our Prior Right, and Our responsibility and authority absolute over Our Lives and Property.

So to Our Honouring and Enactment of the internationally recognised 1835 He wākaputanga o te Rangatiratanga o Nu Tireni cf. Proclamation of Sovereign State of Nu Tireni, and Our standing in beneficial alliance with the Proclaimed Sovereign Hapu, being a member of the internationally recognised Congress of Proclaimed Hapu Ko te wākaminenga o nga Hapu o Nu Tireni cf. Sovereign Order and Customary Law Jurisdiction of Nu Tireni. Also, Our Honouring and Upholding, to the best of Our abilities, the Standing Agreement of the Parties, between Victoria, Queen of England, and nga Rangatira o nga Hapu o Nu Tireni, being the international law Te Tiriti o Waitangi of 1840.


*We the People of **Te Rōpū Tautoko Collective**, acknowledge and respect the Ancestral Right and Prior Right of the Proclaimed Hapu of Nu Tireni, their Sovereign Order, the Customary Law Jurisdiction, and their internationally recognised Congress, being Ko te wākaminenga o nga Hapu o Nu Tireni, and that Hapu Tikanga cf. Customs and Usage – Customary Law Jurisdiction, is the paramount authority of each Proclaimed Hapu and reigns supreme over the Common Law and over all legislation, in the respective Hapu territories of Nu Tireni.*


By the passing of Nga Tupuna cf. the Ancestors, We are called to Honour and fulfil the duties and responsibilities of the Proclamation of Sovereign State of 1835 and our Customary Law Jurisdiction and Constitutional Order of the territory of Nu Tireni, and the sanctuary they granted Our forebears.

*Thus, We the people of **Te Rōpū Tautoko Collective** are fully committed to upholding Self Determination and Sovereignty of all peoples. As such We are neither property nor possession of any association nor entity. Nor are We bound by any Crown, nor jurisdiction, legislation, nor Law, nor Contract that We have not knowingly, willingly, with full disclosure, informed consent and of Our freewill agreeance, entered into.*
