and operated by the Speclang team (“we”, “us”, “our”). By accessing these Websites, you acknowledge and accept the terms outlined below.

Certain creative works displayed on these Websites, including all elements of the Axtlan project, are hosted by Speclang but owned solely by their respective author, who publishes under the artistic name “Xixicor”.

1. Acceptance of Terms

By browsing or using the Websites, you confirm that you have read, understood, and agree to be bound by this Agreement. If you do not agree with these Terms, you must discontinue use of the Websites. Access to the Websites, its content, and any related services is provided only to users who accept these Terms.

2. Privacy

Before continuing to use the Websites, please review our Privacy Policy available at <https://legal.speclang.pro>. It explains how we handle user information and outlines our data practices.

3. Age Requirements

Use of these Websites is restricted to individuals aged 16 years or older. By accessing these Websites, you represent that you meet this age requirement and are legally capable of entering into this Agreement. If you are under the legal age to consent, a parent or legal guardian must agree on your behalf. We are not responsible for any false statements regarding age or eligibility.

4.1 Trademark Ownership

Nothing in these Terms grants users any license, assignment, or transfer of intellectual property rights beyond the limited permitted use described in Section 5.

4.4 Ownership of the Axtlan Universe

Xixicor (“Author”) is the artistic name under which the Author creates and publishes the Axtlan universe.

The Axtlan world-building project—including all artwork, characters, names, storylines, symbols, lore, illustrations, visual assets, and narrative elements—is the exclusive intellectual property of its author, Xixicor (“Author”). Speclang does not own the Axtlan universe; Speclang only provides hosting, publication, and platform services for the Author. If Speclang ceases operations or the website is discontinued, all intellectual property rights in Axtlan remain solely with the Author. Nothing in these Terms transfers, assigns, or licenses ownership of Axtlan to Speclang.

5. Permitted Use of the Website

You may access the Websites and save or print limited portions of its content for personal, private, and non-commercial use—such as study, reference, or research—provided that:

- all content remains intact and unaltered,
- all copyright, trademark, and ownership notices remain visible, and
- our authorship of the materials is clearly acknowledged.

Your permitted use of Axtlan materials is limited to what is expressly allowed by the Author and does not grant you any ownership or derivative rights. Axtlan materials may not be used for commercial, derivative, or creative reinterpretation purposes without the Author’s explicit written authorization.

6. Prohibited Conduct

You agree that you will not:

- reproduce, modify, distribute, upload, frame, repost, or transmit Website content except where expressly permitted;
- use Website content separately from its accompanying context or text;
- exploit Website content for commercial purposes without our written authorization;
- use automated tools such as bots, scrapers, or crawlers to access or monitor the Websites;
