

## OVERVIEW



**Negotiations on the Free Trade Agreement (FTA) between India and the European Union have made notable progress, with several technical chapters having been concluded and others broadly agreed upon in principle. However, a set of core economic and regulatory chapters remains partially open, forming the principal bottlenecks to the timely and balanced conclusion of the agreement.**

**These bottlenecks are not merely technical. They reflect deeper divergences in :**

- economic structure and development levels,
- regulatory philosophies and compliance regimes,
- services, mobility and market access priorities, and
- sustainability and climate-linked trade measures.

**The roundtable is being convened at a particularly consequential moment, with the European Union's top leadership expected to visit India around Republic Day 2026, alongside high-level India–EU engagement that is widely anticipated to place the FTA at the centre of discussions. This creates a narrow policy window where credible, structured recommendations can be especially valuable to stakeholders on both sides.**

**This roundtable will bring together experts to examine the most pressing bottlenecks, identify feasible pathways for convergence, and generate policy-ready recommendations aligned with negotiation realities.**



## SCOPE OF DISCUSSION



The roundtable will focus on structural, political, and regulatory bottlenecks that continue to delay or complicate convergence on the India–EU FTA. The scope includes :

- Examination of partially open chapters that are deal-defining
- Assessment of select open chapters that directly interact with unresolved areas
- Identification of trade-offs, sequencing options, and implementation flexibilities
- Consideration of domestic political constraints and ratification dynamics
- Exploration of how the FTA can remain balanced, development-sensitive, and future-oriented

The discussion will remain solution-driven and will aim to generate actionable inputs relevant to policymakers, negotiators, and stakeholders.





## KEY THEMES



### a. Market Access and Industrial Sensitivities

- Tariff liberalisation vs protection of sensitive sectors
- Phasing mechanisms, safeguards, and calibrated exclusions

### b. Services Trade and Professional Mobility

- Mode 4 feasibility under political constraints
- Recognition of qualifications and regulatory cooperation

### c. Sustainability, Climate, and Trade Conditionality

- Trade and Sustainable Development commitments
- Climate-linked measures and transition/implementation flexibilities

### d. Supply Chains and Rules of Origin

- Preventing trade deflection while enabling value-chain integration

### e. Digital and Investment Governance

- Data governance differences and digital trade norms
- Investor protection and dispute settlement design



## KEY GUIDING QUESTIONS



### Partially Open: Market Access for Goods

1. What are the most critical tariff-related bottlenecks in Market Access for Goods, and which sectors are politically non-negotiable for each side?
2. What sequencing models (staging, tariff-rate quotas, safeguards, carve-outs) can balance domestic sensitivities with meaningful market access?

### Partially Open: Trade in Services

1. What forms of commitments under Trade in Services—including Mode 4—are politically feasible within the EU while still being meaningful for India?
2. Can sector-specific, skills-based, or quota-based mobility frameworks provide a pragmatic middle ground?

### Partially Open: Trade and Sustainable Development

1. How can commitments under Trade and Sustainable Development be aligned with development realities without weakening credibility and enforceability?
2. What transition mechanisms, flexibilities, or cooperation instruments can reduce friction from climate-linked trade measures?
