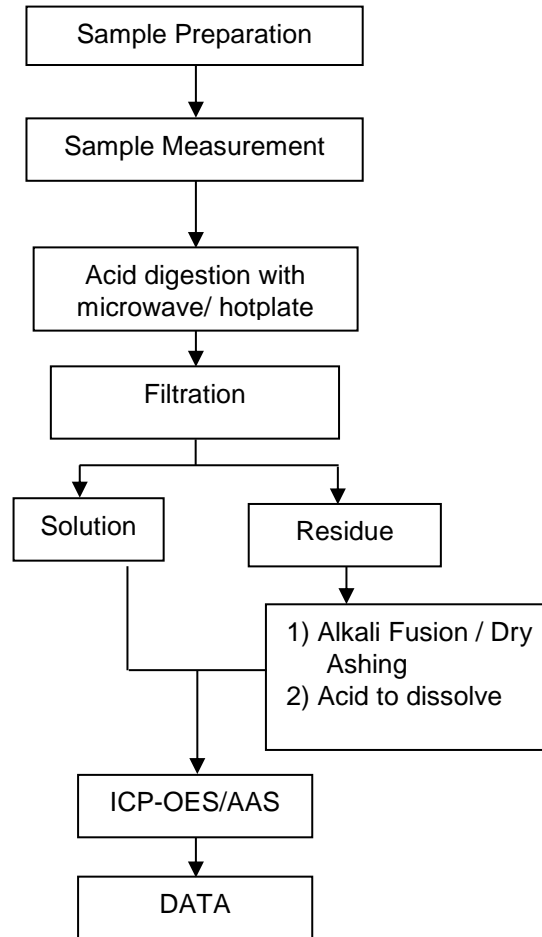

### Elements Testing Flow Chart

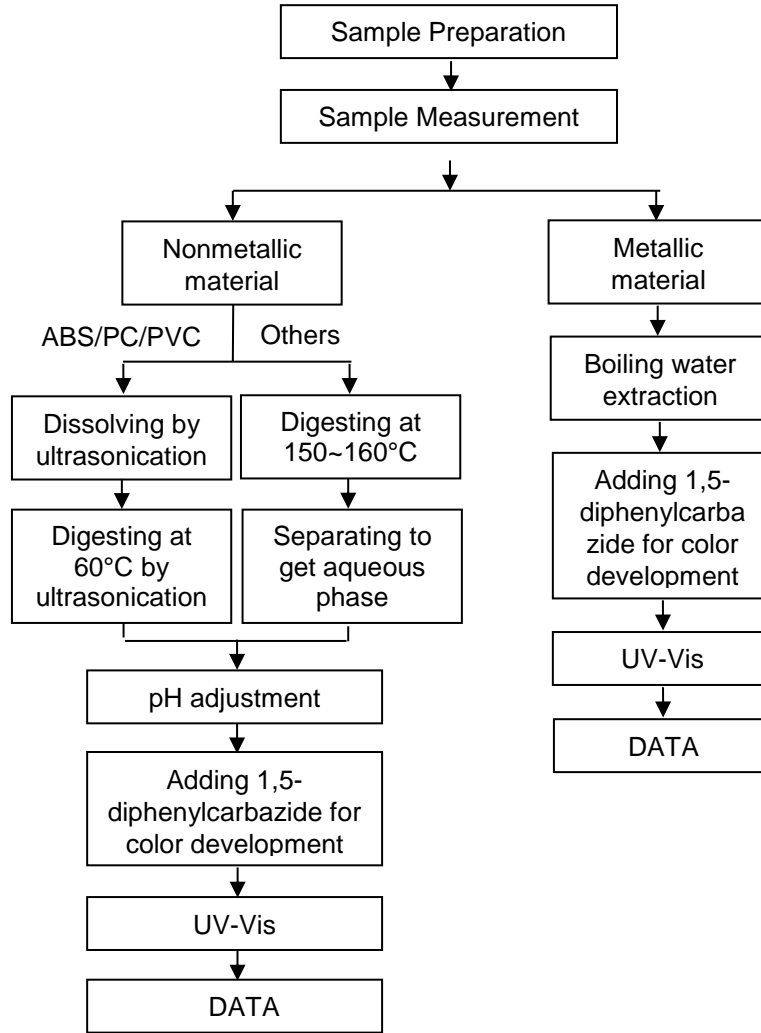

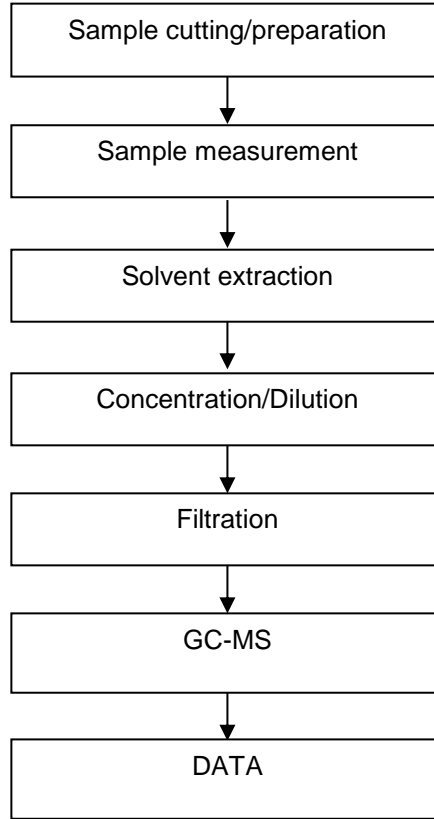

**Hexavalent Chromium (Cr(VI)) Testing Flow Chart**



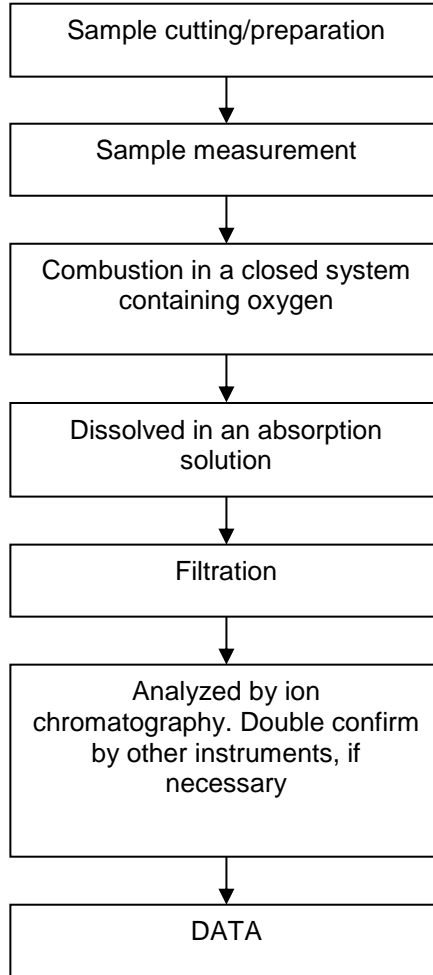
**PBB/PBDE/Phthalates Testing Flow Chart**

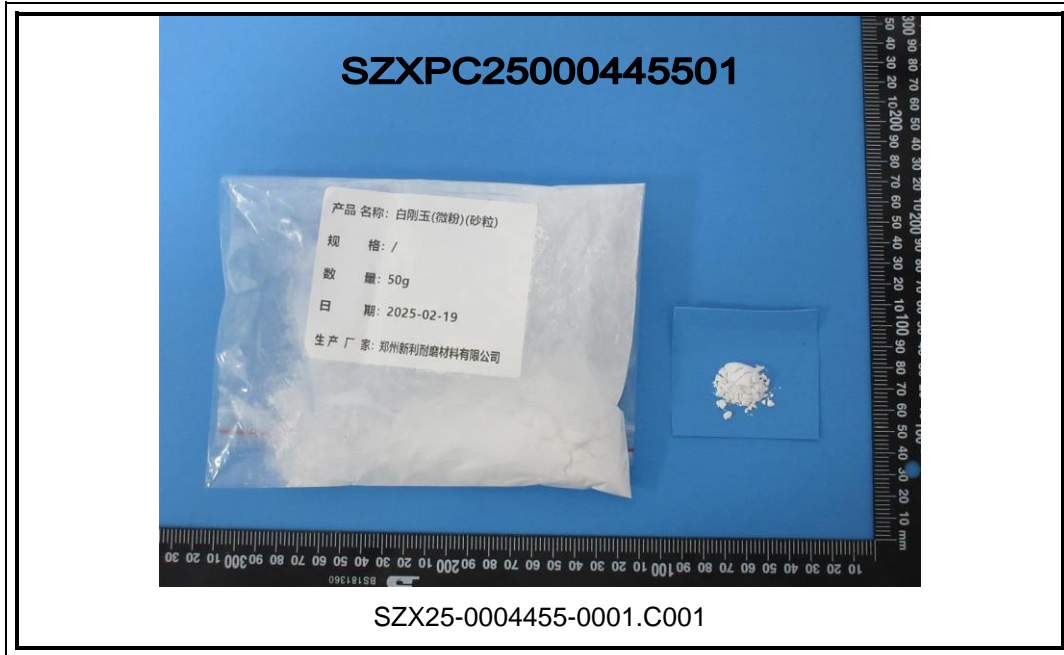
