The purpose of this Statement is to obtain information relating to your eligibility to invest under Regulation A (Tier 1) of the Securities Act of 1933. Regulation A offerings are available to both accredited and non-accredited investors, subject to the following conditions:

1. Accredited Investors (as defined in Regulation D, Rule 501(a)) may invest without limitation.

2. Non-Accredited Investors are subject to investment limits. A natural person who is not an Accredited Investor may invest no more than 10% of the greater of his or her annual income or net worth. An entity that is not an Accredited Investor may invest no more than 10% of the greater of its annual revenue or net assets.

3. For the purposes of this determination:

- **“Net worth”** means total assets minus total liabilities, and excludes the value of a primary residence.
- **“Annual income”** means adjusted gross income as reported for federal income tax purposes.

You will be asked to provide information regarding your income, net worth, and investment amount to ensure compliance with these limits.

This Investor Questionnaire is being furnished in connection with a proposed investment in the securities of the Company pursuant to **Regulation A (Tier 1) of the Securities Act of 1933, as amended (the “Act”)**. The purpose of this Questionnaire is to enable the Company to determine whether you are eligible to invest under the requirements of Regulation A, including the investment limitations applicable to non-accredited investors.

The information supplied will be used solely by the Company to comply with U.S. federal securities laws and will be kept in strict confidence, except as may be required by regulators or law. By completing and signing this Questionnaire, you represent and warrant that the information provided is true, complete, and accurate, and you acknowledge that the Company is relying on your responses to determine your investment eligibility.

B. INVESTOR ELIGIBILITY

- Certain licensed financial professionals (e.g., Series 7, 65, or 82 holders).
