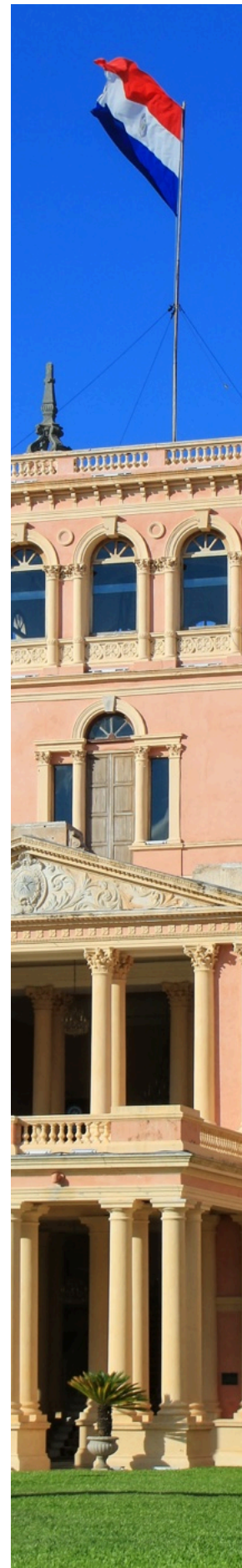

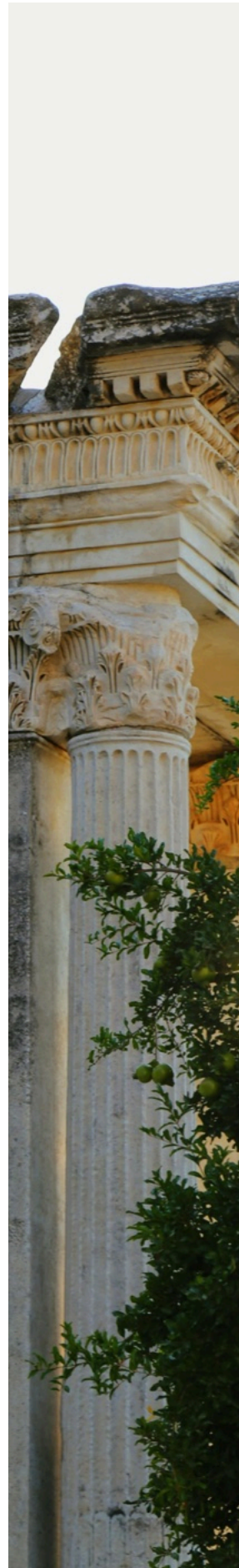

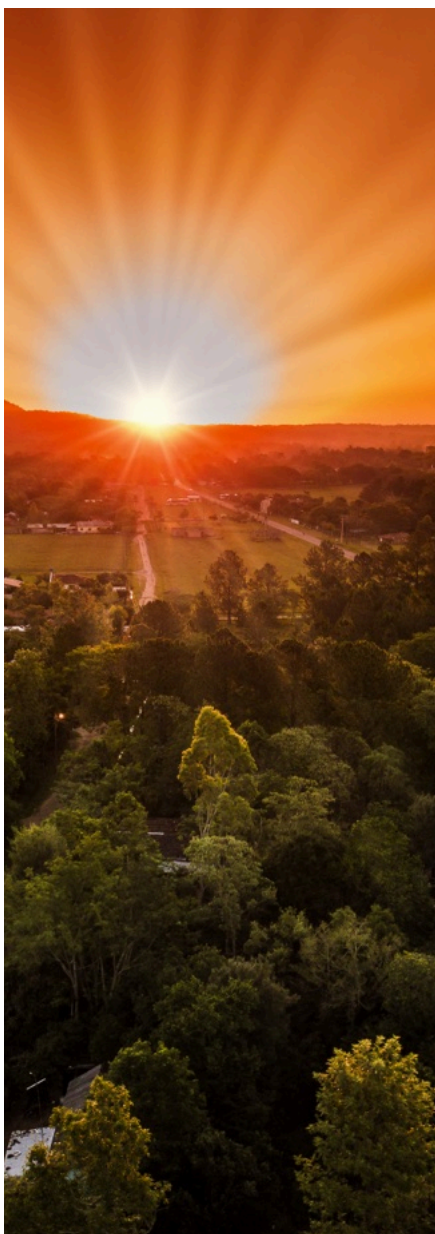

## Why

# Paraguay?



*Paraguay is not the most famous country in the world. That is precisely what makes it interesting. While other popular expat destinations become more crowded, expensive, and bureaucratic, Paraguay has remained calm and manageable — with a residency procedure that is clear, affordable, and genuinely achievable.*

Our clients come in two varieties. Plan A people are ready to make a definitive move and are looking for a country where they can live, build, and invest for the long term. Plan B people want a residency as a safety net — a legal exit option if ever needed, or as a stepping stone towards a future relocation they are not ready for yet. For both groups, Paraguay offers one of the strongest options in the world.

Paraguay is growing in popularity among international entrepreneurs, digital professionals, and families seeking stability and freedom. But it remains far removed from overcrowded visa programmes, which means the procedure stays clear and accessible.

## Low cost of living

Paraguay is one of the most affordable countries in South America for those earning in a strong foreign currency. A comfortable life in Asunción — with a good apartment, quality restaurants, private healthcare, and leisure time — is achievable at a fraction of what it would cost elsewhere.

A family of four can live comfortably for \$2,000–2,500 per month including rent. Those who prefer a premium lifestyle with international schools and a spacious villa will pay more, but even that remains significantly cheaper than comparable comfort in Western Europe.

***Electricity: extremely low — Paraguay has the cheapest power on the continent thanks to the Itaipú dam.***

***Healthy food: approximately 40–60% cheaper than in Western Europe.***



### Some reference figures:

- 1 Apartment rental (2 bedrooms, modern, Asunción): \$650–1,100/month
- 2 Private healthcare: available and affordable, hospital insurance from approximately \$50–80/month
- 3 Dining out: a good restaurant dinner for \$15–20 per person

# Territorial tax system

Paraguay operates a territorial tax system. This means the Paraguayan tax authority only levies tax on income generated within Paraguay. Income from abroad — whether you have clients elsewhere in the world, hold foreign investments, or generate online revenue through foreign platforms — falls outside its scope.

For entrepreneurs, freelancers, and investors who earn the majority of their income outside Paraguay, this is an exceptionally favourable situation. There is no wealth tax, no inheritance tax, and the overall tax burden is one of the lowest on the continent.

**Important: the territorial system has rules. Your income sources need to be correctly classified and your tax registration must remain active. We can assist you through the experts in our network.**

Paraguay does not make headlines with political crises. The government actively pursues policy to attract foreign capital. The currency (Guaraní) is stable and inflation is manageable. Paraguay sits far from active conflict zones and is not involved in the geopolitical tensions that destabilise other regions.

## Favourable business environment

Paraguay has a low-tax and lightly regulated economy. Company formation is relatively fast and affordable. The local population is entrepreneurially minded and the government interferes little with day-to-day business operations. Sectors such as real estate, agriculture, energy, and logistics are growing strongly. Paraguay also borders Brazil — a market of over 200 million people directly accessible from Asunción. For those looking to build a platform in the region, Paraguay's location is strategically strong.

## The Maquila Regime

Paraguay has a particularly attractive industrial regime for foreign companies: the Maquila system. This allows products to be processed or assembled in Paraguay using foreign raw materials or semi-finished goods, and then exported — at **a flat tax rate of just 1%** on added value.

- Ideal for production, assembly, logistics, and services — including digital services like software development, SaaS, BPO, and remote services
- Export worldwide at the 1% rate — including to Mercosur countries (Brazil, Argentina, Uruguay), where additional origin rules may apply for tariff-free access
- Government actively supports Maquila applications

**NOTE:** The Maquila regime is particularly interesting for companies targeting Europe, North America, Asia, or Mercosur (Brazil, Argentina, Uruguay) as their end market, who want to structure their operations more cost-effectively and tax-efficiently. 1% tax on added value — one of the lowest production regimes in the world



Free import of raw materials, machinery, and components — temporarily duty-free



Full profits to your foreign holding — no dividend withholding tax when distributing profits abroad



## Straightforward residency procedure

Paraguay does not require a large investment, property purchase, bank deposit, or proof of passive income to obtain a temporary residence permit. You need your passport, a criminal record check, a birth certificate, and a few other standard documents — all things you already have or can easily arrange.

As a temporary resident you are required to be present in Paraguay for at least 1 to 2 days within 365 days of your application. With permanent residency this reduces to a minimum of 1 to 2 days every 3 years.

The entire process can be completed in one trip to Paraguay. With Express and Premium we actively bypass the queues at Migraciones. The average processing time for both the residency card and cédula is approximately 4 months. A rushed process is available for clients who need to move faster. Essential follows the standard procedure with an average timeline of approximately 6 months.

*There are multiple providers offering residency in Paraguay. That means you have a choice, and that is a good thing. But it also means you need to be critical about who you let handle this. A residence permit is a legal document — mistakes cost you time, money, and sometimes the permit itself.*

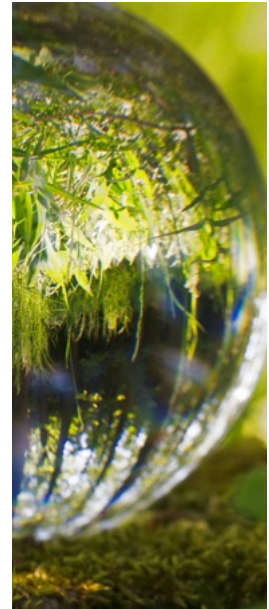
Our team is based in Asunción. We know the city, the procedures, the offices, and the contacts that matter. That is not a marketing line — it makes a practical difference. When procedures change at Migraciones, we find out quickly. When a file runs into a problem, we know how to address it. We are on the ground, every day.

We currently offer our services in Dutch, English, and Spanish, with Portuguese and Italian planned. You can count on all communication, document review, and process guidance happening in a language you understand — without translators or middlemen getting in the way.

## Transparent approach

We work with fixed packages and transparent pricing. No hidden costs, no vague hourly rates, no surprises afterwards. Before you start you know what you pay, what you get, and what you need to arrange yourself.

We also always check your documents remotely before you book your flights — our remote document review system. We assess whether everything is in order so you do not arrive with the wrong paperwork. Documentation errors are the most common cause of delays, and our pre-check prevents exactly that.



## More than just paperwork

We guide you through the residency application, but we are there afterwards too. The moment you land, we make sure you are immediately online with a temporary SIM card. From there we can assist you further with your RUC registration, tax filings, tax planning, advice on local real estate investment, or setting up a company.

# The residency

## process explained



*The residency process in Paraguay is more straightforward than in most countries. There are no points systems, no embassy queues at home, and no annual income requirement. At Migraciones there are queues, but with Express and Premium we bypass these through the right channels. That said, it is crucial that you follow the steps correctly — an error in documentation or incorrect apostilling can cause delays.*

## The 1-trip and 2-trip method

With the 1-trip method (Express and Premium Package) you wrap everything up in one visit to Paraguay. You complete the full residency application and arrange the cédula application during that same trip. When your documents are ready, we ship them worldwide via DHL — complimentary with the Premium package, available as a paid add-on with Essential and Express.

With the 2-trip method (Essential Package) you submit your application during your first visit. You then return within 365 days — this is a mandatory visit for all residents — which is also the right moment to submit your cédula application. Essential is specifically designed for clients who choose this method.

MyParaWay guides you through both phases. Permanent residency provides the strongest legal foundation for the long term and is the natural next step after your temporary residency expires.



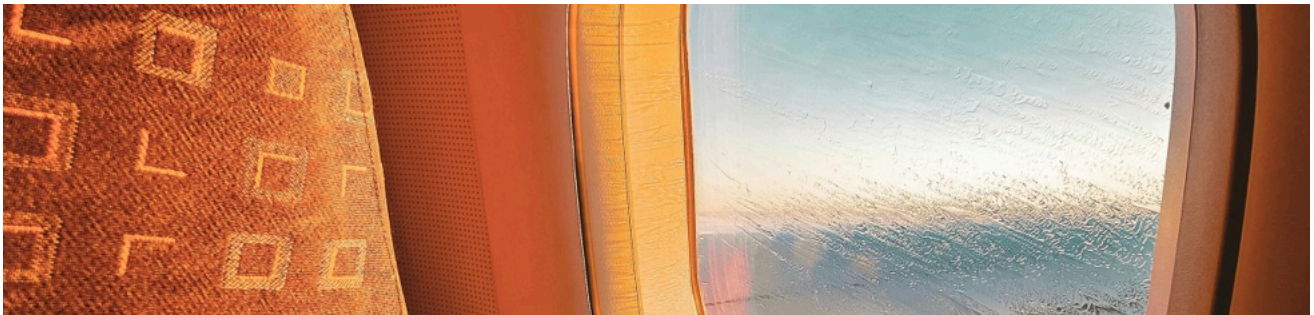
**Please note that processing times with Essential are longer than with Express and Premium, as this package follows the standard procedure at Migraciones.**

## Temporary vs. permanent residency

- ✓ **Temporary residency (2 years):** This is the first step. You apply during your visit to Paraguay. Upon approval you receive a temporary residence permit valid for two years.
- ✓ **Permanent residency:** After your temporary residency you can apply for a permanent residence permit. This requires a new visit and an updated file. Permanent residency offers greater security and opens the door to Paraguayan citizenship after three years.

# Document checklist before your flight

These are the documents you need for your application. We check all of them before you book.



## Passport

Valid passport (minimum 6 months validity after arrival date).

## Birth certificate

Birth certificate — with apostille from your country of origin.

## Criminal record check

Criminal record check (VOG or equivalent) — recent, with apostille.

## Marriage certificate

Marriage certificate (if applicable) — with apostille.

*All foreign documents must be apostilled in the country of origin and are then translated in Paraguay by an authorised Paraguayan translator. We arrange this for you on the ground.*



## What happens during your visit

The moment you arrive in Asunción, we are ready for you. We ask all clients to keep their first week flexible. Paraguay operates at its own pace and several steps in the process depend on third parties and government offices outside our direct control. We cannot tell you in advance exactly when each appointment will be scheduled — but we handle the planning and guide you through every step.

*All transfers are by private transport. You do not need to worry about navigation, queues, or communication — we handle it.*

A typical residency visit includes:

- Pick-up from the airport and transfer to your accommodation
- Temporary SIM card so you are immediately online
- Private transport to all relevant government offices
- Submission of your residency application at Migraciones
- Biometric registration for the cédula (fingerprints, photo)

## After your visit

After submission, Migraciones processes your file. Once your cédula is ready, we ship your documents worldwide via DHL — complimentary with the Premium package, available as a paid add-on with Essential and Express. We keep you informed as your file progresses

All residents are required to return to Paraguay within 365 days of their application for a minimum stay of 1 to 2 days. For Essential clients, this is also the right moment to submit the cédula application.



Once your temporary residency is established, you can apply for **permanent residency** in due course. We guide you through that step too, including updating your file and planning your visit.

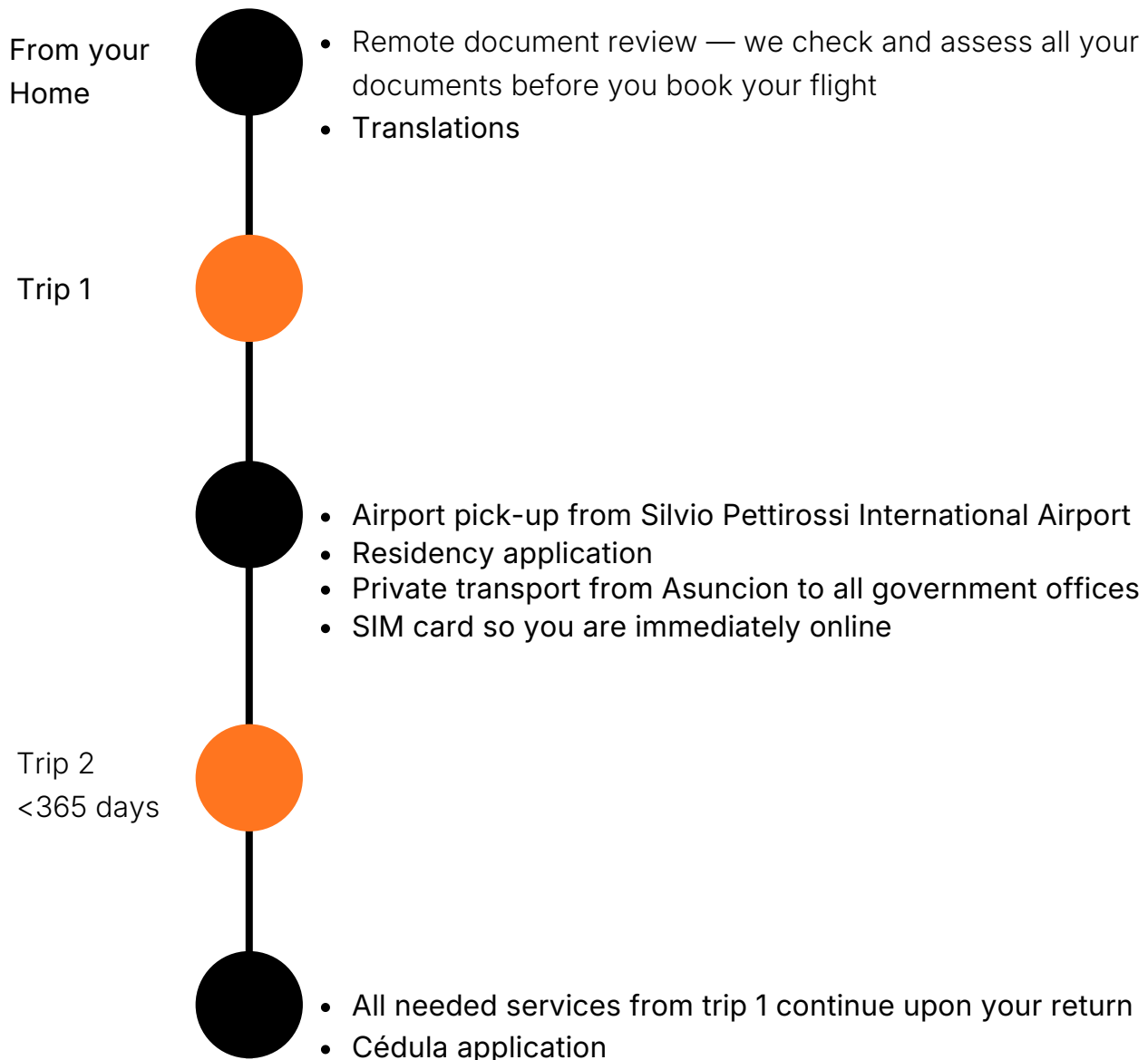

## Essential (2 trips)

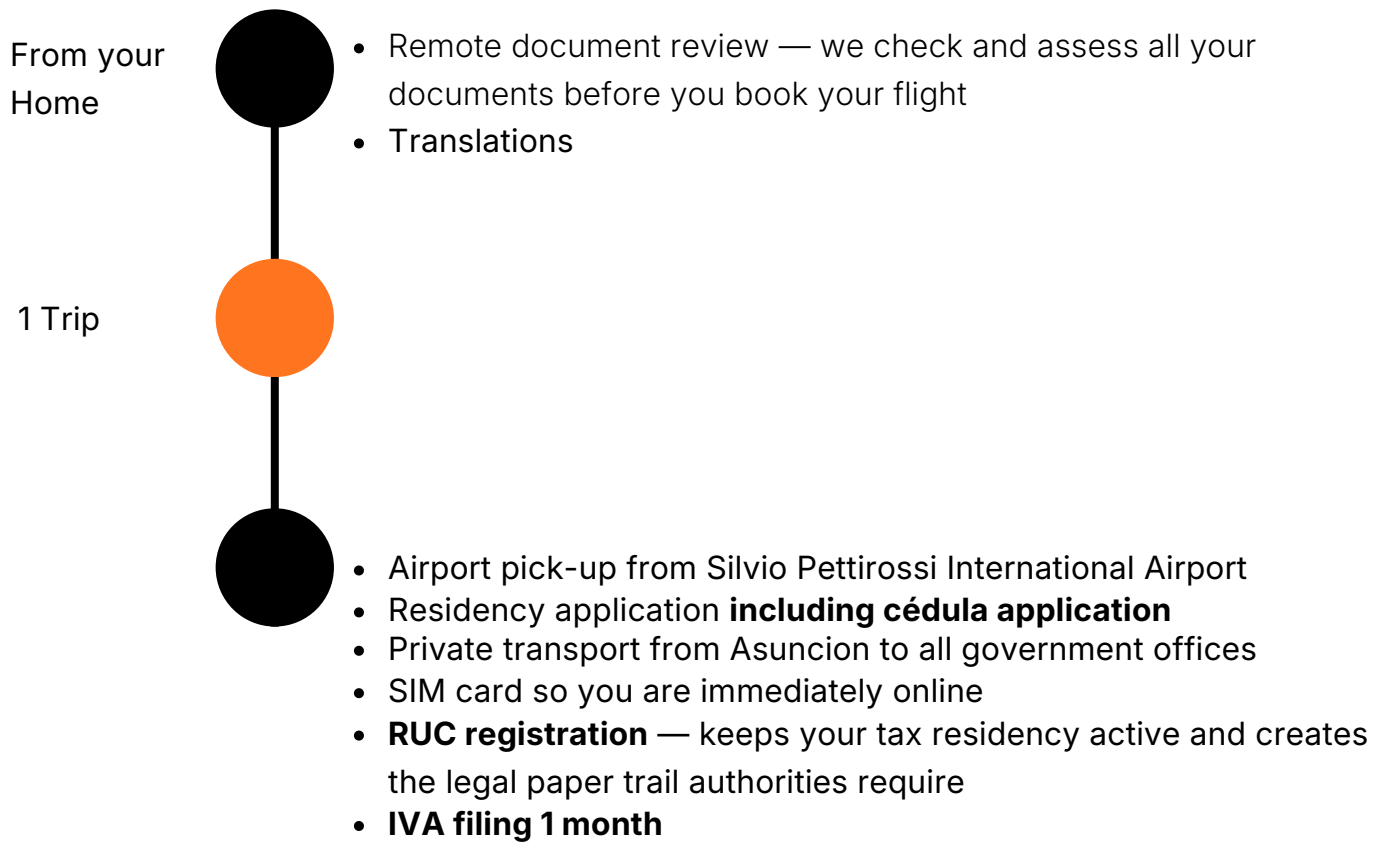
For those who submit their application on trip 1 and arrange their cédula application during the mandatory visit within 365 days. The most affordable option, with an average processing time for the residency of approximately 3 months.



**Note:** The cédula application is submitted during the mandatory visit within 365 days — not collected. Make sure your criminal record check is still valid at that point; for most clients it will have expired and will need to be renewed.

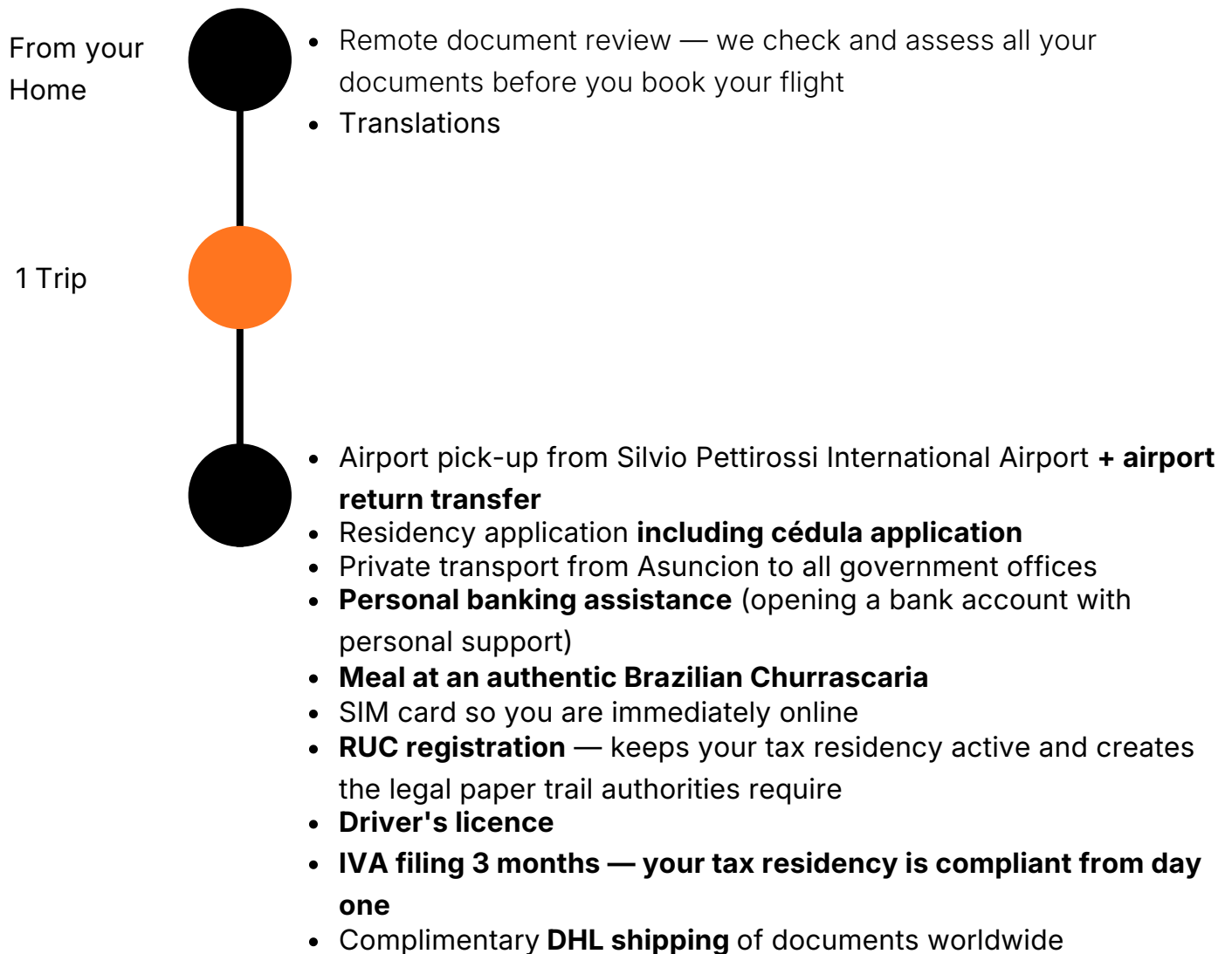
## Express (1 trip)

Everything completed in one visit, including the cédula application. Average processing time for both the residency card and cédula approximately 4 months.



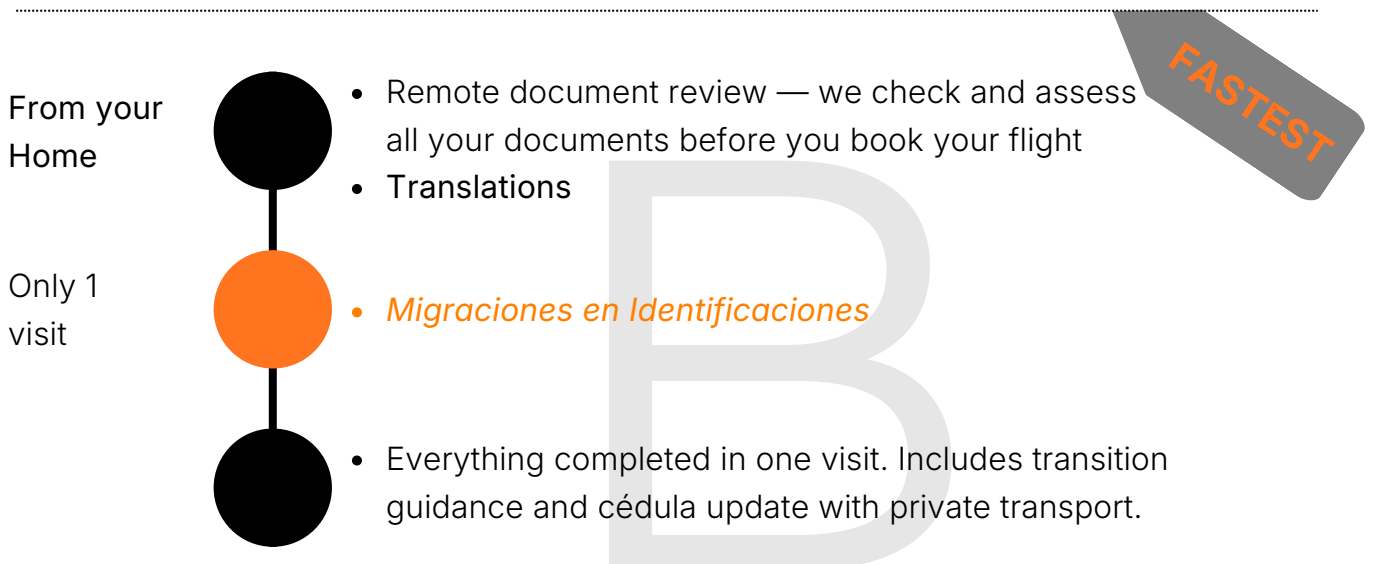
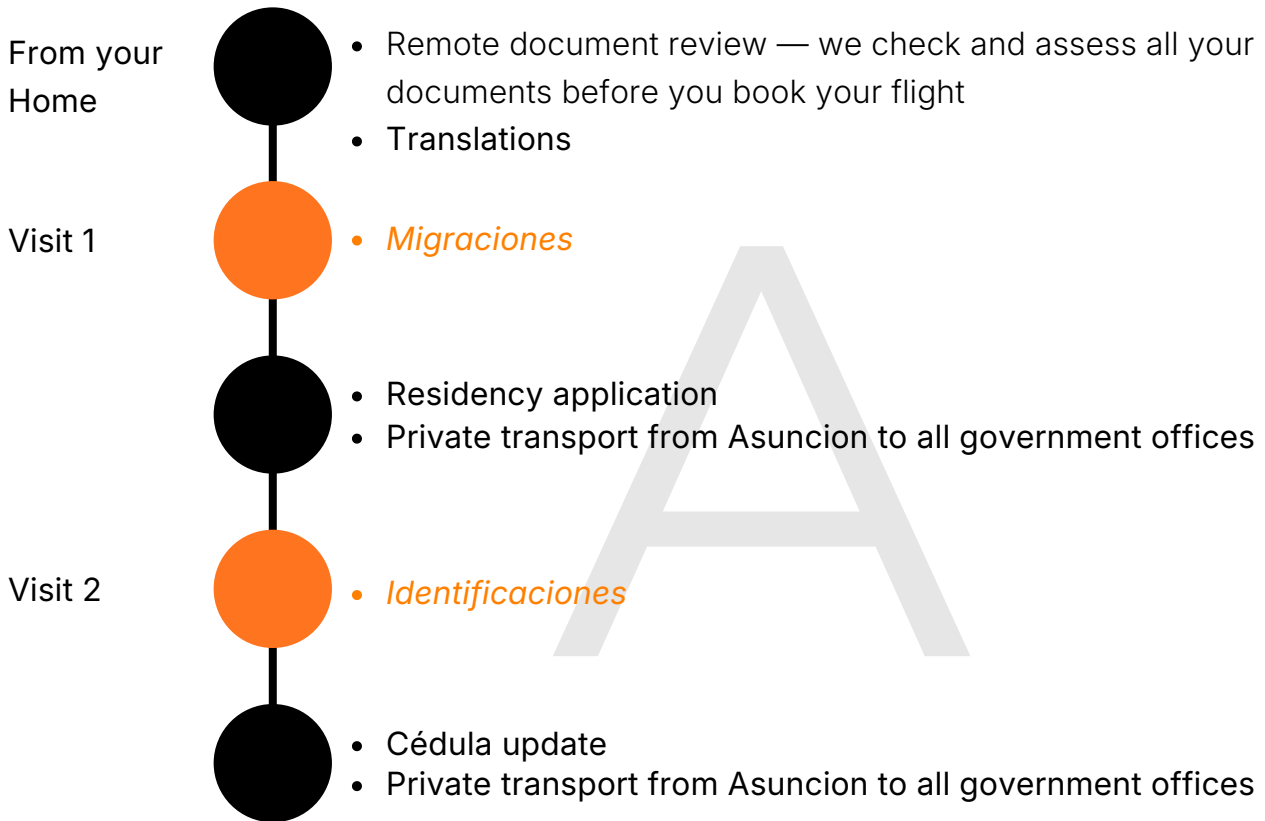
## Premium (1 trip)

Fully taken care of, including personal banking assistance, a meal with the MyParaWay team at an authentic Brazilian Churrascaria, and driver's licence. Average processing time for both the residency card and cédula approximately 4 months.



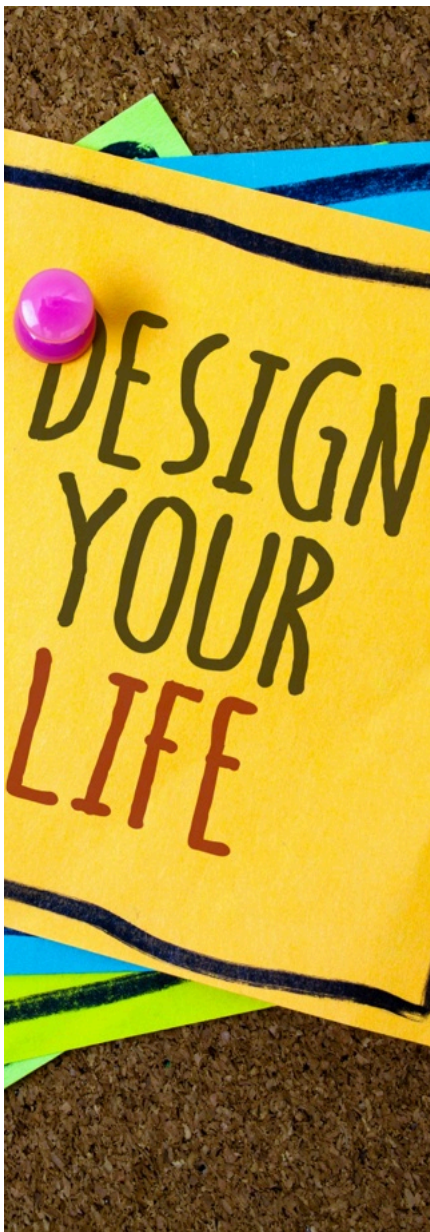
# Permanent Residency Upgrade

After your temporary residency, you can transition to permanent residency. This requires a new visit and an updated file, but the process is significantly simpler than the first application. For this, we offer two options: **Permanent A** (Standard processing) and **Permanent B** (Faster processing).

Paraguay is growing. The real estate market in Asunción and surrounding areas offers interesting opportunities for foreign investors, both for rental yield and personal use. This gives you the assurance that every step is handled correctly and with full legal protection.

Foreign judgments are not enforceable in Nevis, and the jurisdiction does not publicly disclose trust details. We offer this service in partnership with a specialist firm with established relationships with licensed Nevis trustees. We handle the introduction and coordination; they handle the legal formation.

## Paraguayan citizenship

After three years of permanent residency you may be eligible for Paraguayan citizenship — a second passport that is one of the most valuable legal documents you can hold. Processing is handled fully by our specialist partner.

### Eligibility requirements:

- Minimum 3 years of permanent residency
- Demonstrable ties to Paraguay — residency, social, or economic activity
- Basic command of Spanish
- Clean criminal record
- Renouncing your current citizenship is not required by Paraguay — but depends on your home country

### Long-term benefits:

- Visa-free or visa-on-arrival access to numerous countries
- Full Paraguayan citizenship rights — including the right to vote and live permanently
- Maintain your existing citizenship (subject to your home country's rules)
- Strong legal status independent of your country of birth

## Driver's licence

**As a Paraguayan resident you can apply for a local driver's licence. This cannot be arranged during your residency visit — your cédula is required first.**

Once your cédula has been received, we handle the full process for you. We prepare your file, schedule the appointment, and personally bring you to the location. You don't need to worry about paperwork, translations, or navigating offices — just show up and sign. You keep your foreign licence; the Paraguayan licence is an addition. Available for car, or the combination car and motorbike.



## Firearm licence in Paraguay

**Paraguay permits firearm ownership for legal residents. The licencing and registration process runs through DIGEMABEL, the national firearms authority, and follows a structured four-phase procedure.**

To apply, you must hold permanent residency, have a clean police and judicial record, complete an authorised firearms safety course, and obtain a psychological certificate from a qualified professional. DIGEMABEL then validates your dossier, collects biometric data, and issues both the firearms licence and ownership card.

We coordinate the complete process on your behalf. Note that a firearms licence requires permanent residency and can therefore only be applied for once your permanent cédula has been received.

# Frequently asked questions

*Below, we answer the most common questions we receive — from timelines and travel requirements to language, family applications, and practical setup. Clear, straightforward, and based on real experience, so you know exactly what to expect.*






- Do I need to live in Paraguay to keep my residency?

- How long does the residency process take?

- What if I do not speak the language?

- Can my partner or family apply together?

- Is Paraguay safe?



- Can I start the process remotely?

- What is a RUC and do I need one?

- No. As a temporary resident you are required to be present in Paraguay for at least 1 to 2 days within 365 days of your application. With permanent residency this reduces to a minimum of 1 to 2 days every 3 years. You can live anywhere else in the world in between.

- The average processing time for the residency is approximately 3 months. In some cases we can expedite this to 45 days. We do not publish hard time guarantees — final processing sits with Migraciones.

- No problem. We start with services in Dutch, English, and Spanish, and are expanding to Portuguese and Italian. At all government offices we handle all communication on your behalf.

- Yes. Each family member requires their own application with their own documents. We handle multiple applications simultaneously. Contact us for family situations.

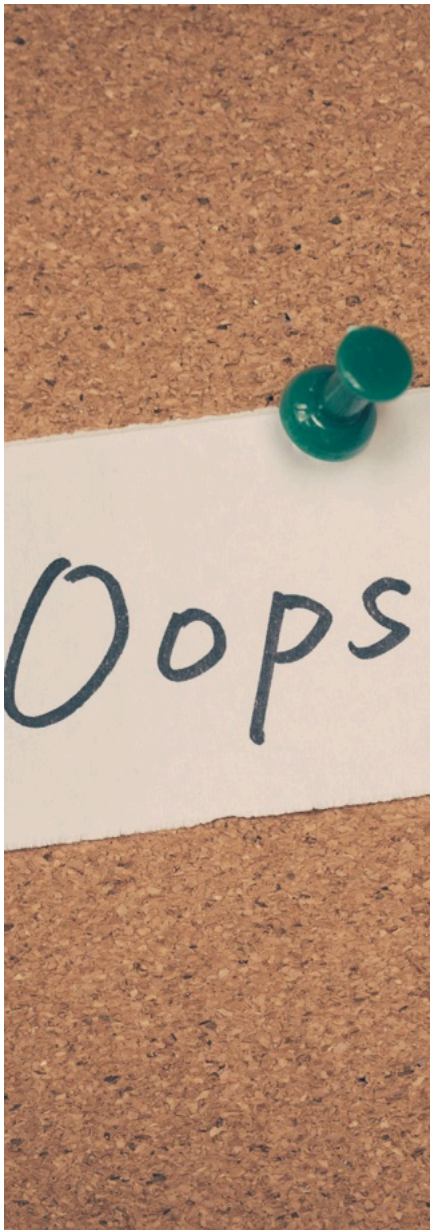
- Asunción is generally considered one of the safer capital cities in the region. The expat neighbourhoods — Las Mercedes, Recoleta, and Villa Morra — are calm and pleasant to live in. As anywhere, common sense goes a long way.

- Yes. We always begin with a remote document review and thorough preparation from a distance. You only travel to Paraguay once everything is ready and your visit can be optimally planned.

- A RUC is your Paraguayan tax ID. It is not a requirement for all residents, but is necessary for those with business activities in Paraguay or who want to set up tax planning. We advise you on whether and when a RUC is relevant for your situation.

# Common mistakes



*The residency process in Paraguay is accessible, but it requires accuracy. These are the most common mistakes — and how to avoid them.*



## Common mistakes

- Documents not apostilled

- Bringing documents that are out of date

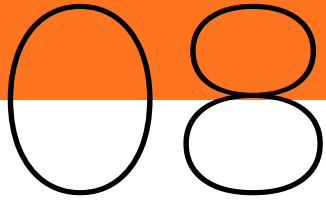
- Bringing copies instead of originals

- Trusting foreign translations

- Missing or rescheduling appointments

- Trying to do it alone without local knowledge

- All foreign documents must carry an apostille from the country of origin. Without an apostille they are invalid in Paraguay. Our pre-check prevents this.
- A criminal record check must not be older than 6 months at the time of arrival. Check the validity of all your documents well in advance — and keep in mind that with Essential you will need a fresh criminal record check for your second visit.
- Paraguay requires original documents. Copies are not accepted at Migraciones.
- Documents must be translated by an authorised Paraguayan translator in Paraguay itself. A translation made at home will not be accepted.
- Migraciones works on an appointment basis. A missed appointment means delay. We plan everything for you and accompany you to every visit.
- Paraguay has a clear bureaucracy, but knowing the right offices, the local procedures, and the people who matter makes a significant difference.



# Next steps

### Step 1 — Introductory call

Schedule a free introductory call. We discuss your situation, answer your questions, and together determine which package suits you best.



### Step 2 — Remote document check

Once you choose a package, we start the remote document review. We check all your documents before you book a single flight.



### Step 3 — Planning your visit

We work together to set a travel window. We ask all clients to keep their first week in Asunción flexible. Paraguay operates at its own pace, and several steps in the process depend on government offices outside our direct control. We cannot commit to exact appointment times in advance, but we handle all planning and guide you through every step from the moment you land.



### Step 4 — Your visit to Paraguay

We are ready when you arrive and guide you through the complete process — from airport to Migraciones and back.



### Step 5 — Receiving your documents

After your visit, Migraciones processes your file. Once ready, both the residency card and cédula can be shipped to you worldwide via DHL — complimentary with Premium, available as a paid add-on with Essential and Express. You are officially a resident of Paraguay.
