Subsidy Matching

What the Matching Engine Does

- **AI Eligibility Pre-Checks:** Evaluates whether a farm likely qualifies before applying, reducing wasted time and rejections.
- **Manual and Automatic Expert Assignment:** Experts can be suggested or assigned to each funding opportunity to assist with strategy and execution.
- **Real-Time Updates:** The engine adapts as new grants are published or existing ones are amended.

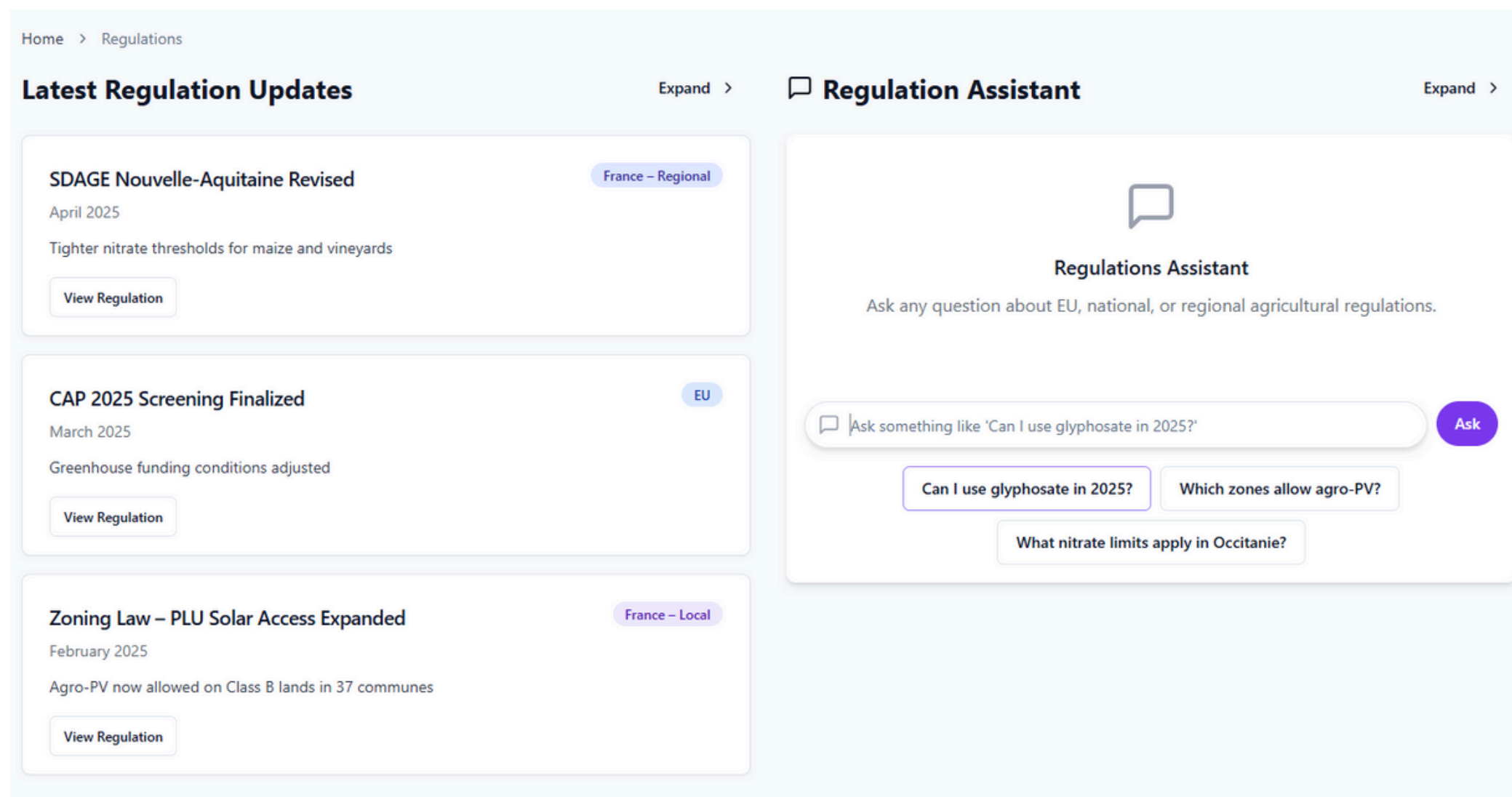

Regulation Chatbot

What the Regulation Chatbot Does

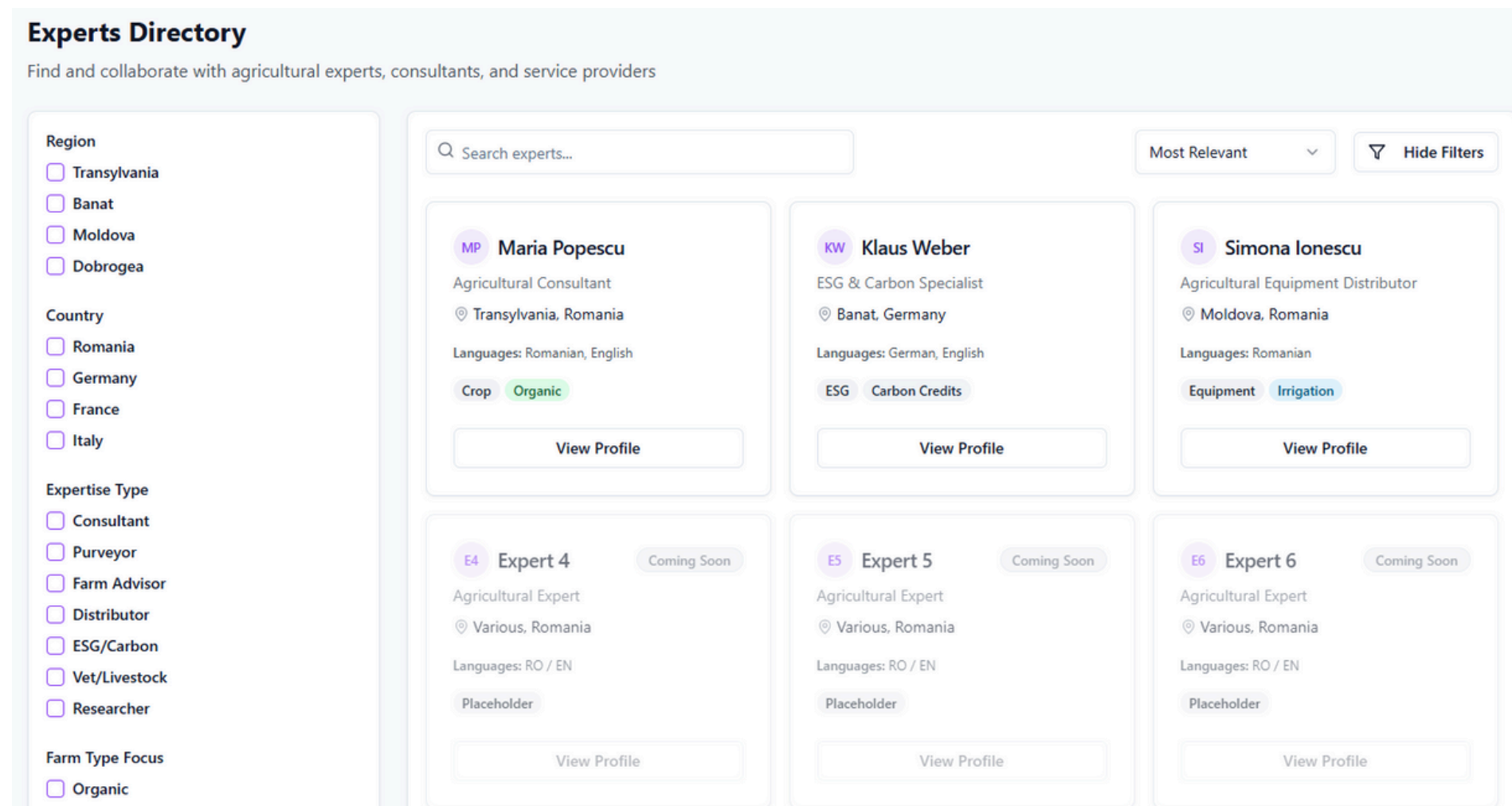

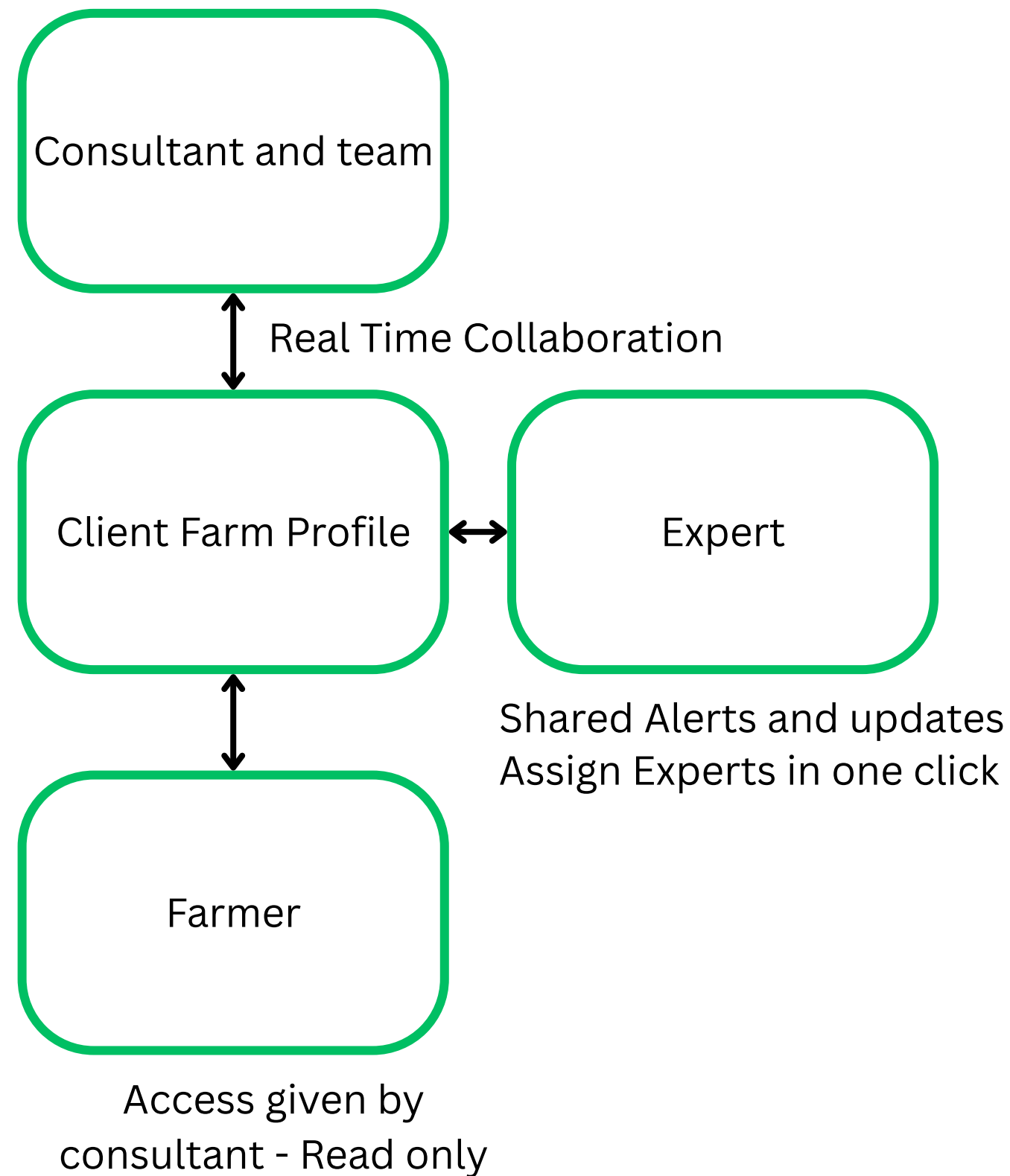
