LETTER FROM THE EXECUTIVE DIRECTOR



In 2017, a small group of people came together to create SD Voices for Peace (SDVFP) and SD Voices for Justice (SDVFJ). Our shared values included building welcoming communities where immigrants, refugees and Muslims belong and eradicating hate by pushing back on bigotry and racism whether it appeared at our dinner tables or legislative session. Our sister organizations work together to create social change by working “top down” in influencing policies and laws that hurt our communities (SDVFJ) and work “bottom up” to build communities by providing them access to immigration legal services and access to information to use their voices through civic engagement (SDVFP).

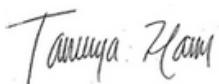
Over the last four years, our journey has taken us to new places and shaped who we are in this moment. Some of our highlights include:

- ✈ The first rally we organized was a national day of action called “Families Belong Together.” This solidarity action took place on June 20, 2018 and was in response to the administration’s “Zero-Tolerance Policy” to separate children from their parents at the southern border. Nearly 500 people showed up in solidarity. This community response became the foundation of what today is our free immigration legal services program where we serve children and survivors of violence in immigration court.
- ✈ In response to the COVID-19 Pandemic, our team raised \$1.2M for the state’s only Emergency Relief Fund for Immigrants in SD, assisting 1,700 immigrant-led households with direct cash assistance. With this work, we hired outreach coordinators to make sure immigrant communities across the eastern half of the state knew about this resource. Our rapid response program received national attention and funds to grow our outreach programming by creating more access to information around COVID-19, the vaccine and now Medicaid Expansion. The trust our outreach team has made with multilingual communities is the foundation we needed to grow our health equity work.
- ✈ On September 17, 2019, we organized community members in the McKennan Park neighborhood to advocate for the City of Sioux Falls to pass a “no-hate” resolution, after KKK recruitment fliers were found. This led to our ByStander to Upstander Training - providing tools to disrupt racist and bias incidences while assuring the victim of the incident comes back into belonging.
- ✈ Through our various advocacy and lobbying efforts in our Legislature, City Council and County Commission meetings, we learned that SD is full of neighbors who care for one another and want to speak out more against racism and bigotry, but they felt alone. This sparked the idea of our Cohorts for Courage program where we bring similar sectors of people together to learn about Islamophobia and why bigotry exists in our communities. We learn about strategic ways to respond. The inaugural cohort were Christian Faith Leaders, which led to an interfaith justice collective West River, and a BIPOC (Black, Indigenous, People of Color) Youth Advocates Cohort leading to the *In The Know* podcast.

Throughout our journey, the support of donors, cheerleaders, and community partners have pushed us to grow in ways we could not have predicted. Thank you for your continuous support and belief in this important work.

LEGAL SERVICES



Our clients have collectively traveled **183,598** miles to reach safety in South Dakota.

Our clients traveled from: Guatemala, El Salvador, Honduras, Nicaragua, Mexico, Kuwait, Burundi and Ethiopia.

SDVFP is the only free immigration legal service provider in the state.

We serve two distinct immigrant populations:

- 1) **Survivors of Violence**: Violent crimes which take place in the U.S.
- 2) **Unaccompanied Children (UC)**: children who travel to the U.S. border without their parents.



As of 2022, we are serving and representing

30 Unaccompanied Minors
14 Survivors of Violence
And we have a growing waitlist

The Immigration Process

We collect evidence and interview clients to determine whether they will qualify for a pathway to citizenship. There are 4 pathways to citizenship that our clients qualify for: 1) **Asylum**, 2) **SIJ**, 3) **U visa**, and/or 4) **VAWA**. Clients can be eligible for more than one pathway to citizenship. There are two federal government entities we work with : 1) **USCIS** (U.S. Citizenship and Immigration Services, an agency within Department of Homeland Security), and 2) **Immigration Court** (IC is within the Department of Justice. Immigration Court is Regional and appearances for court are in Fort Snelling, MN. Some interviews with USCIS take place in Omaha, NE).

Each pathway requires different evidence and has varying timelines for a final decision. We file an **EAD** (work authorization) application once a client is eligible. Upon approval, clients have to renew EADs every 2 years, and we assist in filing these applications too. At the same time, we are appearing in court, filing motions with the court, and responding to USCIS inquiries. Once a client becomes eligible for **LPR** status (Lawful Permanent Resident), we file this application. LPR status allows for eligibility of government services, like student financial aid and permanent work authorization. After receiving LPR status, the client will be eligible for U.S. Citizenship.

Asylum: prove past persecution or well founded fear of future persecution based on race, religion, nationality, political opinion, or "particular social group."

SIJ: Special Immigrant Juvenile status is granted to children under 21 who prove they have been abused, neglected or abandoned by one parent and it is not in the child's best interest to return to home country.

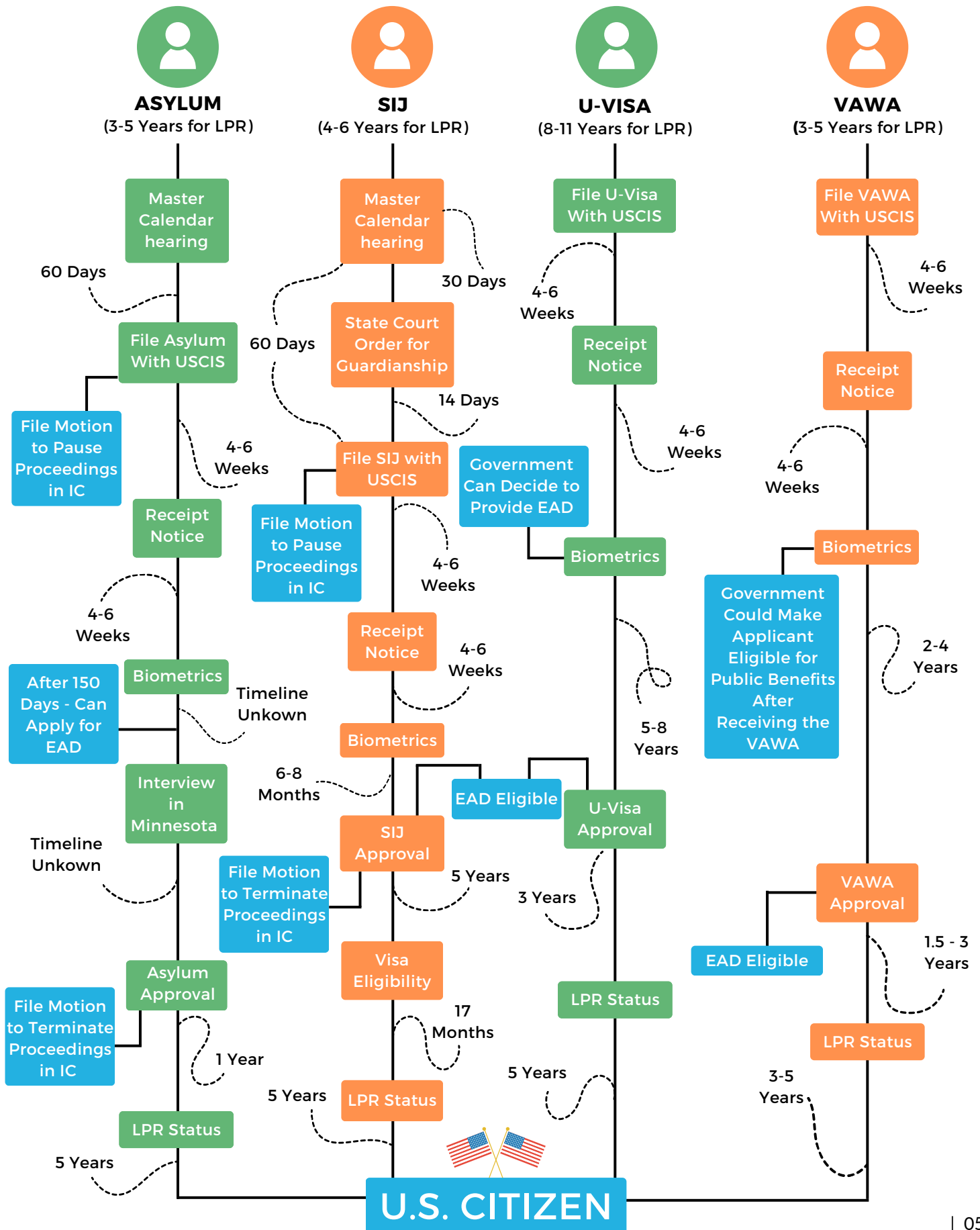
U Visa: must suffer from mental or physical abuse from qualified crime and are helpful to law enforcement in investigation or prosecution.

VAWA: victim is an abused spouse, parent or child of a U.S. Citizen or LPR abuser.

Pathways to U.S. Citizenship

**All of our UC clients are in Immigration Court. Some of our adults may not be in court.*

Denial: If an application is denied and our client is in Immigration Court, our client may appeal the decision to a judge. If our client is not in Immigration Court, there will be an order for removal (deportation).



OUTREACH & HEALTH EQUITY

SDVFP Covid-19 Journey

The pandemic exacerbated existing barriers. In SD, most of the COVID-19 information, whether about testing or accessing vaccines, was only available in English. To confront the challenges posed by inaccessible information, our team developed materials that would be translated in Spanish, Amharic, and Nepali to address the specific needs of immigrant, refugee, and Muslim populations. When information was ready to be distributed, we traveled to various places of worship, immigrant-owned businesses, and non-profit organizations in Sioux Falls and Eastern South Dakota.

Our model is based on the premise that "we need to meet communities where they are and not wait for them to come to us." Reaching our communities in-person and having one-on-one conversations was our most effective strategy. This approach facilitated connection and communication with community members and organizations who shared similar goals in the greater community. We proudly presented to national stakeholders on the success of our model, including to Dr. Anthony Fauci.

Outreach continued at various cultural events, festivals, and celebrations. Part of our mission was to increase vaccine confidence in South Dakota, and with our partners South Dakota Urban Indian Health and Lewis Drug Pharmacy, we organized a series of pop-up clinics throughout the year and into 2022, vaccinating nearly 500 people. The first pop-up clinic was hosted in partnership with South Dakota Urban Indian Health and South Dakota State University Dairy Extension in July of 2021; the clinic was located in the Empire Mall parking lot for convenience and accessibility. The achievement of this initial pop-up clinic became a guide for the development of future COVID-19 efforts.

Made to Save (Civic Nation)

Made to Save was a COVID-19 initiative created by Civic Nation to focus on national education and grassroots campaigns to increase COVID-19 vaccine accessibility; they do so by empowering community-based organizations to focus on outreach programs that facilitate opportunities for vaccinations in communities that were disproportionately affected by the pandemic.



Community Catalyst

Community Catalyst is a leading non-profit national health advocacy organization dedicated to advancing a movement for health equity and justice. Funded by the Centers for Disease Control and Prevention (CDC), the national program aims to increase vaccine confidence through community-based outreach.



Mobile Pathways

Mobile Pathways helps immigrants gain access to reliable legal information about their numerous pathways to immigration via mobile technology. Mobile Pathways created the Vaccine Equity Coalition to work on vaccine confidence and accessibility for undocumented immigrant communities who are disproportionately undervaccinated.



CIVIC ENGAGEMENT THROUGH EDUCATION, ADVOCACY & RAPID RESPONSE

COHORT OF COURAGE YOUTH ADVOCATES

First Cohort of Courage BIPOC Youth Advocates

Cohorts of Courage: Youth Advocates is our next initiative in fighting bigotry and racism. By giving Black, Indigenous, and People of Color (BIPOC) youth the tools and knowledge they need to make positive change in their communities and be the next generation of change agents. Cohorts of Courage deepens the understanding of what it means to build community and take action to implement strategies of social change.

In August 2021, SDVFP launched our first BIPOC Youth Advocates Cohort. Students learned how to organize press conferences, write op-ed letters, research issues and develop talking points. They heard from local media on the importance of using their voice.

The culmination of the week-long intensive program was a public forum where participants presented on topics that they were passionate about and proposed solutions for: healthy foods in schools, public transportation in Sioux Falls, and discrimination in public schools.



In the Know Podcast

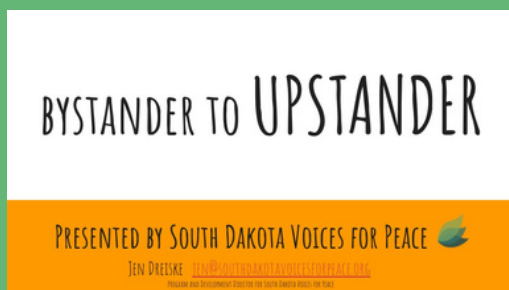
CoC Youth Advocate members have developed the *In the Know* podcast - A podcast allowing BIPOC youth a space to share their ideas, by bringing the latest and important news and topics in a digestible and relatable form. Through conversations with people doing the work of fighting bigotry and racism, they unpack complex topics for the listener.



Bystander to Upstander Trainings

What can a person do when they hear or observe another person being treated with disrespect, and even potential violence? Every one of us encounters acts of discrimination, hate, and bigotry whether in our schools, workplace, grocery store or dinner table. We cannot be Bystanders to these kinds of incidents. The Bystander to Upstander Intervention training is a 60-minute introduction on ways to respond to these kinds of traumatizing incidents. Participants learn how to safely disrupt these situations and bring the target of the incident back into belonging.

We have provided these training sessions to educators, community organizations, business professionals and concerned citizens.



Perspectives Column

In collaboration with the Argus Leader, SD Voices for Peace organized the Perspectives Column, to uplift voices of our BIPOC communities by sharing various aspects of lived experiences in South Dakota. The Argus Leader was recognized by the South Dakota Newspaper Association in its annual awards ceremony for this column.

Responding to Hate

After anti-Semitic posters were disseminated across Sioux Falls in late 2021, SDVFP created a space for Jewish community members and supporters to rally against the hateful propaganda. The rally was hosted at First Congregational Church on the last night of Hanukkah.

Tracking incidents is the first step in understanding the gravity of hate and bigotry in our communities. In order to combat hate, we must document it with photos, videos, and words.

We are grassroots organizations and individuals who believe in justice and equity for our communities. SDVFP organizes monthly meetings for collaboration on initiatives serving our vibrant communities on the eastern half of South Dakota.

SOUTH DAKOTA VOICES FOR JUSTICE

Justice Overview

SD Voices for Justice is the sister organization to SDVFP. As a 501(c)(4), SDVJ works to lobby for legislation, policies and elected officials who support our vision and mission, and we work to lobby against bills that endanger our mission and vision. We organize and coach community members to testify at committee hearings. Since 2017, we have lobbied against anti-refugee bills, advocated at school board meetings for mitigation measures during COVID-19, advocated for an Anti-Hate Resolution at city council meetings, and supported the resettlement of refugees in county commission meetings. We also endorsed candidates who align with our mission and vision in 2020.

2021 Highlights

SD High School Rodeo Club

Slave Branding Auction Event: Through our action alerts we educated the community on the great harm caused by this event on historically enslaved communities and asked community members to reach out the board members to express their concern. This led to a social media storm, news coverage and ultimately the cancellation of this event.



Interfaith Day at the Capitol

This annual lobbying day brings together Christians, Muslims, Jews, Hindus, Buddhists, Atheists and Agnostics from across the state. This lobbying day started in 2018 under the leadership of then ELCA Bishop Zellmer. SDVJ has been a part of this event since. Adhering to COVID-19 precautions, this event took place via Zoom in 2021.

2021 Legislative Session SDVJ Wins and Losses

HCR 6005 - ADVOCATED AGAINST: DEFEATED

Resolution distorting Black History but phrased as "Celebrating Black History Month."

HB 1199 - ADVOCATED FOR: PASSED

Establishes the Office of Liaison for Missing and Murdered Indigenous Persons.

SB71 - ADVOCATED AGAINST: DEFEATED

Designates Juneteenth as a working holiday.

SB 89 - ADVOCATED FOR: LOST

Adds Juneteenth as a State Holiday as a paid day off.

HB 1212 - ADVOCATED AGAINST: LOST

Stand Your Ground Expansion. This bill allows any person anywhere to use deadly force against any person they believe is a threat. There is no duty to retreat. This bill was signed into law on March 8, 2021.

SB 166 - ADVOCATED FOR: LOST

Adds sexual orientation and Native American Two Spirit to a list of protected classes to SD's existing hate crimes laws.

SB 90 - ADVOCATED FOR: LOST

Recognizes hair discrimination as an unfair or discriminatory practice.

SB 125 - ADVOCATED FOR: LOST

Temporarily requires the wearing of face covering in the state under certain conditions and to declare an emergency.
