



## MONACO DI BAVIERA CLASSIC 2025 - RIDER AGREEMENT

### APPLICABLE LAW AND LIABILITY

Monaco di Baviera Classic is the umbrella under which a group of individual riders get an opportunity to enjoy a unique riding experience. It is a challenge which riders undertake under their own responsibility. Thus, Monaco di Baviera Classic, their facilitators, sponsors and any other party involved at the facilitation of the challenge will never be liable towards the participants, their heirs and other people, for what material or personal damage to person or property, whether arising from the negligence of releases or otherwise, and/or personal decease, injury of whatever nature and size, disability, or loss whatsoever, that the participant and other parties can experience in the context of the challenge. Should the rider suffer or produce any damage, the rider will be responsible for it.

The german law is applicable to the challenge and regulates the agreement between the rider and the facilitator of the Monaco di Baviera Classic challenge.

With the signature of the present document the rider confirms their

- agreement with the fact that the investment done in the challenge covers the elements listed under “benefits” area in the rider manual, and that any other element not included in this list (e.g. medical, personal or 3rd party liability insurance) is not included as a service.
- awareness that the risk of injury raising from own actions and from 3rd party actions is significant, including the potential for permanent paralysis and death. They confirm their awareness that while particular skills, rules equipment and personal discipline may reduce this risk, the risk of serious injury does exist. In this context they confirm being aware of the recommendation to buy third-party travel insurance to ensure coverage for any incurred medical, evacuation services or repatriation of remains costs among others.
- voluntary participation in the “Monaco di Baviera Classic” challenge mindful of the risks, both known and unknown, at their own risk
- willingness to accept and bear the consequences and costs of any damage, accident, event or need for compensation generated to themselves or produced to others which may have been generated by themselves or which may arise from negligence or releases of others.
- agreement with being liable for any damage and loss of any nature and with settling the costs themselves, without any form of claim to the facilitator of the challenge
- agreement to release and hold harmless to the Monaco di Baviera Classic facilitators, sponsors and any other party involved, with respect to all injury, disability, death or loss or damage to person or property, whether arising from the negligence of releases or otherwise, to the fullest extent permitted by law.
- agreement with the fact that they are held liable for the payment of all and any taxes, surcharges, levies, imposts, fines, penalties, compensation for accidents, personal



damages or similar charges incurred in connection with their participation in the challenge

- agreement with the fact that Monaco di Baviera Classic and anyone involved in facilitating or sponsoring the challenge are free of liability and cannot be issued or brought in front of the tribunals in the context of the Monaco di Baviera Classic challenge. In this context, the rider confirms their agreement that, should at any moment, for whatever reason, the rider, their heirs or any other people on the rider's behalf, decide to involve Monaco di Baviera facilitators in any dispute, they commit to cover the expenses of any Law Firm designed to their defence in a court of law by the Monaco di Baviera Classic facilitators.
- agreement to not making or permitting to be made any public announcement(s) in relation to this agreement without prior consent of the MDBC facilitator, nor to disclose to any third-party information concerning the terms or subject matter of this agreement from the date hereof.
- understanding that MDBC retains all rights over intellectual property; this includes, but is not limited to name, logos, photos and films.
- agreement to the unlimited usage of their images or videos from the event for event media.
- agreement with the fact that should any force majeure, natural disaster, political situation, etc. generate such a risk that the challenge facilitator decides that it is not safe enough for the challenge to continue as planned, they will receive no reimbursement of any expenses incurred (inc. the subscription to the event)
- agreement with the fact that decisions made by the event facilitator are final.

I have read the rider's manual and the rider's agreement in its full content, including the challenge details, important pre- and post-challenge notes, contract clauses, applicable law and liability release and I fully understand and agree with its terms. I thus freely and voluntarily sign this agreement with the purpose of registering to the challenge.
