1. BOOKINGS & DEPOSITS A NON-REFUNDABLE DEPOSIT IS REQUIRED TO SECURE YOUR BOOKING. THIS AMOUNT WILL BE DEDUCTED FROM YOUR FINAL BALANCE, WHICH MUST BE PAID IN FULL BY THE AGREED-UPON DATE PRIOR TO YOUR WEDDING DAY. BOOKINGS ARE NOT CONFIRMED UNTIL THE DEPOSIT IS RECEIVED.

#### 2. PAYMENTS

FINAL PAYMENT IS DUE NO LATER THAN 7 DAYS BEFORE THE EVENT DATE. FAILURE TO PAY IN FULL BY THE DUE DATE MAY RESULT IN CANCELLATION OF YOUR BOOKING.

#### 3. CANCELLATIONS & CHANGES

CANCELLATIONS MUST BE MADE IN WRITING. DEPOSITS ARE NON-REFUNDABLE UNDER ANY CIRCUMSTANCES.

ANY REDUCTION IN THE NUMBER OF SERVICES BOOKED MAY STILL INCUR FULL CHARGES IF CANCELLED WITHIN 30 DAYS OF THE WEDDING DATE.

CHANGES TO DATES OR TIMES ARE SUBJECT TO AVAILABILITY AND MAY INCUR ADDITIONAL CHARGES.

#### 4. TRIALS

A TRIAL IS HIGHLY RECOMMENDED FOR THE BRIDE TO ENSURE SATISFACTION WITH THE FINAL LOOK. TRIALS ARE CHARGED SEPARATELY FROM THE WEDDING DAY SERVICE.

IT IS COMMON FOR PREFERENCES TO EVOLVE AFTER A BRIDAL MAKEUP TRIAL. SHOULD YOU WISH TO EXPLORE A NEW LOOK OR MAKE SIGNIFICANT CHANGES TO YOUR ORIGINALLY TRIALLED STYLE, AN ADDITIONAL TRIAL APPOINTMENT WILL BE REQUIRED AND CHARGED ACCORDINGLY.

#### 5. LASHES & EYE ENHANCEMENTS

ANY ENHANCEMENTS TO THE EYE AREA SUCH AS LASH LIFTS OR LASH EXTENSIONS MUST BE DISCLOSED AND DISCUSSED PRIOR TO BOTH YOUR MAKEUP TRIAL AND YOUR WEDDING DAY. THIS ENSURES COMPATIBILITY WITH THE MAKEUP APPLICATION.

IF A LASH LIFT IS PERFORMED PRIOR TO YOUR BOOKING, PLEASE NOTE THAT FALSE LASHES CANNOT BE APPLIED, AS THEY MAY NOT ADHERE OR SIT CORRECTLY.

IF YOU CHOOSE TO WEAR EYELASH EXTENSIONS, THIS CAN BE ACCOMMODATED, AND NO ADDITIONAL LASHES WILL BE APPLIED.

THIS APPLIES TO ANY CHANGES MADE FOLLOWING YOUR MAKEUP TRIAL AND HELPS ENSURE THE FINAL LOOK CAN BE EXECUTED AS INTENDED.

6. SKINCARE PREPARATION CLIENTS ARE ENCOURAGED TO CONSULT WITH A SKINCARE PROFESSIONAL IN THE LEAD- UP TO THEIR WEDDING. A CONSISTENT SKINCARE ROUTINE INCLUDING GENTLE EXFOLIATION AND PROPER HYDRATION IS ESSENTIAL TO ACHIEVING A SMOOTH, LONG- LASTING MAKEUP FINISH. PLEASE AVOID ANY HARSH TREATMENTS, SKIN PEELS, OR ACTIVE PRODUCTS THAT MAY CAUSE IRRITATION CLOSE TO THE WEDDING DAY. MAKEUP WILL SIT BEST ON HEALTHY, WELL-PREPARED SKIN.

7. CLIENT OBLIGATIONS CLIENTS MUST ENSURE THEY ARRIVE WITH A CLEAN FACE FREE OF MAKEUP, MOISTURISERS, OR SPF ON THE DAY OF THEIR SERVICE UNLESS OTHERWISE INSTRUCTED. ANY ALLERGIES, SKIN SENSITIVITIES, OR MEDICAL CONDITIONS THAT MAY AFFECT THE SERVICE MUST BE DISCLOSED AHEAD OF TIME.

8. TIMING & SCHEDULE A DETAILED RUN SHEET WILL BE CREATED FOR YOUR EVENT TO ENSURE SMOOTH TIMING. DELAYS CAUSED BY LATE ARRIVALS, UNFORESEEN EVENTS, OR UNPREPARED SKIN MAY AFFECT THE FINAL RESULT OR TIMING OF SERVICES. MAKEUP APPLICATION REQUIRES A CALM AND TIMELY ENVIRONMENT FOR THE BEST OUTCOME.

9. LIABILITY & ARTIST ILLNESS IN THE RARE EVENT THAT THE PRIMARY ARTIST IS UNABLE TO ATTEND DUE TO ILLNESS OR EMERGENCY, EVERY EFFORT WILL BE MADE TO FIND A TRUSTED REPLACEMENT. IF ONE IS UNAVAILABLE, YOU WILL RECEIVE A FULL REFUND FOR ANY SERVICES NOT RENDERED.

10. SERVICE REFUSAL THE ARTIST RESERVES THE RIGHT TO REFUSE SERVICE TO ANY INDIVIDUAL DISPLAYING CONTAGIOUS SKIN CONDITIONS, AGGRESSIVE BEHAVIOR, OR INTOXICATION. NO REFUND WILL BE ISSUED IN THESE CASES.

BY PAYING THE DEPOSIT, YOU ACKNOWLEDGE THAT YOU HAVE READ, UNDERSTOOD, AND AGREED TO ALL TERMS AND CONDITIONS OUTLINED ABOVE.
