Ana L. Toledo, Esq., Counsel for Targeted Justice has written a letter to Department of Homeland Security (DHS) Secretary Kristi Noem, demanding an immediate end to what they call "un-American and illegal" programs funded by the agency. The letter accuses DHS of orchestrating a sprawling network of surveillance, harassment, and psychological operations through Fusion Centers, targeting innocent Americans under the

guise of counterterrorism. The letter claims DHS is funding a campaign against over 300,000 Americans wrongfully placed on the FBI's Terrorist Screening Database (TSDB).

Ana L. Toledo, Esq., alleges that 97% of TSDB entries have "no known ties to terrorism," saying the list is used to silence whistleblowers, political activists, January 6th defendants, and parents protesting at school boards—groups viewed as "enemies of the Deep State."

"If fMRI scans are incorporated into the government's investigatory process, constitutional safeguards should be in place to protect the fundamental right of privacy and an individual's freedom to decide whether to assist the state. This Note proposes that the results of fMRI scans are testimonial evidence: first, because the scans reveal the subject's knowledge or beliefs, and second, because this classification ensures that fMRI scan results are afforded the protection of the Fifth Amendment. If fMRI scans are privileged under the Fifth Amendment, the government cannot compel an individual to submit to the scan and reveal the contents of her mind."

**Is it a federal crime to covertly implant a victim with a wireless body area network without their knowledge or consent?**

"War and Corpses - The Last Hope of the Rich"

This is a satirical political artwork, anti-capitalist and anti-elite war propaganda condemning war profiteering and class exploitation, i.e., **GLOBALISTS**. A hyena wearing a top hat and a medal, traditional symbols of wealth, aristocracy, bankers and ruling elites. The animal is standing on corpses of soldiers, implying profiteering from mass death. The setting resembles a battlefield, emphasizing war's destruction. The German caption at the bottom translates to "War and Corpses – The Last Hope of the Rich." This type of imagery was common around World War I thru the Korean War. The exaggerated, grotesque style is deliberate, meant to provoke moral outrage. This

is another generation's feelings about elites. They want the same things now as they did then -- money, power and land.



NOTE the word **ULTRA** on the red jacket. ULTRA is thought to be the name of the program we are in - a descendant of MK-ULTRA. This made me wonder if this artist is a TI (or a stalker). I imagine there are a lot of artists who do not fit the GLOBALIST'S idea of utopia. Hitler's idea of a utopia was primarily centered on creating a vast, racially "pure" **Greater Germanic Reich** in which the "superior" Aryan race would have ample "**Lebensraum**" (living space). Living space is what the elitists think they must have and are actively removing people from the land with floods, fires, landslides, tornadoes, hurricanes, etc.

The album cover for Logic's fifth studio album, *Confessions of a Dangerous Mind* (2019), was painted by artist Sam Spratt (Released May 10, 2019). This is **conceptual artwork** exploring psychological and technological themes. You see dual identity, inner conflict, technology vs. humanity, and mental fragmentation. The split face is a visual metaphor that suggests a contrast between a calm exterior and a violent or distorted inner self. The smartphone and futuristic imagery may point to technology's impact on identity, anxiety, or self-perception AND knowledge or experience of the stalking agenda of ULTRA. As a TI, I can identify with this because

when I see a stalker, there is a character that looks innocent, portrays themselves as "not doing anything" and a demon who is reading my implants and may or may not know the harm they are doing. Some seem to enjoy the tormenting of their victim and others act like a stone statue until you break them out of it by asking "what time is it?" Its a very simple question but it performs quite a few actions. It turns the stalker into their real selves, they become really very helpful and eagerly tell you the time, OR you get them out of their aloof bubble that stalking puts them in. It lets them see you are just an ordinary person, not a "X" rapper/killer. It turns you both back into just humans. And...it tells you what time it is. - Skizit.
