ISO 14001 (Environmental Management System)

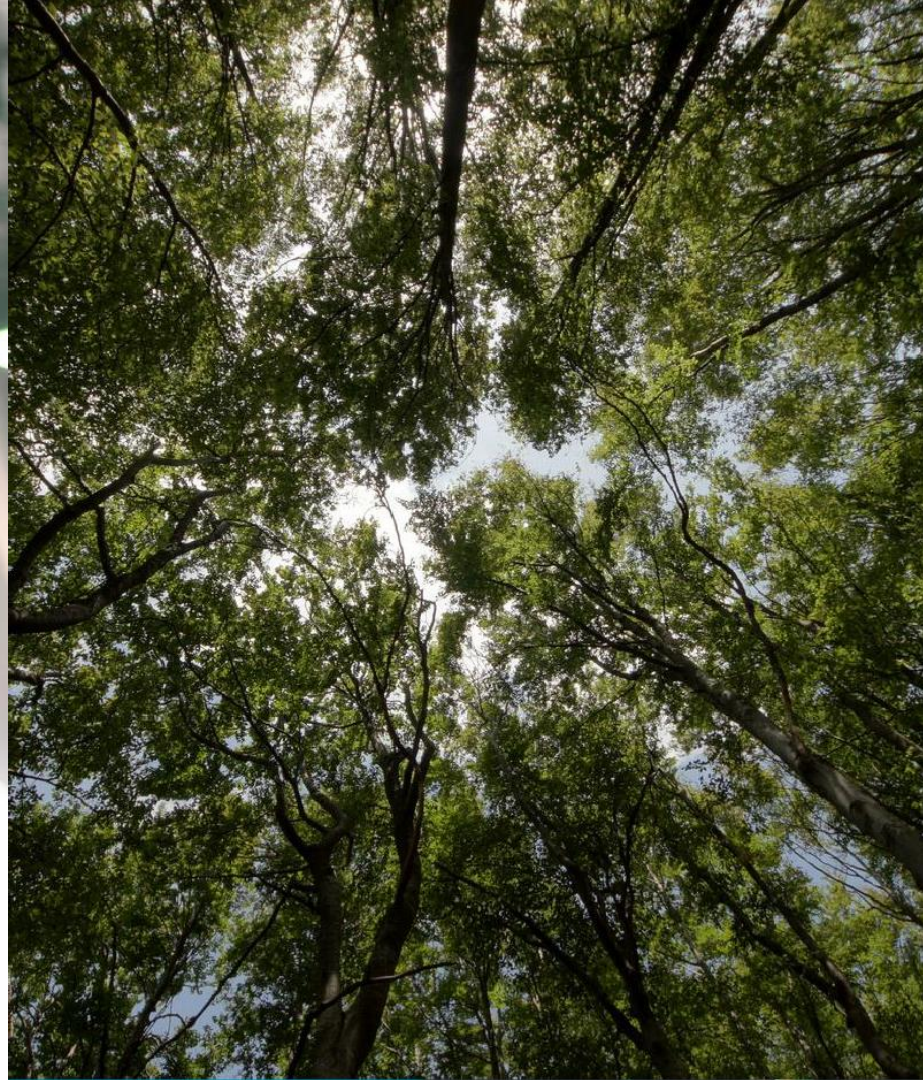
An international standard for managing a company's environmental impacts.
