- 4) Directions of the State Govt. from time to time shall have to be complied with.
- Before imposing any fees afresh, the school authority should seek the approval from the competent authority of the Education Department. The present fee policy should be displayed prominently in the notice board.
- 6) The school authority shall issue appointment letters in favour of all working staff in the school indicating the relevant package pay.
- 7) The salaries or wages of teaching and non-teaching staff shall not in any way be less than that notified by the Labour Department, Government of Tripura for private educational institutions from time to time.
- 8) The school management shall be under obligation to follow the Right of Children to Free & Compulsory Education Act, 2009.
- 9) Ensure CCTV camera installation in the school (in entrance, exit & vulneralal areas).
- 10) Availability of safe and adequate drinking water & separate toilets for girls and boys in the school premises.
  11) Prevention of Substance above in the school
- 11) Prevention of Substance abuse in the school premises.

The above sanction is subject to fulfillment of following condition:-

- 1. The grant for recognition is not extendable and does not in any way imply any obligation to recognized/affiliated beyond Class-VIII.
- The School shall abide by the provisions of Right of Children to Free and Compulsory Education Act, 2009(Annexure-I) and the Right of Children to Free and Compulsory Education Rules, 2009(Annexure-II)
- 3. The School shall admit in class I, to the extent of 25% of the strength of that Class, children belonging to weaker section and disadvantaged group in the neighborhood and provided free and compulsory elementary education till its completion. Provided, further that in case of pre-primary classes also, this norm shall be followed.
- 4. The School shall not deny admission to any for lack of age proof. If admission is sought subsequent to the extended prescribed for admission. On the ground of religion, caste or race place of birth or any of them.
- 5. The School shall ensure:
  - No child admitted shall be held back in class or expelled from school till the completion of elementary education in a school;
  - ii) No child shall be subject to physical punishment or mental harassment;
  - iii) No child is required to pass any board examination till the completion of elementary education.
  - iv) Every child completing elementary education shall be awarded a certificate as laid down under Rule 23.
  - v) Inclusion of Students with disabilities/special needs as per provision of the Act.
  - vi) The teachers are recruited with minimum qualification as laid under section 23(I) of the Act. Provided further that the current teachers who, at the commencement of this Act. do not possess minimum qualifications shall acquire such minimum qualification with in a period of 5 years.

- vii) The salary and allowance payable to and the terms and conditions of sub-rule (I) of rule (18) for the purpose of section 23(3) of the Act;
- viii) The teacher performs its duties specified under section 24(1) of the Act and
- ix) The teacher shall not engage himself or herself for private teaching activities.
- The school shall follow the syllabus on the basis of curriculum laid down by appropriate authority.
- The school shall enroll students proportionate to the facilities available in the school as prescribed in the section 19 of the Act.
- 8. The school shall maintain the standards and norms of the school as specified in section 19 of the Act. The facilities reported at the time of last inspection are as given under:-

- The School building or other structures or the ground are not used during the day or night for commercial or residential purpose (except for the purpose of residence of any employee of the school) or for political or noneducation activity of any kind whatsoever;
- The School is run by a society registered under the societies Registration Act. 1860(21 of 1860), or a public trust constituted under any low for the time being in force;
- The school is not run for profit to any individual, group or association of individuals or any other person;
- 13. The accounts should be audited and certificate by a chartered Accountant and the Statements of Account should be prepared as per rules. A copy each of the Statements of Accounts should be sent to the DEO every year.
