Your website can be started up for as little as \$25 and at most \$300. The "startup fees" allow you not to have to pay again for another 12 months. And those renewal plans are explained below, with discounts.

Startup Fees

\$15–25/hr for scheduled building meetings.

Domain costs (purchases/transfers) if any occurred.

Prepayment for next 12 months of management at \$25.00.

Renewal Fees

Website Hosting \$25/year Yearly Hosting Fee

Management \$25/year Yearly Management Fee

Domain ~\$15/year (if purchase) Yearly Variance Cost

Referral Discounts

If a new referred client pays startup fees for their own website, the management fee of your own website is reduced by 50% off (\$12.50) and if additional referral reduces management fee to \$0.00 for a 100% discount.

All other fees remain, such as hosting and domain costs, essentially the website management fee is reduced by your first two referrals. Your referral discount is permanent, even if the referral no longer renews after the initial year. Limit of 2 discounts of 50% to management fee line items.

Management Fee Services

Consist of a limit of no more than 5 revision requests a month, also not exceeding combined annual sum. The fee for service also constitutes that GrupoMoyer will reasonably make accommodations for those revision requests. You'll have 30 past due days to pay, after 60 past due days your site will be reduced priority services.
