Boarding rates:

\$45/day per dog with the holiday rate being \$50/day per dog

\$50/day for puppies (12 months or younger) with the holiday rate being \$55

Daycare rates:

Adult dogs- \$30 (8 hours) \$35 (10 hours) \$40 (12 hours)

Puppies - \$35 (8 hours) \$40 (10 hours) \$45 (12 hours)

Late pick-up may result in additional charges

Belongings (beds, toys, leashes, etc.) are left at Owner's risk
