- 2. All the existing Aided and Private Polytechnics including Engineering Colleges conducting Diploma level courses in Engineering & Technology should renew the SBTET-A.P Affiliation by Paying the Affiliation Fee prescribed by the State Board of Technical Education & Training, for every Academica Year .
- 3. All the SBTET Affiliated Polytechnics/Colleges should follow the Curriculum Prescribed and Published by SBTET, A.P., from time to time ensuring that the student receives Quality Education, recognized and widely accepted by all other State Technical Boards in India.
- 4. Academic Audit team constituted by SBTET/DTE conducts academic inspection at regular intervals even without prior intimation to monitor the ongoing activities in the colleges with the standards prescribed by the Department of Technical Education, Government of Andhra Pradesh and AICTE, New Delhi. The affiliation accorded will be withdrawn if found in violation of rules and regulations.

- 3. The Affiliation with variation in intake will be considered as per the **No Objection Certificate** (NOC) issued by the Department of Technical Education (DTE, A.P) for the academic year 2025-26.
- 4. It is mandatory to comply with all the essential requirements as given in 2024-25 to 2026-27 (Chapter-VI) and important instructions mentioned in the AICTE EoA from time to time.
- 5. In case of any differences in the content of this affiliation order, the content/information as recommended by the inspection teams available on the records of SBTET- A.P shall be final and binding.
