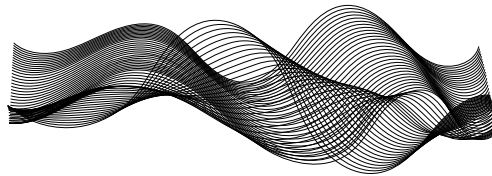
1 The Evolving Challenges of European Banking
