# PEOPLE'S CHOICE NETWORK CHANNEL AGREEMENT

## 12 MONTH CONTRACT FROM\_\_\_\_\_ TO\_\_\_\_\_

**This Channel Agreement ("Agreement") is made and entered into by and between \_\_\_\_\_ and People's Choice Network, hereinafter referred to as the "Provider," and the undersigned channel owner, hereinafter referred to as the "Channel Owner."**

### **1. Channel Setup and Monthly Fees**

- a. The Channel Owner shall pay a one-time channel setup fee of **\$50** for the initial channel setup (**\$100 first month subscription fee**). **This fee of \$150.00 is due upon signing this Agreement.**
- b. The Channel Owner shall pay a monthly subscription fee of **\$100** for the ongoing use and maintenance of the channel, starting from the second month after setup.

### **2. Upload Limits**

The Channel Owner is granted the right to upload content to the **People's Choice Network**. The Channel Owner is entitled to upload up to 8 videos or content items per calendar month. Additional uploads beyond this limit will be subject to additional charges as specified by the Provider.

### **3. Payment Terms**

All fees, including the setup fee and monthly subscription fee, shall be paid in accordance with the payment terms specified by the Provider. Payment methods, due dates will be communicated separately.

### **4. Content Ownership**

The Channel Owner retains ownership of all content uploaded to the **People's Choice Network** channel. By uploading content, the Channel Owner grants the Provider the non-exclusive right to display and distribute this content on the **People's Choice Network** platform.

### **5. Content Quality and Compliance**

The Channel Owner agrees to provide content that complies with the quality and content guidelines set forth by the Provider. Content that violates any local, state, or federal laws or regulations will not be accepted.

### **6. Channel Promotion**

The Provider may, at its discretion, promote the Channel Owner's content within the **People's Choice Network** platform. The Channel Owner may also promote their channel independently.

### **7. Termination**

- a. The Channel Owner may terminate this Agreement at any time by providing written notice to the Provider. 30 Days Notice Required.
- b. The Provider may terminate this Agreement if the Channel Owner breaches any of the terms and conditions outlined in this Agreement, including non-payment of fees.

### 8. Liability and Dispute Resolution

The Provider shall not be liable for any damages or losses incurred by the Channel Owner because of using the **People's Choice Network** platform.

Any disputes arising from this Agreement shall be resolved in accordance with the dispute resolution process outlined by the Provider.


### 9. Changes to Terms

The Provider reserves the right to change the terms and conditions of this Agreement, including fees and upload limits. The Channel Owner will be notified of any changes according to the notice provisions outlined in this Agreement.

### 10. Governing Law

This Agreement is governed by the laws of [Jurisdiction], and any legal actions or proceedings related to this Agreement shall be resolved within this jurisdiction.
