RULES AND REGULATIONS

1. The Academy is open 7 days a week. It remains closed on national/ public holidays such as **Republic Day, Independence Day, Gandhi Jayanti, Diwali** etc. The School is also closed for summer and winter vacations. The schedule of holidays is displayed on the School's notice board & uploaded on the website from time to time.
2. Full quarterly fees is to be paid through **Cheque/ Demand Draft** or **QR Code** facilitated in the school office (**Cash payment is not accepted**). The quarterly fees apply also for the periods during which the School remains closed: **Summer Vacation (the month of June) and Winter Vacation (Two weeks)**.
3. Instrument and vocal lessons may be provided either individually or in groups, based on level and requirement. Dance classes are conducted in groups. Class timings are finalized mutually between teacher and student at the start of each quarter and cannot be changed mid-quarter.
4. Classes missed due to faculty unavailability will be compensated. However if a student misses a class, any make-up class is solely at the teacher's discretion. The academy is not obligated to provide any such make-up class. Late arrivals (more than 20 minutes) may be marked absent at the discretion of the instructor.
5. Classes missed by students for the following reasons will NOT be made good
 - a. Classes falling on national/public holidays and during summer and winter vacations.
 - b. Classes missed due to school examinations/outstation camps, trips, late attendance or for any other reason. In case of serious illness or hospitalisation, however, the Director may consider making up classes as a special case on the evidence of a medical certificate.
6. The last date to register for classes for any month will be the final day of the preceding month.
7. The due dates for payment of fees by students for the upcoming quarter will be the 15th of the last month of the current quarter.

Note : 500/- late fee will be charged after the due date.

The above dates for payment of fees by students should be strictly complied with. Teachers will not take classes for students not paid their fees for the quarter. There is no guarantee that the slot will be maintained after three weeks from the due date of the late fees.
8. Fees for the quarter, once paid by the students, will not be considered for refund. However, exceptional circumstances and cases may be considered.
9. Students should attend the classes regularly. Students whose attendance is irregular or who absent themselves frequently and for long periods without prior intimation and full justification, would be removed from the rolls. The Director reserves the right to terminate the lessons of students at any time, if their work, application or discipline are found to be unsatisfactory.
10. The school reserves the right to change a teacher assigned to a student at any point of time, if found necessary.
