News from the MSAA

Minnesota State Archery Association 2021 Regionals & Indoor, and Covid-19

The MSAA Board met on 11/19/2020 (by video) to discuss 2021 activities and specifically the Regional/Indoor tournament process. As a result of the meeting the Regionals planned for January and February were cancelled and the Indoor format was adjusted. The board decided that given the current worsening state of Covid-19, government restrictions (also the likelihood of their extension) and the association's responsibility to the archery community that the MSAA could not guarantee that members in the near-term could safely participate.

The Indoor tournament will remain a two-day event, the first day will be a qualifying round and the second will be a championship round. First day results will be used to determine standing (flighting) for the second day's championship round, specifically:

- Two-day event (March 20th & 21st held in Fargo, hosted by Lake Agassiz Bowmen & Sandhills Archery Club): Saturday qualifying, Sunday championship. Saturday's results will be used to flight participants with their competition for Sunday's championship.
- Participants will shoot an MSAA 300 Round (60x) on each day
 in the same class. Participants are restricted to one class,
 choosing multiple classes to compete in will not be an option this
 year.
- 3. Single lines will be used to minimize the number of participants in the arena at any one time. On Saturday line times will be 8AM, 10:30, 1PM and 3:30. Line times may be adjusted based upon level of participation. Flighted results will be posted following Saturday's qualification round. The flighted results will show Sunday line times.
- 4. Registration will be used to schedule a line time for Saturday's qualification round:

- a. A registration form will be available on the MSAA website (www.mnarchery.org) in January 2021.
- b. The registration form will include the opportunity for a participant to specify first and second line time preferences (from those listed in #3, above).
- c. If a participants first line time choice is not available then their second choice will be considered.
- d. If neither of the participants line times are available then they will be assigned from what remains available.
- e. Line times will be assigned in the order that they are received.
- f. An up-to-date list of assigned line times will be posted on the MSAA website.
- g. Preferred line times are not guaranteed but every effort will be made to accommodate.
- 5. Registration will open on January 23rd and will run until March 5th.
- 6. Once all of Saturday's lines are full a waiting list will be started.
- 7. All other MSAA Indoor Championship Tournament rules apply.
- 8. MSAA Two-day tournament fees apply.

Please plan on the observation of Covid-19 restrictions that are mandated by government and are in the best interest of the MSAA.

All other MSAA activities held at dates later in the year are planned on being held. The board hopes that 2021 will see the association's events rebound as the Covid-19 menace recedes.

Thank you for all of the content that you sent in and thank you for your kindness along the way.

That out of the way I believe that we have come to a time where we have to ask if there is even a point to producing the magazine anymore? Several months back the MSAA decided to distribute the magazine only online and to stop paper publication. Once online we have learned that relatively few people are accessing the magazine in its new digital-only format. I obstained from the vote that the MSAA board took to move the magazine online (I was also Indoor VP at the time) because as editor I was an employee. I cannot say that I would have been in opposition, the future can be troubling and one cannot remain dumb in the face of what is impossible to stop - everything is going online and the world has gotten that much smaller because of it in my opinion.

The magazine was always around in other ways too, in several of the shops that I visited over the years, invariably, especially around indoor season, there the magazine would sit on the shop counter.

I feel that putting the magazine online was the one step necessary to making it go away entirely, like many other things that we old-timers just liked having around. We will not be reminded that we are MSAA members by not finding the magazine in our mailboxes anymore. The activities of the MSAA board will be that much less known and open to scrutiny because meeting minutes will not be easily available. And in the end it will be just that less fun – no more cover photos of aspiring young archers that make them celebrities for just a moment... maybe a very important one.

News from the DNR

DNR invites public input on deer population goals

Minnesotans interested in deer populations in certain areas of the state can take an active role in shaping deer population goals during an open public input process starting Monday, Feb. 8.

The Minnesota Department of Natural Resources sets deer population goals — how much of an increase or decrease is desired in a deer population in a particular deer permit area — as part of managing the state's wild deer herd. The goals are being updated on a staggered basis in 14 regional goal-setting blocks that comprise multiple deer permit areas. The population goals established in this process will provide direction for management in each goal-setting block for a 10-year period, with a midpoint review at the five-year mark.

This year, to minimize the risk of COVID-19 transmission and support social distancing measures, the DNR is shifting to online-only engagement, rather than in-person workshops.

"We're adapting from last year's new workshop process, mirroring those workshop activities in an online format," said Barbara Keller, DNR big game program leader. "We're excited to see how people engage with

this topic, and encourage anyone who has an interest in deer management to give feedback on future deer population trends in the areas where they live, work and recreate."

This is the second year of a four-year, statewide process, with several geographic blocks addressed each year. This year focuses on blocks in the southwestern and northeastern parts of the state. The goal blocks and deer permit areas for this year are as follows:

Minnesota River goal block – 274, 275, 278, 279, 280, 281, 282, 283, 284, 290

South-Central goal block – 230, 232, 233, 253, 254, 255, 291, 292, 293, 299

Blufflands Plateau goal block – 234, 237, 238, 250, 252, 286, 288, 289, 294, 295, 296.

Border Uplands/St. Louis Moraines goal block – 119, 132, 171, 173, 176, 177, 178, 179, 181, 199.

Details, including how to participate, are listed on the DNR's deer goal-setting webpage.

Join the goal-setting process

The DNR will gather public feedback using its online community engagement tool, in two separate phases. During the first phase, from Feb. 8-28, participants may give input on whether the deer population should increase, decrease or stay the same, and share their ideas on deer management. During the second phase, from March 15-25, participants may provide feedback on proposed population goals developed based on input from the first phase and other information available to the DNR.

Anyone may participate, regardless of affiliation or knowledge of the process. Background information about deer management and population goal setting will be provided. Participants who cannot access the webpage through a computer browser or mobile device may provide feedback by calling the local area manager listed on their deer permit area map for the permit areas of interest.

Goal-setting and deer management information

In 2019, the DNR updated its deer population goal-setting process, which previously obtained input through citizen advisory committees and in-person public meetings. The new format design allows more participants and encourages discussion across viewpoints.

In addition to goal setting, anyone can talk directly with area wildlife managers about deer management or attend deer open houses, held statewide outside of the goal-setting process. The open houses are designed to encourage conversations about deer and deer management, enhance local relationships and foster two-way communication between the DNR and the public. DNR continues simplified spring turkey regulations in 2021

Hunters hoping to bag a tom turkey with a firearm this spring will see similar regulations as last year, and will not be restricted to a single permit area. A spring turkey license will provide the opportunity to hunt all permit areas in the state, with the exception of three major wildlife management areas.

Hunters have through Friday, Feb. 12, to apply for permits available by lottery to hunt in the Mille Lacs, Carlos Avery or Whitewater wildlife management areas. Beginning March 1, all spring turkey hunters can purchase a license over-the-counter.

"We had really good participation last spring; license sales increased 36%, up 6,000 over 2019," said Leslie McInenly, wildlife populations program manager with the DNR. "This year we are carrying forward the changes we made last year."

Making up the increase last year was a 59% increase in youth license sales, while archery and adult firearms license sales increased 24% and 20%, respectively. Hunters harvested 13,996 birds, the highest harvest recorded since modern wild turkey hunting began in 1978 but similar to the 2010 harvest of 13,467 birds. The average harvest over the past 10 years has been 11,400.

"We're happy to see that people took advantage of the more flexible license structure last year and are looking forward to this spring," McInenly said. "Wild turkey restoration is a great conservation success

story and the expansion of their populations in Minnesota has allowed us to continue allow flexibility in hunting regulations."

2021 season details

Turkey season will be from April 14 to May 31 and is divided into six hunt periods, A through F (dates are in table below). Firearms hunters 18 and older must choose their hunt period when they purchase a license. Firearms turkey hunters can participate in Hunt F if they have an unused tag from one of the earlier hunt periods.

Firearms turkey hunters ages 18 and older who are interested in a permit to hunt in Mille Lacs, Carlos Avery or Whitewater wildlife management areas during A through C seasons will be required to apply for a lottery. The deadline to apply for those high-demand areas is Feb. 12. Successful applicants may hunt statewide, with the exception of the

other two lottery areas, in addition to their selected wildlife management area.

Archery-only license holders may still hunt statewide for the entire season (April 14-May 31). Hunters cannot purchase both a firearms and archery-only license.

Licensed hunters ages 17 and younger may hunt statewide for the entire season (April 14-May 31) with firearms or archery equipment.

Because there is no lottery for statewide spring wild turkey licenses, the landowner and tenant drawing, which had set aside a percentage of lottery licenses in each permit area for landowners with qualifying land, was discontinued, and landowners and tenants can purchase licenses like other turkey hunters.

Turkey lottery applications for the Mille Lacs, Carlos Avery or Whitewater wildlife management areas cost \$5 and can be purchased online at mndnr.gov/buyalicense, by phone at 888-665-4236, or in person from a license agent. Successful applicants will receive a notice in the mail and can purchase their hunting license starting March 1.
