Information We Collect

- Payment information (processed securely through third-party processors)
- Donation history and giving preferences

How We Use Your Information

We use the information you provide solely to:

- Send tax receipts and acknowledgment letters
- Communicate updates about our programs and impact
- Inform you of upcoming events, campaigns, or opportunities to get involved
- Comply with legal and reporting requirements as a 501(c)(3) nonprofit

What We Will Never Do

- ✗ We will **never share your name or giving information** with other organizations for their fundraising purposes
- ✗ We will **never contact you** on behalf of other organizations
- ✗ We will **never use your information** for any purpose beyond the scope of your relationship with The Re-Entry Connect Organization

Third-Party Payment Processors

Donations made online are processed through secure third-party platforms. These processors have their own privacy policies governing the handling of your payment information. We encourage you to review their policies when making a gift.

Record Retention

We retain donor records for a minimum of **7 years** in compliance with IRS requirements for nonprofit organizations. Records are stored securely and accessed only by authorized staff.

Children's Privacy

Our website and donation pages are not directed at children under the age of 13. We do not knowingly collect personal information from minors.
