**1. Welcome and Apologies**

As above. Item 3.(a) was taken at the outset. Item 7.(a) was taken after 5.(e). We thanked all who arranged, came along, and/or donated to local Xmas events. £800 had been raised for *Tummies not Trash*.

**2. 2026 Events**

- (a) During a Murrayfield Community Council (MCC) visit on 12 Jan, the ice arena said they sought to use their venue for other things in the May-August season. They hoped to connect these events with main stadium concerts and were open to other ideas. MCC suggested a John Lennon plaque, Doors Open Day, and Threadedinburgh.scot. This year there would be no FLY event. The Ice Hockey European Cup of Nations would be held on 5-7 February. **Action: JM** will maintain contact.
- (b) DD's working group had proposed two projects for Scottish Rugby funding: a suite of new park facilities with Friends of Roseburn Park (FoRP); and an app-guided trail along the Water of Leith from Balgreen to Wester Coates, with the Water of Leith Conservation Trust (WoLCT), for which DM had supplied an outline. **Action: DD/JM** would meet with Scottish Rugby to discuss.
- (c) No one had heard of plans for a Holyrood Election hustings. **Action: HR/JY** would look at the new constituency map and decide with whom we might discuss a hustings.

**3. Parking**

- (a) There was progress at last at the "garden" island of the junction of Balgreen Road and Glendevon Park. Parking on this during events had become a problem after the fence was removed. It was hoped that a new fence and double-yellow lines would prevent this. **Action: Cllr Beal** will attempt to direct officers to achieve this outcome first but could not commit to a deadline. He asked local neighbours to advise him of progress on the ground.
- (b) There was no further news about the proposed Controlled Parking Zone (CPZ) in Roseburn. There would be knock-on effects in Colbriidge, Murrayfield/Henderland and Saughtonhall.
- (c) Roseburn Cliff neighbours were divided on the merits of the Traffic Regulation Order (TRO) to reduce parking spaces in the street. There is now a scheme that allows carers to park in controlled areas.
- (d) It will take months to fix the gap between the double-red and double-yellow lines on Murrayfield Gardens. **Action: HR** would supply Cllr Beal with a list of neighbour complaints about this to date.
- (e) Parking tickets were being issued on the raised table junction of Roseburn Street and Roseburn Place.

4. Councillors' reports

(a) Cllr Beal intended to speak to 3.(a), 5.(a), 5.(c) and 6.(a) on the agenda. He had yet to raise the question of Lothian Buses route-change consultation process. He noted that the Balgreen Road / Saughton Crescent works were making good progress. Works were also expected: on Ravelston Dykes to ease cyclist passage between the Roseburn Path exit and the road; to resurface Corstorphine Road from Balgreen Road to Western Corner. He had no update on the re-siting of the Colbbridge Avenue bin hub. **Action: Cllr Beal** would ask Cllr Davidson for an update on progress of the bin hub.

5. Minutes of 2 December 2025 meeting and matters arising

(a) JBi reported from the Road Safety Group (RSG), as attached, but also: the RSG had received and commented on draft plans for the Ellersly/Kinellan pavement works just as the works had started, and lamented that this did not amount to useful dialogue, although MCC welcomed the start of the works; a new RSG member had supplied speed enforcement data for the area (attached).

(b) There had been no recent response from the City Centre West East Link (CCWEL) project about reinstating signs showing no-right-turn into Murrayfield Gardens from Corstorphine Road. **Action: Cllr Beal** would pursue the matter.

(c) The Craigmyle Tunnel designs are still under road safety audit but works are should start between 16 March and 3 April.

(d) Two speed surveys on Craigmyle Crescent had produced doubtful results. **Action: JBi** will put these on an RSG agenda and would forward data to MR if a further view was needed. Cllr Beal was asked to support requests for survey kit and data checks.

(e) There is a participatory budgeting project for locals to propose and decide the local use of Visitor Levy funds. **Action: HR** will invite the relevant Council Officer to our next meeting.

(f) The minutes of 2 December 2025 were approved (JY/JM) subject to the following additions: under item 6.(a) Cllr Beal had referred to the Junction of Balgreen Road and Glendevon Park; under item 7 the minutes of 14 October 2025 had been approved (JY/JM).

6. Planning and Licensing

(a) JC reported as attached, in which MCC further objected to the illuminated screen at 1b Russell Road (Tesco) (25/05546/LBC), objected to the shop sign at 101-103 Saughtonhall Drive (25/06275/ADV), and objected to the Lansdowne House development on 11-15 Colbbridge Terrace (25/06035 FUL / CON / LBC). It was unclear if there would be a hearing about Lansdowne House in the face of the large number of comments submitted. **Action: JC/JB** to forward details of objections to Cllr Beal's inbox.

(b) DM reported no change to his advice of the previous meeting about the 6 Hampton Terrace House of Multiple Occupation.

7. Reports

(a) HR referred to the Engagement & Inclusion report (attached). No one at the meeting wanted to become an admin for the suspended *Roseburn and Murrayfield Blether* Facebook group.

(b) JM reported accounts for November and December as attached.

(c) JY relayed a police report as attached.

- (d) GS reported for Donaldson Community Association (DCA) as attached and invited us to the AGM on 30 April.
- (e) MR reported for Saughtonhall Community Association (SCA) that an extension was being requested for the Hall works. He hoped there would be MCC members at the AGM on 2 February, which would include resolutions to end SCA, the unincorporated association, and adopt of the constitution of SCA, the Scottish Charitable Incorporated Organisation (SCIO).
- (f) BK reported for Friends of Roseburn Park (FoRP) as attached.

8. Any Other Business

- (a) JY hoped to attend the Edinburgh Association of Community Councils on 29 January, which would include a report on the survey of August 2025 into the Community Council elections of that year.
- (b) The outgoing Scottish Transport Secretary's had remarked that the Scottish Government would not fund a new north-south Edinburgh tram line and that the City Council should look to the Southeast Scotland Transport Partnership's SESTransit project.
- (c) The Community Council's AGM could take place at the earliest on 19 May 2026 (TBD).
- (d) Community Councillors were asked to advise HR if they could not attend the 7 April 2026 meeting because it was near to Easter.

The above are **subject to approval** at meeting of 24 February 2026.

## **Road Safety Group report for CC meeting 13 January 2026**

- There remains uncertainty about plans for the pavement improvement and crossing for Ellersly Road . Work was to be started in January, with scheduled resurfacing. but no recent communication from CEC;
- The work in Balgreen Road has progressed including a raised table and crossing points at the Glendevon Park junction: we are keeping an eye on 2026 developments
- Craigmillar Tunnel work awaits a start date: speed monitoring on Craigmillar Crescent has been undertaken
- On Murrayfield Road speed monitoring in 2025 has been completed: however, comparison with monitoring activity in 2019 is not possible due to changes in the location.
- The Road Safety Group meets Police Scotland on 14th January to discuss 20 mph enforcement, speed monitoring, criterial for road safety intervention, changes to the Highway Code as it affects pedestrians and work with local schools.

For the period 1<sup>st</sup> January 2022 to 9<sup>th</sup> September 2025, I can confirm that there were 19 FPNs issued for exceeding the 20-mph limit within the district EH1- EH17.

**Number of speed checks and campaigns carried out to monitor or enforce compliance with the 20-mph limit. Give clarifying remarks as appropriate.**

Road safety remains a national priority for police Scotland and is a local policing priority here within E Division. Our primary focus is casualty reduction and there are a number of tactical options at our disposal to help reduce the number of people killed and seriously injured on our roads. Speed enforcement is perhaps the most readily identifiable tactic among the public and is undertaken by Road Policing officers, Community officers and through safety camera deployment, both fixed and mobile.

The Police Scotland Standard Operating Procedure in respect of speed enforcement has been published online and can be found using the following link. This sets out clear direction and operational instruction for officers and staff involved in speed enforcement.

Road Policing officers carry a handheld speed detection device routinely whilst on patrol. In addition to this, the patrol vehicles are fitted with a calibrated speedometer which allows for offence detection whilst moving. Carrying out speed enforcement is a core and dynamic function and as such, the locations, times and duration of this activity is not specifically recorded

**B) Other enforcement actions carried out, if any,**

Edinburgh benefits from a network of fixed Safety Cameras and mobile Safety Camera Unit van deployments.

## **Planning Report** for Murrayfield Community Council Meeting 13 January 2026

3 Murrayfield Place – MCC was not involved but I can confirm that change of use from Class 1A (shop) to Class 3 (café) with restricted cooking facilities was granted to Francacia & Co (decision issued 08/12/2025).

MCC objected to the listed building consent application (retrospective) for the illuminated screen at Tesco, IB Russell Road; the advertisement application was refused.

MCC objected to the illuminated fascia sign at 101-103 Saughtonhall Drive. The fascia has been installed.

The Community Council has made submissions objecting to the proposed conversion and change of use with associated demolition and new build at Lansdowne House, 11-15 Colbridge Terrace. We did not comment on the proposed use but considered the whole scheme an overdevelopment of the site.
