USTF School Membership Certificates - Annual Registration Reminder

The USTF would like to remind all affiliated schools to submit their annual Taekwon-Do school registration. The registration is required each year for any school with more than 20 students. The annual fee is **\$50 per school** and must be submitted no later than **January 31st** each year. The school membership certificate program replaced the former USTF Plaque Program and serves as the official recognition of active school membership within the organization. Schools that complete their registration receive:

- Official USTF School Membership recognition
- Instructor discounts on USTF merchandise
- Confirmation of good standing within the USTF

There are no additional regional or state fees for any USTF school beyond this annual registration. When submitting your registration, please be sure to include the **official name of your Taekwon-Do school** to ensure accurate processing and certification.

USTF Annual Maintenance Membership Fee - Due March 30, 2026

The USTF reminds all members that the **2026 Annual Maintenance Membership Fee** is now due. The annual maintenance fee is **\$75.00 per individual** and must be submitted no later than March 30, 2026.
