### Terms and Conditions:

1. VEC Trust individual membership is open to any individual 18 years of age and holds citizenship of INDIA.
2. Individual member cannot use VEC Trust membership status on behalf of his/her company/institution they are employed at, unless the company/institution becomes an active member of the VEC Trust.
3. The Admission decision of a new member is subject to the approval of the VEC Trust Board of Trustees.
4. Membership fees payable by new member would be determined by the VEC Trust Board and will be communicated if approved.
5. The refusal of the membership application to VEC Trust is not subject to appellate.
6. The VEC Trust Member Board and Board of Trustees may apply from disciplinary penalties up to the termination of a membership if the member violates the VEC Trust Code of Conduct.
7. Registration process of new members will be conducted by the Board of Trustees.
8. The member of the VEC Trust has no rights over the Trust property (including any kind of fees paid/collected by the trust).
9. The Trust shall not be liable for the obligations of its members and its members are not liable for the obligations of the Trust.
10. A membership to the Trust does not deprive a person from his/her rights and freedoms as well as does not prohibit a person to occupy any positions at governmental bodies.
11. The Trust property cannot be divided among its members.
12. In the case of members' absence, he/she can choose authorized person who will have right to participate in the Assembly with due approval of President.
13. VEC Trust may have honorary members whose rights and obligations are set by the VEC Trust Board of Trustees.
14. Individual member elected as an Assembly member must be present to all Meetings. In case of 3 consecutive absences, the member gets a stern warning and may lose his/her membership and be dismissed from the Trust by the decision of Board.

### VEC Trust Members' rights

1. at supreme bodies of Trust and to vote, be elected as a statutory position of the VEC Trust;
2. to take part at the Trust Assembly and to vote or be elected as a President and Secretary of the Assembly;
3. to vote at the Trust Assembly where the individual membership holder has the right to vote once;
4. to propose constructive offers, remarks, activities and projects to the governing bodies in order to improve the work of the VEC Trust.;
5. to demand complete information about the VEC Trust;
6. to terminate the membership agreement between the VEC Trust in written form;
7. to participate in the VEC Trust organized events and be informed about the Trust news;
8. to get from the VEC Trust any legal, financial, material, ethical, moral support;
9. to get continuous professional development opportunity;
10. to be involved and participate in Working Groups meetings in accordance with his/her will;
11. to participate in the trainings or other courses that Trust partner organizations will provide with significant discounts;

### VEC Trust Members' are obliged

1. to increase the VEC Trust reputation and to fulfill diligently all his/her duties;
2. to accept responsibilities to any agreed task within the timeframe.
3. to meet the VEC Trust requirements, Trust's governing bodies' decisions;
4. to support the replenishment of the VEC Trust membership list;
5. to take part in the events and projects held by the Trust
6. to understand and share the Trust's goals and objectives;
7. to be able to explain the Trust's activities and targets;
8. to explain the Assembly his/her personal motives and purposes to become a member;
9. to advise the Trust President of possible win-win collaboration;
10. never accept/offer any sort of bribes to those correlated with the Trust's activities;
11. to avoid strictly any kind of conflicts of interest;
12. to pay the membership fees in timely manner;
13. to use his/her business network for finding funds and investments for the Trust's activities;
14. to be involved in official dinners/events organized to expand the Trust's network;

### The membership fee size and procedures for the payment

1. The size of annual membership fee is set by the Board of Trustees.
2. According to the membership types either monthly or annual membership fees should be paid cash to the Trust or transferred to Trust's bank account.
3. Annual payments must be made before the 5th day of next renewal month.
4. Membership fees are non-refundable under any circumstances.
5. Membership fees are the property of the Trust and may be used for the implementation of the organizational goals
