

Reservation Contract

I, _____, This _____ day of _____, 20____, enter into this adoption contract and acknowledge new ownership of puppy on pick up day described as: _____(name) , Cavalier King Charles Spaniel (breed) , (sex), ____/____/____(birth date), _____(color), _____(registration type).

A Non-Refundable Reservation fee- Buyer acknowledges that the Reservation fee is non-refundable in all circumstances, including but not limited to if Buyer decides they do not want or is no longer able to take the puppy. Upon receipt of the reservation fee, Breeder agrees to hold the puppy for Buyer until the pickup date agreed upon. The Reservation fee shall be made in the Breeder's preferred method(s) of payment.

Holding Fee- A fee of \$15.00 (fifteen dollars) a day accumulating to and including the day of pick up will be required for holding the puppy past original pick up date stated. This fee may be asked for upfront when agreement to hold puppy longer is made. Holding fees must be paid before puppy is released to new owner, failure to do so by new agreed to pick up date will terminate your rights and a new owner will be found. Written, text, e-mail files etc. act as proof of correspondence and/or if this is a mutual agreement to hold pup for a fee and the new pick up date set. If you (the buyer) do not notify the breeder or the breeder does not agree to hold the puppy past the pick up dates or you do not show up to pick up your puppy by the latest pick up date a new owner will be found and your rights will be terminated. Should the breeder need to hold back the puppy for treatment related to health you will not be charged for those days and a new pick up date will be agreed upon. This is to protect both parties, and to ensure the puppy has a new home to go home to on the pick up date.

Traveling Fee/Mileage Charges- We prefer to meet you! You are more than welcome to come to our home in Kermit, WV. With a scheduled appointment to pick up your new puppy. We do ask for precautions to be took, (shoes off, clean clothing, wash hands) before you enter, this is to protect the puppies. There is no additional charge for the above option. Breeder is willing to deliver the puppy to Tri-State airport in Huntington, WV. Should you arrange to have us deliver your puppy or meet you at any other location, we charge a non-refundable fee of \$0.70 per round trip mile from our home. (amount based on Federal mileage rate set by the IRS). Travel arrangements must be discussed and agreed upon in advance by both parties and must be paid before the puppy is released to the new owner, failure to do so will terminate your rights and a new owner will be found.

Shipping Fee - We also offer to hand off your puppy at the Tri-State airport in Huntington, WV for you or a Flight Nanny to pick up and fly your puppy home in the airplane cabin. If we have to travel to a different airport our mileage charge will apply. Transportation arrangements, flight costs, travel costs, mileage costs, nanny fees, health certificate, airline approved pet carrier and any other travel supplies needed is the responsibility of the Buyer. Please contact us for additional information if you are planning to fly your puppy. We need to make sure that we plan for obtaining a veterinary health certificate to fly and correct size pet carrier for the specific airline you will be using.

Forms of payment for deposit- Breeder accepts Money order (for deposits only and only if there will be enough time for it to clear the bank), PayPal (if using PayPal method buyer must contact the breeder first due to PayPal's charge for additional fees). Good Dog (pay.gooddog.com/stonecoal-cavaliers) All additional fees are the responsibility of the buyers.

Remainder of Price upon delivery- Breeder accepts Cash or Good Dog (pay.gooddog.com/stonecoal-cavaliers) This payment is for the remainder of the balance for the puppy (minus non-refundable reservation fee), boarding fee (if applicable), traveling fee (if applicable), shipping fee (if applicable). All additional fees are the responsibility of the buyer.
