RESEARCH HYPOTHESIS

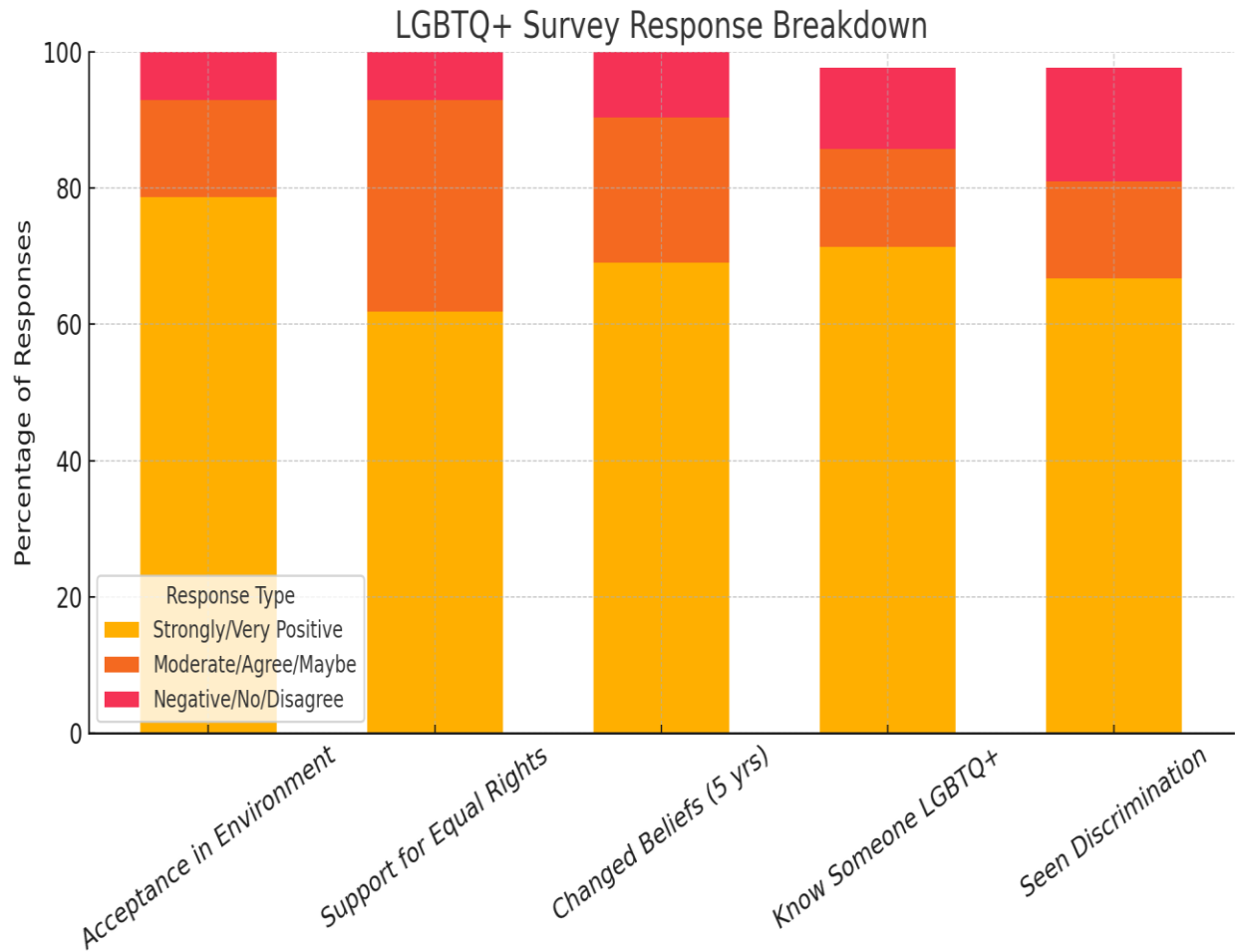
- **H₁:** When society learns more about LGBTQ+ people and their identities, it becomes more accepting, supportive, and less discriminatory.
