#### **PROCESSING CONDITIONS**


The actual extrusion conditions will depend on the type of equipment used and the size and wall thickness of the pipe required. The following conditions should be used as a guide when starting up the extruder.

Following parameters should be used as guidelines for extrusion:

Cylinder	170-190°C
Die	180-200°C
