

## CONTRACTOR SERVICE AGREEMENT

This Agreement explains Contractor's obligations to Customer (hereafter referred to as, "Client", "Customer", or "You") and TLR LLC D/B/A Dolce Detailers (hereafter referred to as "Contractor", "Us", "Our", or "We" ) and Your obligations to us in relation to the service(s) You purchase.

By using the Contractor services, You hereby agree to the following terms:

1. **ACCESS TO WATER & ELECTRICITY:** For remote contracts, We require access to water and electricity for all of Contractor's car detailing services.
2. **OPERATING & MOVING YOUR VEHICLE:** You authorize us to operate and to move Your vehicle, as deemed necessary by Contractor, without approval so long as the distance is less than 100 yards.
3. **QUALITY OF SERVICE:** No services offered are guaranteed to restore Your vehicle to any previous condition. We will make best efforts to deliver the best condition reasonably possible within the constraints of Contractor's resources, time, and expertise.
4. **FINAL INSPECTION:** We will conduct a final inspection with You at the end of the job. Contractor will not be responsible for any concerns following final inspection after payment and We return keys to You.
5. **ACCIDENTS, PRE-EXISTING CONDITION AND DAMAGE:** We use high quality chemicals and equipment and widely accepted industry processes in providing Our services. Although rare, accidents, damage, or adverse alteration of serviced surfaces can happen. If something does get damaged, altered, or a pre-existing condition is discovered while detailing Your vehicle, we will notify You.
6. **CHARGES AND OVERRUNS:** In the event a project is deemed to take longer than reasonable due to undisclosed conditions, Contractor will notify Client and may charge an additional fee to continue servicing the vehicle. Contractor will not charge an additional amount without Client approval but may cease services as a result.
7. **PHOTOS:** You authorize Contractor to take and publish photos of your vehicle so long as no identifying information (plate, VIN, etc.) are visible in said photos.
8. **CLIENT CAUTION:** Client acknowledges that Contractor may use treatments or chemicals that may leave a slick or slippery residue on various surfaces, such as: pedals, steps, door frames, handles, steps, knobs and levers. Client assumes full responsibility for any risks or injury associated with these conditions and surfaces.
9. **CONTRACTOR LIABILITY:** You acknowledge and agree that Dolce Detailer's liability for any services performed under this Agreement does not exceed the monetary value/charge for the services covered by this Agreement.
