Note: Tasks vary weekly based on campaigns. Agents must complete 3–5 tasks weekly to remain active.

Application Requirements

Applicants must meet rigorous criteria aligned with South African standards, evaluated through a tiered shortlisting system designed by the Board of Directors to prioritize committed and capable agents.

Standard South African Requirements

1. **South African Citizenship or Residency:** Valid South African ID, passport, or residency permit.
2. **Age Eligibility:** 18 and older.
3. **Non-Discrimination:** Inclusive of all genders, races, and backgrounds.
4. **Declaration of Interest:** Statement (200–300 words) on why you want to join and how you'll contribute to DEI HUB's mission.
5. **No Criminal Record:** Police clearance certificate or affidavit confirming no pending charges (submit post-shortlisting).
6. **Consent to Data Use:** Agree to data use for monitoring and promotion, per the Protection of Personal Information Act (POPIA).

Program-Specific Requirements

1. Digital Literacy

- Demonstrate proficiency in social media (e.g., Instagram, WhatsApp) and basic content creation (e.g., photos, videos).
- **Mandatory Documentation:**
 - Short digital skills quiz (10 minutes, completed post-application).

2. Commitment to Engagement

- Attend a mandatory 2-day virtual onboarding session and weekly check-ins (1 hour each).
- **Mandatory Documentation:** Signed commitment letter (provided post-shortlisting) agreeing to engagement terms.

3. Technology Access

- Access to a smartphone with reliable internet for task management.

4. Performance Monitoring

- Consent to tracking task completion, content quality, and campaign impact.
- Meet minimum thresholds (e.g., 80% check-in attendance, 12 monthly tasks).
- **Mandatory Documentation:** Signed performance monitoring agreement (post-shortlisting).

5. Financial and Tax Compliance

- Readiness to receive payments via bank transfer and comply with tax obligations.
- **Mandatory Documentation:**
 - Valid SARS Tax Clearance Certificate or declaration to register for tax (support provided post-selection).
 - Bank account details in applicant's name.

6. Content and Conduct Standards

- Adhere to DEI HUB's ethical content guidelines (e.g., no misinformation, respectful communication).
- **Mandatory Documentation:** Signed code of conduct agreement (post-shortlisting).

7. Tiered Shortlisting System

- Evaluated by the Board of Directors into:
 - **Tier 1:** Experienced digital users with strong content skills and community ties.
 - **Tier 2:** Emerging users with basic skills and high motivation.
 - **Tier 3:** New users needing training but showing commitment.
 - **Scoring:** Digital skills (35%), community impact (30%), motivation (25%), documentation (10%).
 - **Mandatory Documentation:** All required documents submitted with application; certified copies within 7 days if shortlisted.

Application Process

Follow these steps to apply:

1. **Complete Online Application:** Submit the digital form including:
 - Personal details, declaration of interest, and required documents.
 - Optional sample content to strengthen your application.
2. **Document Submission:** Upload all mandatory documents. Incomplete applications are disqualified.
3. **Screening and Shortlisting:** Applications scored by the Board for Tier 1, 2, or 3 placement. Shortlisted candidates notified within 2 weeks.
4. **Digital Skills Quiz and Interview:** Shortlisted applicants complete a 10-minute quiz and may attend a virtual interview to assess fit.
5. **Onboarding Notification:** Successful agents receive confirmation within 3 weeks, with onboarding session details.
