

Note: Activities vary based on business needs and program cycles. Participants must engage in at least one live event or training per quarter and attend monthly check-ins.

# 4. Tools and Support

#### 5. Application Requirements

To ensure a rigorous and fair selection process aligned with South African standards, applicants must meet the following criteria. The program employs a tiered shortlisting system designed by the Board of Directors to prioritize businesses with strong growth potential.

#### **Standard South African Requirements**

- 1. **South African Citizenship or Residency:** Provide a valid South African ID, passport, or proof of legal residency.
- 2. Age Eligibility: Applicants must be 18 years or older, with no upper limit to encourage diverse entrepreneurs.
- 3. **Non-Discrimination**: Open to all genders, races, and backgrounds, promoting inclusivity.
- 4. **Declaration of Interest:** Submit a statement (200–300 words) outlining your business, its challenges, and how the program aligns with your growth goals.
- 5. **No Criminal Record:** Provide a police clearance certificate or affidavit confirming no pending criminal charges (submit post-shortlisting if selected).
- 6. **Consent to Data Use:** Agree to the program's use of data for monitoring, evaluation, and promotion, compliant with the Protection of Personal Information Act (POPIA).

# Program Eligibility Criteria

To be considered for participation in the Digital Economy Hub Program, applicants must meet the following core requirements:

#### **Screening & Selection**

- Applications are reviewed and scored based on:
  - **Business Viability** (35%)
  - Digital Readiness (25%)
  - **Community Impact Potential** (25%)
  - **Documentation Quality** (15%)
- Candidates are placed into one of the following support tiers:
  - $\circ$   $\,$  Tier 1: Established businesses with digital growth potential.
  - **Tier 2**: Emerging businesses needing moderate support.
  - **Tier 3**: Early-stage or informal businesses showing high commitment.

# **Application Process**

#### Step-by-Step Guide:

#### Step 1: Submit Application

- Complete the digital form at [Insert Website Link].
- Include:
  - Personal and business information.
  - Business overview (200–300 words).
  - All mandatory supporting documents.

#### Step 2: Document Upload

- Upload required documentation in the application portal.
- Incomplete or missing files may lead to automatic disqualification.

#### Step 3: Shortlisting & Tiering

- Your application will be reviewed and scored.
- Shortlisted candidates are notified within 3 weeks.

#### Step 4: Optional Interview

• Some shortlisted applicants may be invited to a virtual interview for final assessment.

#### Step 5: Final Selection & Onboarding

• Successful applicants receive onboarding materials and join the program within 4 weeks of application closure.

#### Q. What is the Digital Economy Hub Program?

A: The Digital Economy Hub Program empowers small businesses by providing access to cutting-edge tools, training, AI support, and networking opportunities to help businesses grow and connect to the digital economy.

#### Q. Who is eligible to apply?

A: The program is open to **small businesses** (formal or informal) that have been operational for at least **6 months** and are willing to commit to using digital tools, attending monthly check-ins, and engaging in training and networking events.

#### Q. How do I apply?

A: Complete the **online application form** on our site www.digitaleconomyhub.org Ensure all required documents are uploaded before submission. Incomplete applications will not be considered.

#### Q. When can I expect to hear back?

A: After submission, the **shortlisting** process takes **up to 3 weeks**. Shortlisted candidates may be invited for an interview. Successful applicants will receive onboarding details within **4 weeks** after the application deadline.

# Q. What is the duration of the program?

A: The program runs for **12 months**. During this time, participants will engage in monthly checkins, events, and training sessions. After the first year, there may be opportunities for continued support through mentorship and premium tools.

# Q. Are there any costs involved?

A: There are **no fees** for applying to the program. However, participants must commit to engaging with the provided tools and attending required events and training.

# Q. Do I need to be tech-savvy to apply?

A: While a basic level of **digital literacy** is required (e.g., email use, social media), the program is designed to support businesses at all levels of digital readiness. We will provide tools and support to help you grow your digital skills.
