Born from Passion and Purpose:

In January 2024, a team of crypto enthusiasts, IT leaders, and problem-solvers joined under the OPTA banner.

Driven by a shared vision, they aim to:

- **Unlock Mass Adoption:** Identify and address the key barriers preventing widespread acceptance of cryptocurrencies and tokenized assets.
- **Real-World Solutions:** Develop practical applications that demonstrate the true potential of crypto beyond speculation.
- **Optimised Security:** Prioritising risk management, compliance, and robust governance to safeguard user assets.

Tokenomics: Fuelling Growth and Rewarding Holders

OPTA's tokenomics are meticulously designed to ensure a robust token while providing holder rewards, security, and a flexible framework for continued growth.

OPTA Token (ETH):

- **Total Supply:** 100,000,000,000
- **Launch Price:** \$0.0000004
- **Distribution:**
 - Public (Uniswap): 55% (facilitating easy access for investors)
 - Archangel Reclamation: 10%
 - Team Allocation: 5%
 - Treasury and Operating Costs: 30% (partnerships, exchanges, marketing & operational expenses, etc.)
- **Transaction Tax (6% on both Buys and Sells):**
 - Liquidity: 2% (continuously adds liquidity to the token pool, stabilising price)
 - Operations Budget: 2% (supports project operations and development)
 - Marketing budget: 2% (provides funds to utilise towards marketing)

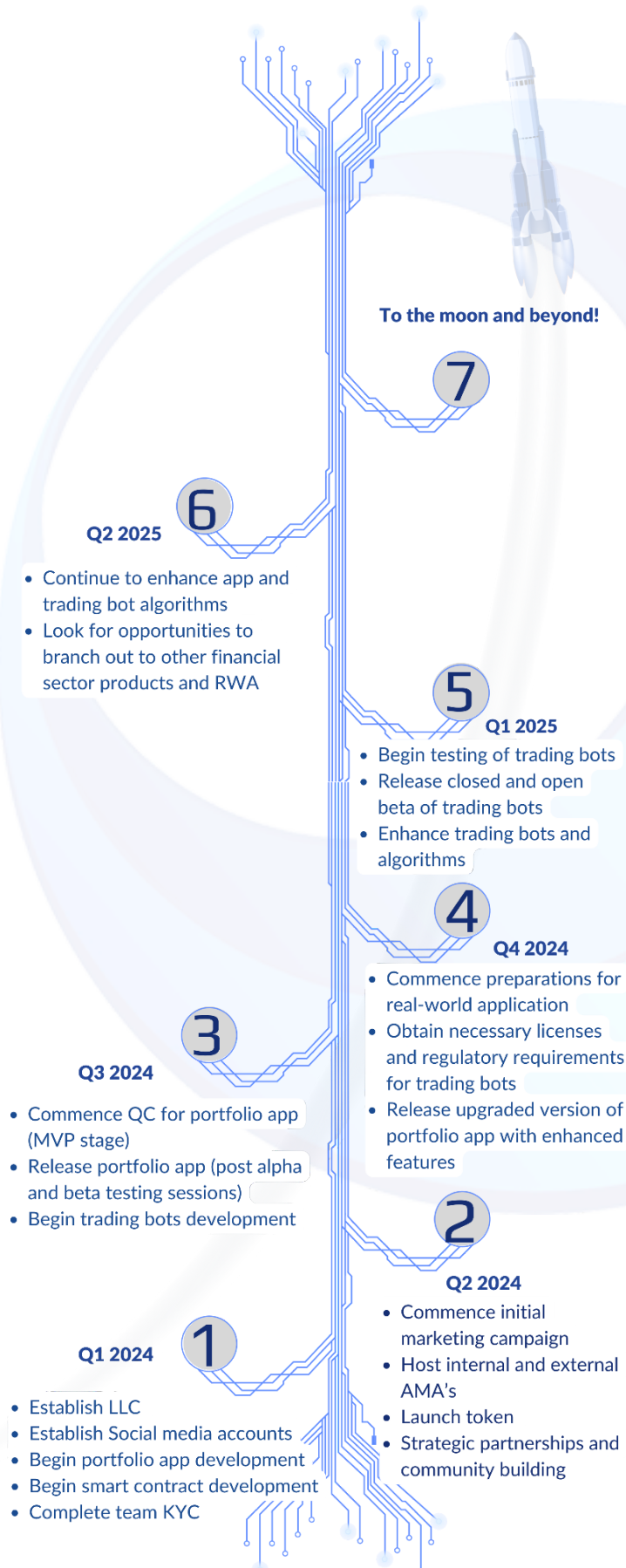
Anti-Whale Sell Tax: 25% Tax on Whale Sells – For any sells more than 3% of tokens in LP in a single transaction (Split is Marketing 10% Development 10%, Liquidity 5%)

Project features

- **Multi-Signature Wallets:** Critical wallets (deployer, operations budget, marketing) require multiple signatures for enhanced security. (4-5 signatures)
- **Transparent Allocation:** A significant portion of tokens is reserved for essential purposes like (but not limited to) exchange listings, marketing initiatives, staking pools, charitable contributions, etc.
- **LP Security Measures:** Liquidity is locked for 1 year (protect holders against migrations from an inability to adapt to any regulatory or scalability opportunities in the future) through a reputable service, and a security audit will eventually be conducted by a recognized firm.
- **KYC Compliance:** The project team has undergone internal KYC verification for added transparency and security.
