Fire Door Inspections

Why Fire Door Inspections Matter

Fire doors are a critical line of defence against the spread of fire and smoke. Regular inspections confirm that every door within your building will perform as intended — protecting lives, property, and escape routes in an emergency. Routine fire door inspections also ensure compliance with UK fire safety legislation, including the Regulatory Reform (Fire Safety) Order 2005, Fire Safety (England) Regulations 2022, and the Building Safety Act 2022.

What's Included in an NFDI Inspection

Each certified inspection is carried out by a qualified NFDI fire door inspector, following national standards such as BS 8214:2016 and BS 9999:2017.

- Door leaf and frame condition — checking for damage, warping, or incorrect fit.
- Intumescent and smoke seals — correct type, position, and continuity.
- Hinges and ironmongery — CE/UKCA marked, correctly fitted, and maintained.
- Door closers — effective operation and self-closing action.
- Signage and identification — compliant 'Fire Door Keep Shut' markings.
- Gaps and clearances — measured to BS 8214 tolerances.
- Glazing and vision panels — suitable glass and installation.
- Thresholds and floor finishes — ensuring unobstructed closing.

Inspection Frequency Recommendations

Building Type	Suggested Frequency
Multi-occupied residential (11m+)	Communal doors every 3 months; flat entrance doors annually.
Hospitals / Care Homes / High-risk	Every 6 months.
Schools / Offices / Commercial	Annually.
