Small Works Spring Art Show

Eligibility – Open to all artists 18 and over residing or working in Westminster.

Media: Original fine art executed on canvas, paper, board, or similar approved fine art material. Maximum size is 11x14”, or 154 sq in, not including frame. Anything smaller is okay. Gallery wrapped canvases must have painted/finished edges.

All artworks must be original to the artist. Paletteers Art Club reserves the right to refuse any artwork that does not comply with requirements stated here.

NOT ACCEPTED: computer-generated art; photography; giclee or reproduction prints. In case of question, the juror’s decision will be final. ***All work displayed must remain for the duration of the exhibit.***

Entry Fees – \$25 for up to 2 entries
Make checks payable to Paletteers Art Club. Fees are non-refundable.

Awards – Ribbons and cash awards will be given for 1st, 2nd, 3rd place, plus honorable mention in the show. Throughout the show, the public can vote on People’s Choice Award.

Presentation of Entries

All art works must be delivered ready to display. All artworks **must have wire securely attached** – recommended with screw eye or d-rings, and wire. **No sawtooth hangers. Entries with broken glass, chipped frames, wires that are not secure, will not be accepted.**

Artwork that is delivered with damaged frames, chipped, cracked or dirty, or with improper presentation will be disqualified. Each piece must be identified on back of piece at bottom, with artist name, address, phone number, title, and price.

Dates to Remember

March 29th - Registration Form and entry fee must be received by Mar 29th.

Sunday, April 13, 12pm to 2pm – Hand deliver artwork to ***Fuse Box Container Gallery, 8898 Westminster Blvd.*** (across from Alamo Theaters).

Friday May 2nd – Reception and Award presentation, 5pm to 7pm.

Sunday, May 4th, 3 to 5pm – Take down show and artists pick up artwork. We are not able to store any paintings. **All unsold artworks must be picked up by 5pm.**
