



## **Ending Crony Capitalism:**

For example, the collapse of the case against Eurasian Natural Resources Corporation (ENRC) by the UK's Serious Fraud Office (SFO) highlighted the influence of wealthy oligarchs and their ability to wield legal and financial power to stymie justice.

Addressing crony capitalism requires implementing robust regulations that promote transparency, accountability, and fair competition, ensuring that business practices serve the public interest rather than private gains.

# SYNAPTOCRACY

# Synaptocracy:

# Case Study:

## National Identity Cards

---

In a scenario where a national vote on implementing ID cards resulted in a narrow margin—51% in favor and 49% against—our solution would respect both perspectives while upholding the integrity of the system. In a Synaptocracy, striking this balance fairly would be achieved by implementing an opt-in/opt-out ID card system.

### Opt-In ID Card System

- **Voluntary Participation:** Citizens would be free to choose whether to obtain an ID card, ensuring that those who support the initiative can participate, while those who oppose it are not compelled to comply.
- **Incentives For Adoption:** To encourage participation without mandating it, the **Vicontenate** will highlight the inherent benefits to ID card holders, such as convenience, streamlined access to public services, expedited processing in administrative tasks, and personal peace of mind.
- **Public Awareness Campaigns:** We will educate citizens on the advantages of possessing an ID card, allowing individuals to make informed decisions based on their personal preferences and needs.

### Opt-Out ID Card System

- **Unrestricted Opt-Out:** Individuals can opt out of the system at any time, without penalty or conditions, if they felt their privacy was compromised.
- **Enhanced Privacy Protections:** The system will incorporate robust data protection measures, including encryption and strict access controls, to safeguard personal information.
- **Independent Oversight:** An independent body will oversee the implementation and operation of the ID system, ensuring compliance with privacy standards and addressing any grievances.

This system respects individual choices, offering options without imposing requirements, thereby accommodating diverse perspectives and upholding personal freedoms.

# THE ECONOMY

We will redefine financial ethics, declaring all forms of interest immoral and illegal. A new Golden Age of financial freedom and security is upon us.

**In 2020, as 11.7 million people sunk below the poverty line, the UK paid over £109 billion in interest payments to private banking cartels.**

We consider this a crime against the state. We should never tolerate such economic injustice. We will bring those responsible to account and the people of this country will be fully reimbursed for all historical interest payments made since the first Bank of England loan in 1694. Our estimates put this at £5 trillion.

## **Reimbursing The British People:**

### **Holding The Bank Of England To Account**

Since 1694, approximately 990 million citizens have lived and died in the UK.

All 68.35 million registered citizens living in the UK will receive a one-off payment of £5,050 - injecting more than £345 billion into the UK economy.

Payments owed to the 921.65 million deceased will fund a newly established public pensions and palliative care account. This total would be approximately £4.2 trillion.

## **Taxing Based On Responsibility And Negligence**

Our tax system will target destructive and negative outcomes, such as those perpetuating the economy of scale. The highest taxes, up to 90%, will be applied to companies and individuals that profit from misery or disaster, or manufacture, distribute, or sell products or services that destroy or pollute the environment.

We will abolish Inheritance Tax, tiered Income Tax, National Insurance, and Capital Gains Tax. Instead, a single 5% Citizen's Contribution will be introduced.

A flat rate of 15% Corporation Tax will be applied to every company. No business will be exempt. Every business wishing to trade in the UK will be required to register and bank with Companies House. All payment systems will be operated by Companies House, replacing all existing systems. Revenue will be held in escrow for 30 days, and Corporation Tax will be taken at source on a monthly basis.

## **Tax Reductions And Tax Exemptions**

Tax contributions will be reduced for individuals who participate in a voluntary capacity for any of a number of national infrastructure initiatives and help alleviate the financial burdens taken on by the state.

Tax reductions will apply only to “planet-positive” organisations whose operations directly enhance quality of life and/or repair environmental damage.

## **A Thriving Economy That Invests In Your Health And Well-Being**

Research confirms the alarming correlation between economic struggles, poor health, and rising suicide rates. It's time for change. Instead of wasteful spending, we will prioritise allocating funds to support those in need.

The economy directly affects the well-being of our nation, transcending demographic boundaries. We will build an economy that prioritises the health and happiness of every individual. We pledge to invest in mental health resources, not only by providing comprehensive care but by tackling the root causes of distress.

By nurturing a thriving economy that uplifts all, we can foster a society where physical and mental well-being flourish, and passion will replace rapaciousness.

# No More Interest. No More Inflation.

In our new economy, charging or paying interest on monetary loans becomes unlawful. It's time to recognise the impossibility of repaying debts with the limited money in circulation, and the criminal nature of the fractional banking system.

We will establish, strengthen and encourage world trade agreements with other Riba nations.

And because the government has created so much false fear around terrorism, they felt justified in spending a staggering £371bn on so-called 'Social Protection'.

Now compare the £604bn spent on debt and destruction, to:

Meanwhile, the U.N. Food Program estimates we need only \$40 billion (£33.3 billion) to end world hunger.

It's glaringly obvious that every government for centuries has been guilty of misappropriating public funds in favour of expanding its industrial military complex and police state, or lining the pockets of their wealthy corporate friends and lobbyists.

We would ensure the largest portion of public spending goes to maintaining infrastructure, supporting industry, and improving the quality of life for UK citizens. All UK debt would be expunged and we would no longer charge or pay interest on loans, thanks to our new, interest-free, state-run currency.

# Case Study:

## Iceland

### **The Peaceful Revolution Never Reported**

Following the recession of 2009/10 the people of Iceland made the government resign, they nationalised the primary banks, and it was decided not to repay the debt the banks created with Great Britain and Holland due to their bad financial politics. Instead, a public assembly was created to rewrite the constitution.

An entire revolution against the powers that created the crisis was achieved peacefully, which is why there has been no publicity. If the world knew that this could be done and other countries followed this Shining example, the fractional banking system would collapse overnight.

### **Arrests And Exile**

The government initiated an investigation to bring to justice those responsible for the crisis, and many high level executives and bankers were arrested.

Interpol also dictated an order that forced all of the implicated parties to leave the country.

## **A New Constitution:**

### **By The People, For The People**

An assembly was then elected to rewrite a new Constitution. It includes the lessons learned and substitutes the now defunct Danish Constitution. Out of 522 candidates, 25 citizens with no political affiliation were chosen to form a new Constitutional Assembly. Candidates were required to be aged 18+ with at least 30 supporters.

The Constitutional Assembly began in February 2011 to present a new 'carta magna', formed from the recommendations given by the various assemblies that occurred across the country. It was then approved by Parliament and by the one constituted through the next legislative elections.

### **Not Revolution, But Evolution**

We would repeat this proven strategy. But what would a peaceful revolution in Britain really mean?

2. The abolition of all private banking organisations.

# Case Study:

## Switzerland

In June 2016, Switzerland held a landmark referendum on implementing an unconditional basic income (UBI), becoming the first country to conduct a nationwide vote on this concept. The proposal suggested providing a monthly income of 2,500 Swiss francs to every adult and 625 francs per child, aiming to ensure a dignified standard of living for all residents. Despite the innovative nature of the proposal, it was decisively rejected, with 76.9% of voters opposing it. Several factors contributed to this outcome:

1. **Economic Concerns:** Critics argued that funding the UBI would be prohibitively expensive, potentially costing over 200 billion Swiss francs annually. This raised fears of significant tax increases and potential cuts to public services.
2. **Work Ethic And Social Values:** Opponents contended that providing income without requiring work could undermine the intrinsic value of employment, possibly leading to decreased motivation and a decline in workforce participation.
3. **Immigration Concerns:** There was apprehension that a guaranteed income might attract individuals from other countries seeking financial benefits, potentially straining Switzerland's resources.
4. **Skepticism Of Feasibility:** Many viewed the UBI as a utopian idea lacking practical implementation strategies, leading to doubts about its viability within Switzerland's socio-economic framework.

While the proposal was not adopted, the referendum succeeded in sparking a nationwide discussion on social welfare and economic security. Notably, a significant portion of the younger population viewed the vote as the beginning of an essential national conversation, recognising the need to address future challenges such as job automation and economic inequality.

However, there have been localised efforts to explore UBI within Switzerland. In November 2024, the city of Bern's council approved a pilot project to provide a basic income to 300 residents, marking a first for the country. The project, with an estimated cost of 9 million Swiss francs, aims to assess the feasibility and impact of UBI at the municipal level.

While comprehensive results from Bern's initiative are not yet available, this pilot reflects a growing interest in evaluating UBI's potential benefits and challenges within specific communities.

As of February 2025, Switzerland has not implemented a nationwide Universal Basic Income (UBI) program.

In summary, the Swiss electorate's rejection of the UBI initiative was influenced by economic concerns, cultural values emphasising work, fears of increased immigration, and skepticism about the proposal's practicality. Nevertheless, the referendum played a crucial role in initiating ongoing debates about the future of social welfare in Switzerland.





# HIGHWAYS

## **Britain's Roads: Stronger. Safer. Faster. Fairer.**

We will restore Britain's roads to excellence with a bold, comprehensive vision:

**Rebuild and Resurface** — Britain's major roads will be resurfaced using superior, high-grade materials that improve fuel efficiency, last longer, reduce noise, and are safer to drive on. We will benchmark against France and other leading nations to ensure we exceed global standards.

**Intelligent Design** — All new and upgraded roads will feature separated pedestrian and two-way cycle lanes, divided from traffic by grass verges and safety barriers. At the moment, France receives eight times the number of affluent Chinese tourists than the UK, with Germany welcoming six times as many.


That's because to visit most countries in Europe, foreign tourists need only apply for a single—Schengen—Visa. The UK requires a separate, and more complicated and intrusive form.

Economic damages, also known as special damages, compensate for tangible financial losses directly resulting from an incident, such as medical expenses and lost earnings. Non-economic damages, or general damages, address intangible losses like pain and suffering.

By focusing on compensating actual financial losses, we aim to discourage frivolous lawsuits driven by the prospect of excessive financial gain. This approach ensures that victims receive fair restitution without encouraging opportunistic legal actions. Implementing this policy would involve a thorough assessment of each case to accurately determine the victim's financial losses. This ensures that compensation is both fair and reflective of the actual harm suffered, maintaining the integrity of the legal system and upholding the principle of fairness.

## **Affordable Legal Representation:**

### **Capping Legal Fees**

Access to legal representation is a cornerstone of justice, yet high legal fees often place it beyond the reach of many individuals. To address this disparity, we propose implementing a cap on legal fees, ensuring that essential legal services remain affordable and accessible to all. These A.I. systems will offer guidance, draft documents, and provide preliminary advice, ensuring that all citizens have access to essential legal support. By embracing technological advancements, we aim to bridge the justice gap and uphold the principle that legal assistance should be a universal right, not a privilege limited by financial capacity.

# Greenhalgh's Law: Prohibition of Exploitation of Crises and Misfortune for Financial Gain

---

## **Introduction:**

Recognising the imperative to protect human dignity, animal welfare, and the environment, this legislation seeks to eliminate the exploitation of crises and misfortune for financial gain. It aims to establish a just society where the well-being of all living beings and the preservation of natural resources are paramount.

By fostering a culture that values prevention over profit from adversity, we can inspire individuals and organisations to act with integrity and compassion. This approach not only addresses immediate challenges but also builds resilience and a strong moral foundation within our society.

## **Explanatory Notes**

Greenhalgh's Law aims to create a fair and ethical marketplace by eliminating practices that profit from human suffering, animal exploitation, and environmental harm. By establishing the Ethical Commerce Commission and implementing targeted taxation, the law seeks to incentivise responsible business practices and protect the well-being of all living beings and the planet.

In part, this legislative framework draws inspiration from, and aims to replace, existing UK environmental tax measures, such as the Climate Change Levy and the Plastic Packaging Tax, both of which were sold as a means to encourage businesses to operate in an environmentally friendly manner. However, it is worth noting that the Plastic Packaging Tax has not discouraged businesses to use alternatives to plastic, nor has it resulted in the legalisation of plastic alternatives such as hemp. Instead, it has merely become another stealth tax placed upon the consumer. Additionally, the law aligns with the UK's commitment to achieving net-zero greenhouse gas emissions by 2050, as outlined in the Environmental Improvement Plan 2023.

## Section 1: Definitions

1. **Exploitation:** The act of profiting from human or animal suffering, or environmental degradation, through the manufacture, trade, promotion, or provision of products or services.
2. **Crisis:** A significant event or series of events causing widespread distress, hardship, or disruption, including but not limited to natural disasters, pandemics, economic downturns, and conflicts.
3. **Misfortune:** An event or circumstance leading to hardship or adversity, such as accidents, illnesses, or personal tragedies.
4. **Environmental Degradation:** The deterioration of the natural environment through the depletion of resources, destruction of ecosystems, and pollution.

## Section 2: Prohibition Of Exploitative Practices

1. It shall be unlawful for any individual, corporation, or entity to manufacture, trade, promote, or provide products or services that profit from human or animal suffering, or environmental degradation.
2. This prohibition extends to all sectors, including but not limited to healthcare, entertainment, finance, and retail.

## Section 3: Establishment of Regulatory Bodies

1. A new regulatory body, the Ethical Commerce Commission (ECC), shall be established to oversee and enforce the provisions of this law.
2. The ECC shall have the authority to:
  - a. Monitor and assess products and services for compliance with this law.
  - b. Investigate and prosecute violations.
  - c. Implement educational programs to inform the public and businesses about ethical practices.

## Section 4: Taxation And Financial Measures

1. A new tax system shall be implemented targeting products, services, and entities that profit from misery, disaster, or environmental destruction.
2. The tax rates shall be structured as follows:
  - a. High taxes on products and services that exploit crises or environmental degradation.
  - b. Incentives and tax reliefs for businesses adopting sustainable and ethical practices.

## **Section 5: Transition And Implementation**

1. A transition period of 12 months from the enactment of this law shall be provided for businesses to comply with the new regulations.
2. During this period, the ECC shall offer guidance and support to assist businesses in aligning with ethical standards.

## **Section 6: Enforcement And Penalties**

1. Violations of this law shall be subject to penalties, including fines, sanctions, revocation of business licenses and, in severe cases, imprisonment.
2. Penalties shall be proportionate to the severity of the violation and the harm caused to individuals, animals, or the environment.

## **Section 7: Review And Amendments**

1. This law shall be reviewed every five years to assess its effectiveness and make necessary amendments.
2. Public consultations shall be conducted to gather input from stakeholders, including businesses, consumers, and environmental groups.

## **Section 8: Title**

This Act may be cited as "Greenhalgh's Law: Prohibition of Exploitation of Crises and Misfortune for Personal Gain."

---

By enacting Greenhalgh's Law, the UK will set a precedent for ethical governance, ensuring that economic activities contribute positively to society and the environment, rather than perpetuate a recipe for disaster, misery, and suffering.

## CRIME & POLICING

We don't believe tackling crime is about creating more rules or taking away people's rights and freedoms. **Real crime prevention** means understanding why people turn to crime in the first place and tackling those problems head-on.

### **A Crime-Free Society:**

#### **The Outcome Of Visionary Stewardship**

Crime rates in the UK have historically been linked to unemployment and economic crises. Many individuals classified as criminals often commit offenses in response to these challenges. What society defines as crime, some may view as a means of survival. This is because, when money, opportunity, and a sense of hope are scarce, people often feel that crime is the only answer. And often without a solid education or happy childhood, the chances of turning to a life of crime become ever greater.

We regard every crime as a failure of current leadership and policy. The persistence of societal issues and rising crime statistics reflect a lack of effective governance and a failure to address underlying problems. Some would even argue this is done intentionally to perpetuate a totalitarian police state and justify ever-growing budget allocations for despotic authoritarian measures.

## **Prevention Rather Than Cure:**

### **Addressing The Root Cause Of The Problem**

The need to address the issue of crime never goes away and over the years we have seen it invade our schools and homes to a staggering degree. We can stop this self-destructive cycle by fulfilling our promises; by investing in the things that really matter, by managing our economy sensibly, by improving everyone's standard of living and by giving everyone the opportunities and support they need to achieve their life goals and ambitions.

If we are to significantly reduce crime we must turn to the root of the problem and put preventative measures in place. To ultimately eradicate crime, we must completely eliminate the reasons people turn to crime to begin with. We will begin to avert any further social and economic crises simply by providing people with a secure home and safe community in which to live.

To address pressing issues within UK policing, we propose a comprehensive reform strategy focusing on recruitment, integrity, structural consolidation, authority reassessment, and community relations.

## **Recruiting The Right Candidates**

We aim to attract individuals who embody the qualities of peacemakers, diplomats, and those with a genuine commitment to public service. To achieve this, we will implement comprehensive psychological assessments for all applicants and existing officers. These evaluations will assess candidates' mental resilience, emotional intelligence, and capacity for empathy, ensuring they are equipped to handle the complexities of modern policing.

While the Myers-Briggs Type Indicator (MBTI) is a widely used tool for understanding personality types, its application in police recruitment is limited. We are committed to eliminating corruption within the police force. Only individuals of the highest moral standing will be entrusted with the responsibility of upholding the law. This entails rigorous vetting processes, continuous monitoring, and a culture that promotes transparency and accountability. The Angiolini Inquiry has highlighted the need for enhanced vetting and aftercare to maintain public trust.

By adopting a single, integrated platform, Local Authorities can streamline processes, improve data sharing, and ultimately deliver more consistent and effective services to the public in a fraction of the time, and with minimal effort and error.

## **Settings New Standard**

### **Building A World-Class Preventative Healthcare System**

Under Visionary stewardship, public healthcare funding would only be granted to those offering preventative care, fitness and therapy products and services, organic nutrition, and wellness education.

Commercial opportunities would continue to be created through preventative products and services, thus incentivising industry to support the genuine well-being of the population rather than perpetuating illness and disease.

### **Healthcare Is A Basic Human Right**

To oppose this principle is to suggest that a sick person who has no money should be left to suffer and die. Only the most repugnant individuals would allow this.

Furthermore, "Greenhalgh's Law" would prevent any company or individual from profiting from the sale of any kind of medication, cure or remedy that produced harmful side-effects.

Such individuals may encounter significant restrictions on their medical practice, including the potential revocation of their licences, to uphold the integrity of healthcare delivery and ensure patient safety. Unethical drug promotion poses risks to patient health, underscoring the need for strict enforcement to maintain public trust in the medical profession.

By implementing these measures, we aim to foster a healthcare environment that supports ethical medical practice, prioritises patient well-being, and provides necessary assistance to practitioners confronting the moral implications of their past actions.

## **Prevention Is Better Than Cure**

Being overweight, a lack of exercise, poor diet, and excessive consumption of drugs and alcohol, shortens life expectancy, exposes us to a greater risk of illness and infection, and costs the NHS over £6 billion a year.

We can't force people to join a gym, but we can make sure that the support they need is available and that they are not exposed to poor quality food or unnecessary health risks.

We will achieve this in two key areas.

### **1. A National Network Of Lifestyle And Fitness Venues**

We believe sports and recreation venues, and accredited influencers can provide the people of Britain with accessible and affordable, year-round fitness facilities and activities.

Sports venues up and down the country hold the key to providing the people of Britain with accessible and affordable year-round activities that will help them improve their physical and mental well-being and maintain an optimum level of overall health and fitness.

Subsidised by the **Vicontenate**, a national network of free lifestyle and fitness venues will open up a range of facilities and classes to support today's diverse and alternative lifestyle choices. By providing free access to sports activities, preventative therapies and other proven treatments, we will help people conquer their addictions and health-harming habits.

Venues would form part of an upgraded National Health & Social Care Service that would integrate:

- Existing national health services
- Gym and leisure facilities
- Medications and prescriptions
- Organic food outlets supplied by inner-city Skyscraper Farms
- Counselling, advisory and support services
- Members of the national volunteers network
- Lifestyle management support

## 2. Reducing Processed Food In The Food Chain

Reducing the prevalence of processed foods in our food chain is essential for improving public health and decreasing the burden on the NHS. Diets high in ultra-processed foods have been linked to an increased risk of health conditions such as obesity, type 2 diabetes, and heart disease.

### **A Future We Can All Look Forward To**

#### **Combining Healthcare, Social Care, And Third Sector Services**

The state of the mind and the state of the body; these two things lie at the core of our healthcare and social care systems. One attempts to help us preserve our physical health, whilst the other attempts to help us develop and sustain social skills and independence. Social care and healthcare are intrinsically linked but for many decades have been administered separately. It's only been in recent years that the two departments have openly discussed integration as a means of reducing costs and boosting competences. That integration must not only continue but also be accelerated, by centralising healthcare and social care departments and providing easy access to information and support services in city centres, high-streets and rural areas.

Simply by streamlining and integrating existing services, we will improve efficiencies and reduce costs exponentially.

# Introducing:

## A New, National Volunteers Network

**Both our healthcare and social care systems are supported by a nation of volunteers, charities, community centres, advisory services, and support groups. Without that additional resource a crucial component of our nation's infrastructure would collapse.**

But that may well happen if we don't prepare; as the population continues to grow, people live longer and the demand for those services increases. We must act now in establishing a stable system that delivers quality services as a direct result of streamlining working processes, reducing operational costs, and increasing efficiencies across the board.

We propose the merging of all health authority departments and registered third sector health and welfare organisations to roll out a new Social Care System; a system that would utilise a single platform to manage and operate all public health services and enable greater knowledge sharing and communication across the UK.

### **The National Volunteers Network (NVN)**

The NVN would be open to all non-profit organisations, charities and community groups and their members.

By registering, organisations would have the opportunity to offload assets in exchange for access to operational facilities and healthcare resources that would better help their volunteers to serve their communities.

Not only that, but donations and funds—raised through the sale of assets—would go further, and more people would receive the help they so desperately needed.

Each NVN county division would fall under the remit of their respective local authorities.

**The NVN Would Utilise:**

- National Health Service (NHS) hospitals, GP practices, and dental clinics
- Local authority town halls and offices
- Council housing
- Libraries
- Community centres
- Vacant or under-utilised council buildings
- Vacant and derelict shops, homes, and warehouses

**Benefits:**

**Enhanced Service Delivery:** By integrating opt-in third sector organisations, healthcare charities, and the National Health Service, we can help more people in less time. Leveraging existing facilities such as NHS hospitals, GP practices, dental clinics, and community centers also allows for the efficient provision of services without the need for new infrastructure. This approach also ensures that resources are utilised effectively, leading to improved access and quality of services.

**Economic Revitalisation:** Transforming vacant and derelict properties into functional spaces will stimulate local economies. For example, adaptive reuse of commercial real estate has been shown to increase property values and attract businesses, thereby boosting local tax revenues.

**Environmental Sustainability:** Repurposing existing buildings reduces the environmental impact associated with new construction, including the consumption of resources and energy. It will also result in long-term cost savings through energy and water efficiency and improve the appearance of our high streets.

**Cost Savings From Adaptive Reuse:** Repurposing vacant properties can lead to significant cost savings. For instance, a study on supportive housing found that providing housing to chronically homeless individuals resulted in a net savings of nearly £30,000 per person per year in publicly funded services.

**Public Infrastructure Savings:** Implementing sustainable practices in public buildings can result in annual savings of approximately £3.7 billion through a 20% improvement in energy efficiency.

We pledge to establish a new state pension model, initiating a fund for every citizen from birth, ensuring financial security and healthcare from retirement until life's end.



# A New Pension Model

## Old Age In The Modern Age

A steadily ageing population, combined with longevity and a greater demand for care services means that the UK will continue to come under tremendous pressure to support a growing community of older people. That community will one day include all of us; you and I, our children and theirs. No one can avoid old age, but we can avoid the trauma and discomfort so many old people suffer today because we as a society refuse to provide adequate care and security.

That kind of security depends on our early incentive to start saving as soon as possible, but it's often something we put off or ignore altogether. For most of us however, the reason is simply because we are never left with enough money to invest in a pension, when the small amount we can spare makes such a big difference to the immediate future. Choosing between food on the table today or a roof over our head in forty years time is not a concern we should ever have to live with. Especially when we pay into a system that was set up to do one simple thing: Provide.

If there's one thing we all know, it's that—when it's not being raided by corrupt politicians—the current state pension is insufficient to support an elderly person in the modern world. It's not because there is insufficient money in the system, it's because public money is misspent by the government, leaving people like you to pick up the tab.

## Financial Security In Old Age

Under Visionary stewardship, you will have a pension, acquired and grown from the day you're born, that guarantees an income and healthcare from retirement until the day you leave us.

### **Under The Proposed New System:**

The new state pension model will see every citizen given a 100% guaranteed and protected pension fund from the day they are born that will pay out a minimum income from the day they retire.

- The pension age will be set at 62 for men and women.
- A state pension account will be opened for everyone from the day they are born, provided the birth is registered.
- Every month, each parent would pay a compulsory minimum contribution of 2% of their salary or into each pension fund.
- At the end of each calendar year, the state would match contributions made.
- Contributions would be held in a secure national savings account — guaranteed and protected, but earning no interest.
- From the age of 21, and upon entering part or full-time employment, account holders would inherit their state pension account.
- Upon inheriting the account, they would be given the option to use up to 50% for investment. This would include property, shares, or **Vicontenate** Bonds.
- The remaining balance would be locked until retirement.
- Account holders would be required to maintain monthly contributions in order to receive matching state contributions.
- Minimum contributions would rise to 10% on inheritance and would remain fixed until retirement.
- Optionally, larger contributions could be made and the state would continue to match up to 25% of each contribution above the 10% base rate.
- Upon retirement, account holders could opt for a single sum or fixed monthly payments.
- Monthly pensions payments would be made in addition to any form of UBI (Universal Basic Income).

## **The 21st Century Pensioner**

For people paying into this system for the first time there will be no state pension fund to inherit on retirement. We would therefore propose a pro-rata contribution is made by the state to everyone in the UK whose year of birth falls within an elected period.

Based on the national averages at the time of implementation, the contribution made would be equal to the amount each person would have received had the system been in place when they were born.

Introducing this change immediately will give us an opportunity to learn important lessons now, rather than in a generations' time.

This structured approach ensures that from birth, individuals have a secured financial foundation, bolstered by both parental and state contributions, leading to substantial financial security upon retirement.

UK state pension funds would be made available in addition to the UK state UBI (Universal Basic Income).

# Case Study:

## A Single Parent Family

Under the proposed new pension system, let's examine the scenario for a single-parent family with a below-average annual income of £28,000:

### Parental Contributions:

- Annual Contribution: 2% of £28,000 equates to £560 per year.

### State Matching Contributions:

- Annual Match: The state matches the parent's annual contribution of £560.
- Total Annual Contribution: Combining both contributions is £1,120 per year.

### Total Contributions Over 18 Years:

- Over 18 years, the fund accumulates £20,160.

### Inheritance of Pension Account:

- Upon entering employment at age 21, the individual inherits their pension account, which has accumulated £20,160.

### Investment Option:

- Available for Investment: The individual can opt to use up to 50% of the fund, which is £10,080, for investments such as a home deposit, shares, or **Vicotenate** bonds.

### Continued Contributions Post-Inheritance:

- Assumed Annual Salary: Upon employment, the individual earns the average UK salary, which was £34,963 for full-time employees in 2023.

- Contributing 10% of this salary equates to £3,496.30 per year.
- State Matching Contribution: Assuming the state matches 25% of the individual's contribution, this adds £874.08 annually.
- Total Annual Contribution: The combined annual contribution is £4,370.38.


### Total Contributions Over 41 Years (Ages 21 to 62):

- Accumulated Contributions: Over 41 years, the total contributions amount to £179,195.58.

### Total Pension Fund at Retirement (Age 62):

- Final Pension Fund: Adding the initial inheritance of £20,160 to the accumulated contributions results in a total pension fund of £199,355.58.

# Transforming The Housing System

**The quality of our living spaces directly impacts our mental and physical wellbeing. This includes the homes we build, the spaces we shape, and the environments we inhabit.**

## **Superior Standards**

New planning laws will introduce minimum standards for room size, ceiling height, and architectural design — rejecting cramped, profit-driven layouts in favour of intelligent, health-affirming spaces that allow energy to flow.

## **Modern, Planet-Friendly Materials**

Hemp will be legalised and elevated — establishing Britain as a global leader in the production of eco-conscious materials, from breathable hempcrete and thermal cladding to low-VOC paints, insulation, wall panels, and structural composites.

## **Future-Proof Homes**

Modern homes will be beautiful, functional, and self-sustaining. All new-builds will be fitted with silent wind turbines, battery storage systems, and geothermal piping to reduce dependence on fossil fuels and centralised energy monopolies. Water independence will be encouraged through potable water tanks and underground collection systems.

## **Better Planning**

We will outlaw the banality of modern urban design. Beauty, individuality, and bio-integrated architecture will be brought to the fore. Planning regulations will reward innovation over repetition.

Off-road driveway turntables will become standard for all new homes with vehicle access — reducing accidents and street congestion. Homeowners will be eligible for grants to retrofit these via the new Highway Commission.

# Ending Homeless Hypocrisy

**Britain is awash with unused homes—nearly 1 million vacant dwellings in England alone, with approximately 272,000 long-term empties not lived in for more than six months.\* Meanwhile, 1.2 million people are on council housing lists, and rising homelessness haunts our streets and public spaces.\*\*.**

This grotesque paradox—empty homes standing while people sleep rough—is a moral and tactical failure we will fix. The time to act is now. There are more than enough empty homes to end homelessness **overnight**.

## **International Covenant on Economic, Social & Cultural Rights**

The UN recognises the right to adequate housing as fundamental. Though not yet legally binding in UK courts, it must guide our moral and political will.

## **Reclaiming The Empty To House The Homeless.**

Under the Housing Act 2004, local authorities have the power to deploy Empty Dwelling Management Orders (EDMOs) to bring long-term vacant properties back into use. Where necessary, councils may compulsorily purchase derelict sites under the Town and Country Planning Act 1990, the Land Compensation Act 1961, and related statutes — provided the action serves a compelling public interest.

## **To Tackle Homelessness Head-On, We Will:**

- Launch a **National Vacant Dwellings Drive** to swiftly identify and reclaim vacant housing stock.
- Use **EDMOs** within six months of vacancy and convert suitable homes into secure accommodation.
- Where owners refuse to co-operate, councils will **compulsorily purchase** properties at market value and allocate them immediately for housing.
- **Prioritise transitional support** for individuals and families as homes become available — ending rough sleeping with stability, not slogans.

We pledge to reclaim these homes, restore community life, and ensure that every person has the security, dignity, and belonging they rightfully expect.^

# Buying A Home

We will change that.

First-time home ownership will be **state-funded** through the issuance of a new **interest-free sovereign currency**. If you borrow £250,000, you will repay £250,000 — not a penny more. No compound interest. No inflationary profiteering. Just fair access to the foundational right of belonging.

The housing revolution is not about more of the same — it's about creating future heritage: homes that honour the past, meet the demands of the present, and anticipate the world to come. It's about rekindling national pride, restoring economic sanity, and giving people something real to protect and believe in.

# DRAFT BUDGET

Reconstructing the UK's budget to prioritise renewable energy, education, healthcare, social care, housing, and infrastructure, while eliminating government loan interest payments and consolidating defence and emergency services, requires a comprehensive approach. Additionally, considering a £4.2 trillion rebate from the Bank of England for historical interest payments backdated to 1694 would significantly impact fiscal planning.

## Key Assumptions:

1. **Elimination Of Government Loan Interest Payments:** Redirecting funds previously allocated for interest payments into priority sectors.
2. **Consolidation Of Armed Forces, Defence, Police, And Emergency Services:** Streamlining these services into a unified expenditure category to enhance efficiency and reduce costs. Merging defence and emergency services must be managed carefully to maintain operational effectiveness.
3. **£4.2 Trillion Bank Of England Rebate:** Utilising this rebate to offset existing national debt and fund strategic investments.

## Debt Reduction Strategy:

- **Application Of £4.2 Trillion Rebate:** Allocate the £4.2 trillion rebate directly to national debt reduction. With the UK's national debt approximately at £2.9 trillion, this rebate would not only eliminate the debt but also provide a surplus of £1.3 trillion.
- **Investment Of Surplus:** The surplus can be invested in a sovereign wealth fund, generating returns to support ongoing and future public expenditures, further reducing the need for borrowing.

This revised budget framework aims to strengthen key public sectors while addressing national debt, contingent upon the realisation of the hypothetical rebate and successful policy implementations.
