



PAYMENT STRUCTURES

NO CASH PAYMENTS ACCEPTED - DIRECT DEPOSIT INTO SUPPLIED BANK ACCOUNT ONLY

1. A 30% Deposit is required.

2. 5% Early Settlement Discount: Only given on full payment within (60) Sixty days of Quote Date.

3. **0 - 6 Months** : Holds Quoted price for a period of (6) Six Months with a 30% deposit.

4. **6 - 12 Months - Over** : All price increases come into effect.

RULES, TERMS AND CONDITIONS

- 1. The order is irrevocable and cannot be cancelled. The memorial will remain the property of Tegg's Granite until full payment has been made.
- 2. Payment of deposit will constitute acceptance of all terms, conditions and contractual agreements whether the Order confirmation (F87) is signed or not.
- 3. No verbal communication can override or cancel any written Terms, Conditions, Rules, Regulations or written literature.
- 4. A minimum of 30% deposit will be required which will hold the price of the memorial for a period of (6) Six Months.
- 5. 5 % Early Settlement Discount on full payment within (60) Sixty days, maximum, after date of Quote (F062)
- 6. The purchaser is liable for all expenses incurred in recovering any outstanding balances due to the seller.
- 7. Should cancellation of an order be accepted, within the required cooling down period of a maximum of (5) Five days, thereafter a 30% administration fee on the total purchase price will be charged.
- 8. Tegg's Granite has the right to stipulate the deadline date and time for the full and final payment, wording and fitting, to the client in order for Tegg's Granite to fulfill and meet the clients unveiling date requirements.
- 9. The purchaser must supply final payment, designs, wording and fitting requirements on the stipulated date to meet their unveiling date.

 Any postponement could result in an (8) eight week lead time after final payment and inscriptions have been received.
- 10. The purchaser accepts all responsibility of pointing out the correct grave to the seller for the purpose of fitting the memorial.
- 11. The onus is on the purchaser to ensure that they know exactly where the grave site is a minimum of (10) working days before the day of fitting the memorial.
- 12. The purchaser hereby consents to the jurisdiction of the Magistrates Court of Pietermaritzburg in regard to any claim or dispute, which may arise by virtue of this transaction.
- 13. The person placing the order confirms that they have the authority to do so and that they are fully aware of its contents and accept responsibility for the payment thereof.
- 14. The following Fitting Rules, Terms and Conditions, as per (Fitting Requirements brochure F) are applicable. Failure to comply will result in additional labor and transport costs at the current daily rate.
 - 14.1. Late appointments / arrivals at the meeting place.
 - 14.2. False / incorrect information resulting in fitting **NOT** being **COMPLETED** on the day booked.
 - 14.3. Clear access to the grave site.
 - 14.4 Grave site to be clear of rocks, vegetation and or any existing structures.
 - 14.4 Roads to the grave site to be in a roadworthy condition during rain_/ wet and dry conditions.
