



Consent Form



Code of Conduct

This document outlines the rules of behavior expected from Delegates of Logos MUN. It is a legal document between the Logos MUN Organizing Team and Delegates at the 3rd Logos MUN conference. Delegates must commit, through signing the Consent Form that explicitly mentions the Code of Conduct, that they have been informed and understand the responsibilities that fall on them as laid down in the policies and extracted in the Code of Conduct. Participation in the event is conditional on having agreed to this Code of Conduct. A signature of a legal guardian is also required.

Applicability: “Delegates” includes everyone attending the event, besides Officials and guests.

Commitment to integrity

1. Delegates are obliged to behave in a way that does not reflect negatively on Logos MUN, and other participants at the event.
2. Delegates are obliged to behave in a way that does not reflect negatively on the Organizing Team, and should therefore respect all rules established by the Organizing Team, including, but not limited to:
 - a. participating in all mandatory items of the programme in a timely manner;
 - b. respecting the venues where the event is taking place, and their respective rules;
 - c. not abandoning the group or premises of the event without explicit permission to do so by the Head Organizers;
 - d. in case of any circumstance preventing the participant from participating in any items of the programme, the Organizing Team should be informed in advance.

Behavior and non-discrimination

3. Delegates must behave respectfully towards other participants. This includes:
 - a. maintaining a positive and welcoming environment for all participants;
 - b. not engaging in conduct that is unfair or abusive towards others;
 - c. respecting cultural, religious, and personal differences;
 - d. not discriminating against any other participant on the basis of their age, sex, gender identity, sexual orientation, physical or mental disabilities, religion, national or ethnic origin, family status, marital status, or any other status.
4. Bullying or harassment of any kind- whether verbal, non-verbal, physical aggression, sexual or emotional- is not tolerated. This includes any form of online harassment or bullying.



5. Recording or taking photos without the consent of the individuals who appear in those videos or photos, is strictly prohibited. In addition, using any video or photo or recording or screenshot in a manner hurtful to another Participant or Student Officer is strictly prohibited.

Sexual conduct and relationships

- 6. Delegates must respect national laws setting the age of sexual consent.
- 7. Logos MUN operates under a clear consent culture. Everything that is not a yes is a no.
- 8. Delegates are expected to promote a safe environment free from sexual misconduct.

Alcohol consumption and drug use

- 9. Logos MUN respects national law and limits to the use of alcohol and tobacco accordingly.
- 10. No Delegates should put themselves in a position in which they are unable to fulfil their duties or participate in the session programme due to overindulgence.
- 11. The consumption or use of any drugs, whether legal or not in the country in which the participant is located, is strictly forbidden throughout the duration of the event.

Illegal Conduct

- 12. Delegates are obliged to comply with national law.
- 13. The Delegates are obliged to abide by national legislation pertaining to illegal activity taking place in cyberspace. In the opposite event, criminal or civil liability might ensue.

Duties and responsibilities

- 14. Every individual should intervene to stop inappropriate behavior when noticed (be it bullying, harassment or other harmful or dangerous behavior). Serious incidents should be reported to the Organizing Team either directly or indirectly through a Student Officer.

Consequences

- 15. Violation of this Code of Conduct will result in appropriate disciplinary action at the discretion of the Organizing Team including, but not limited to:
 - a. reprimands.
 - b. expulsion from the event at the participant's own expense;
 - c. legal action in case of unlawful behavior;

Behavior of participants

I recognize that upon arrival and throughout the duration of the event, he/she must follow the given regulations for the venue and must follow all instructions given by the Organizing Team

Transfer of rights

For the duration of the event, I transfer the right to his/her image to the Logos MUN Organizing Team and give my full consent to being photographed, filmed and interviewed by other participants as well as authorized guests of the event. Further, I give my full consent to having his/her/their personal data (including all media footage) stored digitally for an unlimited time. I give my full consent to redistribution and editing thereof by Logos MUN, and to being contacted by the Logos MUN Organizing Team in the future.

Violations of law, code of conduct or misconduct

I acknowledge that in case of a violation of Greek law during the event, or of violation of the Code of Conduct (e.g., abuse of alcohol), or in any other serious case of misconduct on his/her/their part as decided by the Logos MUN Organizing Team, he/she/they will be excluded from the event and will be sent home immediately at my own expense.
