**This is a contract between Happy Tails Bed and Biscuit and the pet OWNER whose signature appears below (hereinafter called "OWNER").**

1. All pets must be current on the following vaccines prior to their arrival:  
DHPP, Rabies, Bordetella
2. If your dog(s) is staying with us for an extended stay (over 21 days), we require a 50% down payment at check-in.
3. **CANCELLATIONS: Any stay of 3 or more nights will be booked with a charge of a 2 nights stay. (Non-Refundable if canceled within 2 weeks of stay) Shorter stays will be billed for 1 night if canceled within the week of stay.**
4. Current rates for Boarding are \$25.00 per night for 1 dog each additional dog is \$20 if housed in the same run.  
Daycare charge of \$10 for day of pick-up if picked-up in the afternoon  
Medication administration is \$1.00 per med per day.  
  
\* If additional cleaning is required above and beyond our daily routine (bowl accidents, vomit, or blood) an additional \$5.00 per cleaning will be added to your pets bill to cover the cost of product and time.
5. By signing this Contract and leaving their pet(s) with Happy Tails Bed and Biscuit, Owner certifies the accuracy of all information given about said pet(s).
6. Happy Tails Bed and Biscuit shall exercise reasonable care for the pet(s) delivered by the Owner to Happy Tails Bed and Biscuit for boarding. It is expressly agreed by Owner and Happy Tails Bed and Biscuit that Happy Tails Bed and Biscuit's liability in no event exceeds the lesser of the current value of a pet of the same species or the sum of \$200.00 per animal boarded.
7. The Owner further agrees to be solely responsible for any and all acts or behavior of said pet(s) while it is in the care of Happy Tails Bed and Biscuit.

8. Owner specifically represents that the pet has not been exposed to rabies, distemper, kennel cough, or parvo within a thirty-day period prior to boarding.

9. All charges incurred by Owner shall be payable upon pick-up of the pet. Happy Tails Bed and Biscuit shall have and is hereby granted a lien on the pet(s) for any and all unpaid charges resulting from boarding pet(s) at Happy Tails Bed and Biscuit.

The Owner agrees that in the event the boarding charges are not paid when due in accordance with this contract, Happy Tails Bed and Biscuit may exercise its lien rights upon ten days written notice given by Happy Tails Bed and Biscuit to Owner by certified mail to address shown on contract. An animal unclaimed at Happy Tails Bed and Biscuit for ten(4)days beyond its scheduled discharge date is considered abandoned and will become the property of Happy Tails Bed and Biscuit. Every effort will be made to contact the owner, if abandonment becomes an issue.

10. **If for any reason the animal(s) is not going to be picked up on the scheduled dismissal date, Owner shall contact Happy Tails Bed and Biscuit to make arrangements to extend the animal's stay and will pay the additional charges based upon the aforesaid daily rate.**
11. If the pet(s) becomes ill or if the state of the animal's health, solely in the opinion of Happy Tails Bed and Biscuit otherwise requires attention, Happy Tails Bed and Biscuit, at its sole discretion, is authorized to engage the services of a veterinarian or arrange for other requisite attention to the animal up to and including \$200.00 or **(Owner specify amount) \$ \_\_\_\_\_**, whichever is greater.
12. Owner agrees to release, indemnify, and hold harmless Happy Tails Bed and Biscuit from any and all manner of damages, claims, loss, liabilities, costs or expenses, including reasonable attorney's fees and related costs, arising out of or related to Happy Tails Bed and Biscuits' services, including, without limitation, (i) any inaccuracy in any statement made by yourself or information provided by you to Happy Tails Bed and Biscuit (ii) your dog, including but not limited to destruction of property, dog bites, injury, and transmission of disease, (iii) any action by yourself which is in breach of the terms and conditions of this agreement and (iiii) any action by yourself or others in your party that result in injury to person while on premise.

13. This contract contains the entire agreement between the parties. All terms and conditions of this contract shall be binding on the heirs, administrators, personal representatives and assigns of the owner and Happy Tails Bed and Biscuit. Any controversy or claim arising out of or relating to this contract, or the breach thereof, or as a result of any claim or controversy involving the alleged negligence by any party to this contract, shall be settled in accordance with the rules of the American Arbitration Association, and judgment upon the award rendered by the arbitrator may be entered in any Court having jurisdiction thereof. The arbitrator shall, as part of his award, determine an award to the prevailing party of the costs of such arbitration and reasonable attorney's fees of the prevailing party.

## Please Read and Sign below.

1. ALL vaccines must be updated and kept current. Vaccines must be administered no later than two weeks prior to boarding. No more last minute kennel cough boosters 😊
2. We are requesting that dogs scheduled for boarding be limited to outside of home doggie exposure 7 days prior to boarding.
3. A health assessment will be performed by Christine at time of drop off. There is a form to be signed by the owner after assessment has been completed.

### **If a dog is found to exhibit signs of illness, they will be denied stay.**

Please do not bring your dog if they have any of the following:

- Runny nose (other than regular pup cold nose)
- Sneezing that is continuing
- Discharge from eyes
- Shows signs of lethargy
- Shows signs of possible temperature
- Diarrhea

5. Appointments for dropping off and picking up will continue. Please make sure to be on time to your scheduled time.

We will continue our cleaning procedures, using a vet grade solution to clean all spaces, bowls and water buckets.

We will no longer be sharing water buckets in the play yards.

These small changes are in place to help keep all of our furry friends safe and healthy.
