Dear Donors, Corporate Sponsors and those who have supported **Hochoka Retreat Center**:

Thank you for your continued support and interest in the farm.

During 2024 we have completed phase one of the building which entails the office, bathhouse, tiny house model, hay barn, up-fitting 1950's barn for animals' living spaces. We also have served many people in 2024 providing summer camp; retreats; breath-work; and private client sessions.

Our fund-raising goal for 2025 is \$500,000.00. This will be used for finishing the upstairs barn loft for living space for homeless teen girls/girls who have aged out of foster system; and to build tiny houses for retreat guests; older women in transition; and men who want to live/work with the farm and its maintenance needs. Both the barn loft and tiny houses will be able to house 10 people when complete. We are using the finished model of tiny house living as a show piece; and the good community of builders we have developed for building. This is to help the community to counter the high cost of apartment rentals and mortgages; teaching people how to have a home without the huge expense; and to live simply.

The pictures on the back of this letter are some of the farm guests we served in 2024. EnJOY and see the love these horses and this farm convey. It is in a LOVE environment in which we heal and grow. Some of the children we have served have never been in the energy of love; only stress of trauma from life events. Adults also suffer from trauma of life experiences held in the body. The farm makes a difference in teaching relationship through love and trust of a 1500-pound horse! Love heals.
