RULES & REGULATIONS

1. Name of the Society: -

The name shall be **HELP Society** referred to as the "Society" in these rules and regulations.

2. Address: -

3. Membership, Category & Fee: -

Member of Society is extended to all citizens of India irrespective of caste and religion who contributes to the ideas of the Society is eligible of the Member

The Society offers two types of membership, that is: -

- a) Individual b) Honorary

Individual Member Ship: -

- I. Subject to the bye-laws, any person who is desirous of utilizing the services of the Society may express his or her willingness to accept the responsibilities of Membership and fulfill such other conditions as may be specified in the bye-laws of the society and there upon he / she may be admitted as a member, subject however to the condition that the Society is in a position to extend its services to the applicant and that the applicant is not already a member of any Society registered under this Act., providing the same or similar services.
- II. A person admitted as member may exercise the rights of membership, including the right to vote, only on fulfillment of such conditions as may be laid down from time to time decided by the General Body in accordance with the bye-laws.

However, such individual, having the belief in the aims and objectives of the society and strives to work for the upliftment of the poorest of the poor, who is intending to get admitted as member upon payment of the prescribed annual membership fee decided by the General Body from time to time shall enroll himself / herself in the society. However, the admission of any member in the society is purely the prerogative of the General Body, provided that such person.
- IV. Has attained the age of Maturity.
- V. Is of sound mind.
- VI. Is not adjudged by a court as insolvent, or is an un-discharged insolvent individual or society.
- VII. Has not been decreed to wind up any offence involving moral turpitude.
- VIII. Is not carrying on business or activity of such kind which is in conflict with the objects and interest of the society.
- IX. Is not a member of any other society providing the same and similar services.

Honorary Member Ship: -

- I. Any corporate body under any legal frame work that is in force for the time being in India whose aims and objectives are in consonance with the Society, represented by its President, Secretary or any one who is so authorized to represent shall enroll in the society on payment of the prescribed annual membership fee decided by the General Body from time to time. However, the admission of any corporate body is purely the prerogative of the General Body provided such boy corporate.
- II. Is not adjudged by a court as insolvent – institution, or is an un-discharged insolvent institution or society.
- III. Has not been decreed to wind up any offence involving moral turpitude.
- IV. Is not carrying on business or activity of such kind which is in conflict with the objects and interest of the society.

- VI. All nominations for honorary membership shall be received by the board of Executive Members in the first instance, who shall be competent to scrutinize the case / cases and recommend to the general body such cases in their unanimous opinion deserve consideration.
- VII. Honorary members will not enjoy all privileges available to individual members. They will act as only advisors.

4. Subscription for Membership Categories: -

- I. All life members of the society shall pay a membership fee Rs. 100/- towards their subscription and the membership shall commence either on payment of the subscription of Rs. 100/- in lump-sum or on payment of monthly installments of Rs. 10/- all the executive members of the society shall be life members of the society.
- II. In the case of individual members other than life members. They shall pay Rs. 10/- per month each.
- III. Membership fee shall be payable in advance at the beginning of every financial year and subsequent payments shall be payable within one month from the day they to vote.
- IV. Any member, who fails to pay his / her subscription within three months from the due date, will automatically cease to be a member and will lose his / her right to vote.
- V. The general body shall however be competent to revise the rate of Membership subscription as deemed fit.
- VI. Every application for membership of a member, other than the initial promoters shall be made in the prescribed form accompanied by an admission fee. It may be fixed by the board of Executive Members. From time to time and shall be addressed to the secretary of the society.

- VIII. The membership of the member of any category shall liable for termination by a simple majority vote of the general body meeting on the report of the board of executive member that.
- IX. If the member has made default in the payment of membership fee for a period exceeding three months of that the be heavies of the member has been prejudicial of detrimental to the principles and objects of the society.
- X. - VII. The election for Board of Directors of Executive Committee may be secret ballot or by show of hands decided by the General Body. Each delegate on the date of notification of election and who has been a member for the last one only shall have the right to vote.
- VIII. The Director or Executive Committee thus elected shall be in office for a period of three Years.
- IX. Each member or representative shall have one vote. All the decisions and resolutions in the meeting shall be made by simple majority, unless the matter requires otherwise by the provision of the Act.
- X. The meetings of the General Body will be of two types.
- a. Annual General Meeting.
 - b. Special General Meeting.
- XI. The Board of Executive Committee may at any time call a special general body meeting of the society as the case may be. It shall call such meeting within Fifteen (15) days after receipt of requisition in writing format least 1/3rd of the total number of voting members / representatives as the case may be, or as per the direction of the Registrar. A requisition for a Special General Meeting contains the proposed agenda and the reasons why the meeting is felt necessary. Such meeting shall transact only the subject specified in the notice.
- XII. The Annual General Meeting shall be convened by the Board of Executive committee every year, in the month of April or within 6 months of the closing of accounting year.

6. Executive Committee: -

- I. The Board of Directors of Executive Committee shall consist of members elected by the General Body viz., President, Vice-president, Secretary, Joint Secretary, Treasurer and Members totaling 7 (Seven) members.

- II. The term of each Director / Executive Committee members shall be 3 years. All the Directors / Executive Committee members shall be elected at once and their terms staggered by drawl of lots specifying different term for each Director / Executive Committee member. Every year 1/3rd of the elected director shall retire by rotation. Elections shall be conducted before the expiry of the term of office of the outgoing members in the manner specified in the byelaws. The retiring Director / Executive Committee member are eligible for re-election.
- III. In case of any vacancy arising or the found, the General Body may fill these vacancies by cooption from eligible members or representatives as the case may be till the next elections are conducted casual vacancy arose.
- IV. The Board immediately after election shall elect Office Bearers including President and Vice-President, General Secretary, Joint Secretary and other Secretary if need be and the Treasure from among the Directors of Executive Committee Members. They shall be in office for a period of one year. The Board / Executive Committee has the right to remove a President / Vice President or any office bearer at any time during their and elect new once from among them.
- V. The Board / Executive Committee shall meet at least once in every calendar of Three Month. The Member / Representative of all the corporate body may be invited for the Board / Executive Committee meetings by the board for better decision making.
- VI. A Board Meeting shall be convened by manager by giving a 7 days notice sent by post or local delivery to all Directors / Executive Committee members. An emergency meeting if required may be convened with a short notice.
- VII. The quorum for a Board Meeting / Executive Committee shall be at least seven every decision will be taken by a simple majority. The President shall vote only in case of equality of Votes. Any Director / EC Member absent at three consecutive Board Meetings without leave of absence or who ceases

7. Power & Functions of Board of Directors / Executive Committee: -

In addition, the functions specified in the Act, the Board shall.

- I. Admit Members
- II. Interpret the society's objectives and set up specific goals to be achieved towards these objectives.
- III. Make, periodic appraisals, operational / Executive plans and budget.
- IV. Formulate rules for a administration and arrange for carrying on the administration of the Society as per the bylaws and the rules made there under.
- V. Raise funds for the society and control all financial affairs and management and review the accounts of the society.
- VI. Appoint attorneys / advocates, agents etc., for society to defend and institute legal proceedings on its behalf.
- VII. Acquire, purchase, own, lease, mortgage, hypothecate, dispose of any movable and immovable assets for attaining the aims of the society.
- VIII. Formulate polices on all staff matters including recruitment, selection, appointment, promotion, disciplinary action, suspension, removal, remuneration etc.,
- IX. Appoint a fulltime Manager or Chief Executive Officer.
- X. Fix fees, subscriptions, contributions, etc., to be paid by members to society for specific purpose as per the criteria laid down.
- XI. Open branches and / or area level offices for the efficient conduct of activities, administration convenience and greater community participation.
- XII. Appoint Mandal Level / Area Level thematic Management Functional Committees and such other committees with a specific function, powers, tenure etc., and reconstitute the same or remove any or all the committee members at any time.
- XIII. Make policies on utilization of funds of the society.
- XIV. Fill up the vacancies on the Board, if any by cooption as per the provision of the bylaws in the term of the vacating Director / EC Members.

- XV. Arrange for audit and submit the report and accounts to the general body.
- XVI. Formulate rules administration and policies governing the benevolent, relief and welfare scheme etc.,
- XVII. Authorise / Designate Officers for operation of accounts with banks and other organizations.

8. Powers of the Office Bearers: -

- I. **The President:** The President shall have overall supervision and control over the affairs of the Society. The President shall preside over all the Board and General Body meetings. The president shall be one of the signatories on all legal documents executed by the society. In any case the President shall not be perform his duties; the Vice President shall perform the duties of the President. In any case the Vice President shall not perform the duties the Secretary of any member shall perform the duties of the President.
- II. **The Vice President:** The Vice President shall discharge the duties, perform the functions and exercise the powers of the president, during the vacancy in the office of President, or in the absence of the president for more than one month.
- III. **General Secretary:** He / She is overall incharge of the activities of society. He / She shall prepare the minutes of all the meetings of the society of all the meetings budget and expenditure statement. He shall prepare agenda for all meetings. He shall collect the membership fee subscriptions, donations, Contributions and other to raise the funds for the society in accordance with the rules.
- IV. He/ She shall send notice for all meetings seven days well in advance he can represent the association in all legal matters. He shall maintain all property and records of the Associations.
- V. He / She shall maintain files and other relevant correspondence papers. He is the man empowered to deal with the all the matters rating to the society. He / She shall operate the Bank Accounts of the society jointly with the President and Secretary.

- VI. **Joint Secretary:** The Joint Secretary shall assist the Secretary to discharge the duties of the Secretary in the absence or at the request of the Secretary.
- VII. **Treasurer:** He / She shall receive all amounts collected in the name of the society and shall deposit in the bank. In the name of the society within three days from the date of collection. She shall maintain the accounts properly and produce them with all vouchers in the executive committee and general body meetings. He / She shall operate the bank account of the society jointly with the President and Secretary. She shall appoint the Chartered Accountant with the permission of Executive Committee and General Body. He / She shall arrange for the closing accounts ever year by 31st March.

9. Quorum: -

The Quorum of the general body is 1/3rd of the total members on roll. The quorum of executive committee is not less than 4 members. An adjustment of meeting for want of quorum doesn't needs a quorum.

10. Funds: -

- I. The society shall mobilize funds from its members both individual and corporate body as membership fee / admission fee, contributions, grants in cash or kind.
- II. The society shall mobilize funds in the nature of Grant, Contributions from Local Bodies, the Government Departments, Non-Government Organizations and any other State, National and International Institutions for the welfare of the members of the society to implement the programs as stated in the Memorandum of Association.
- III. The funds of the society shall be operated through a bank account, which shall be opened in a Nationalized Bank in the Name of the Society and jointly operated by the President and Secretary.

11. Amendments: -

No amendment or alternation shall be made in purpose of the association unless it is voted by 2/3rd of its members present at a meeting convened for the purpose and confirmed by 2/3rd of the member agreed at the second special meeting.

12. Certain Works Prohibited: -

The society shall not under take any activity with profit motive. It is purely a non-profit and non-political organization. It is only Uplift the poor and downtrodden people in all angles.

13. Staff of the Society: -

- I. The society through Executive Committee shall for the implementation of the programmes, Administration, Day to day management of the affairs, Recruit and Appointment skilled persons on Contract Basis, especially managers, One Chief Executive Officers. They may be taken / appointed on deputation or contract from any other institution who shall be accountable to the society. The staff shall be appointed in accordance in the service conditions laid down by the executive committee from time to time.
- II. The staff shall be jointly and severally liable for the losses caused to the society with will full negligence dis-honesty. The society, if required, shall prosecute such staff for the losses / damage done to the society willfully and dishonesty.

14. Area of Operation: -

The area of operation of the association shall be through out India. The executive committee has power to open / establish Field Administrative Offices. Field Branch Offices and appoint sub committees when and wherever necessary.
