## Additional disclosure notes\*

The following information is provided to assist the reader to understand the accounting statement and/or the Annual Governance Statement

### 1. Expenditure under S137 Local Government Act 1972 and S2 Local Government Act 2000

Section 137(1) of the 1972 Act permits the Council to spend on activities for which it has no other specific powers if the Council considers that the expenditure is in the interests of, and will bring direct benefit to, the area or any part of it, or all or some of its inhabitants, providing that the benefit is commensurate with the expenditure. Section 137(3) also permits the Council to incur expenditure for certain charitable and other purposes. The maximum expenditure that can be incurred under both section 137(1) and (3) for the financial year 2023-24 was £9.93 per elector.

In 2023-24, the Council made payments totalling £ 450.00 under section 137. These payments are included within 'Other payments' in the Accounting Statement.

### 2. Explanation of variances on accounts:

Box 3: Total other receipts increased by £7804.49 (33%)

Proceeds of the sale of a fixed asset (mower) for £2600. Allotment income included an insurance pay out of £655. Toilet account income included insurance pay outs totalling £835. Grants received for projects being £1731 greater than last financial year. Income increased from the Bryn Titli Windfarm fund by £1635, this is linked to power generation.

Box 5: Staffing cost increased by £10397.84 (53%)

National pay awards increased salaries for clerk and caretaker by £1356. Exiting RFO (previously Clerk/RFO) back holiday payment of £1054. The Clerk undertook a project requiring increased hours (from 15 to 25 hours per week) for 6 months at a higher pay scale, £3640. A change in the structuring of the Clerk/RFO position to 2 separate jobs and hours worked by the RFO fluctuating with the needs of the council, £3633.

## Auditor General's report and audit opinion

I certify that I have completed the audit of the Annual Return for the year ended 31 March 2024 of **Rhayader Town Council**. My audit has been conducted on behalf of the Auditor General for Wales and in accordance with the requirements of the Public Audit (Wales) Act 2004 (the 2004 Act) and guidance issued by the Auditor General for Wales.

### Audit opinion: Qualified

Except for the matters reported below in my Basis for Qualification, on the basis of my audit, in my opinion no matters have come to my attention to give cause for concern that, in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislative and regulatory requirements have not been met;
- is not consistent with the Council's governance arrangements; and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

### Basis of Qualification

#### Accounting Statement

I am unable to conclude whether or not the Accounting Statement properly presents the Council's receipts and payments financial position:

- The Council has not provided a complete explanation for significant variances within the year regarding total other receipts and staff costs.
- The Council has not provided a properly completed bank reconciliation as at 31 March 2024.

### Other matters and recommendations

I draw the Council's attention to the following matters and recommendations which do not affect my audit opinion but should be addressed by the Council.

#### Typo on the annual return

The Council must ensure that the balance carried forward of the prior year equals the balance carried forward of the current year.

There are no further matters I wish to draw to the Council's attention.
