## Person specification

1. You must be over 18 years old and have a valid photographic document to prove your age.

2. To aid the recruitment decision-making, you must be comfortable providing photographs of yourself in underwear only. This will allow us to better understand out product fitting and in relation to customer expectation.

3. If you are successful, you will be asked to fill in three feedback forms and provide us with photographs of yourself wearing our product, to allow assessment of fit before and after (comparing with your original photographs) and how your own assessment of

measurements and sizing reflect that of our product.

## Application process

1. Fill in the registration form

2. Provide your proof of age

3. Fill in the person specification form and provide us with required photographs of yourself.

#### Timelines

This recruitment is open-ended at the time of writing this job specification (22/04/2024). This means that the recruitment process will conclude on a date that will be specified later.

We envisage that the testing will take place in autumn 2024; we will inform successful candidates a minimum of 4 weeks in advance of providing them with samples.

# Job description MODEL

#### Contract type

- 1. You will be hired as a freelancer.
- 2. This means you will not be considered our employee at any point during the contract, but we will retain a duty of care for your health and safety when you are undertaking any work for us.

#### Dates

1. All candidates will be notified about the outcome of this recruitment, or any extension to the recruitment, by 31 August 2024.

2. Successful candidates will be issued with details related to product testing and expected date issuing of samples.

3. Successful candidates will be required to test the product for a minimum of 6 weeks and as per requirement provided in the document attached to the samples.

#### Pay

We will pay you the agreed sum based on your commissioned work.

You will need to have a Wise account to receive the payment.

3. We will not offer any advance payments and all payments will be settled once the work is completed.

4. The payment will be made in either USD or INR.

 We will pay you the agreed compensation only if and when we receive all forms completed with relevant information and within the set timeframe.

#### Testing process

1. We will provide you with product or products based on your own body type and sizing assessment.

2. You will be asked to fill in three questionnaires during the testing process.

The first questionnaire will ask about packaging and initial thoughts about the product we provide you with,

4. Completing the second questionnaire will be required within 3 weeks of receiving the product sample/s.

5. Completing the final questionnaire will be required after the 7<sup>th</sup> week of testing.

You can retain the product/s you have been testing at the end of the contract.
