

a review of April minutes in approval.

Horseshoe Bend City Council finance meeting, April 10, 2025, committee chair Sean Draper called the finance meeting to order at 6pm present where Alderman Alderwoman hilkerker, alderman, Booth, Alderman rains, Alderman Vickers, Alderman Dawson and Alderman Draper also present. Mayor Duane Delair and recorded treasurer, Bill Vander pass, absent city attorney Brad SIPP and Alderman Yancy all stood for the Pledge of Allegiance, followed by the invocation led by Alderman Miller. The minutes from the March 13 finance meeting was were read by recorded treasurer, Bill Vander pass, there were two typos. Alderwoman helker moved to approve the minutes with changes. Second by Alderman Miller. Minutes were approved by voice vote. Public comments. Tim Dietzel spoke about a project to eliminate silk build up and eventually mitigate excess lily pads, uses immersible pods. Motion was made to move the matter to Council, to the council meeting by Alderman Miller, seconded by Alder and booth motion passed by voice vote. Larry guinceman spoke about concerns about the city not having control of its Facebook page. She said that emergency services and shelter information could not be properly posted because office staff could not access the page. She asked the mayor to provide the login information, and he refused. She also made comments regarding the city attorney's potentially overlapping duties as city attorney, county attorney and prosecuting attorney. Her last questions were in regard to the location of city surveillance cameras. The mayor and your Irem said that they were still in their boxes as far as they knew. One staff city staff member said she last saw them in the mayor's office. The meeting was paused at 6:36pm while Laurie, the mayor and a couple council members searched for the cameras. They were not found, the mayor would not allow entrance to his office. The meeting was earned at 6:43pm a motion was made by Alderman Miller and seconded by Alderman Dawson to bring the Facebook matter to the council meeting. The motion passed by voice vote. A motion was made by Alderman Miller and seconded by Alderman Vickers to push the city attorney issued to the council meeting. The motion passed by voice vote. Old business, the matter of policy on forgiveness of capping of water bill when a catastrophic leak occurs was discussed. A motion was made by Alderman Miller and seconded by Alderman Dawson to bring the matter to the council meeting. The motion passed by voice vote. New business. Alderman Miller presented the idea of paying council members quarterly instead of semi annually. He stated that since they were required to make quarterly tax payments, they should get paid quarterly to cover those payments. A motion was made by Alderman Miller and seconded by Alderwoman hilicker to move the matter to the council meeting. The motion passed by voice vote. Alderman Miller brought up the issue of 1500 hours being spent on data Scout without Council knowledge. The mayor explained that this was for due diligence in trying to collect an unpaid on unpaid assessments. He claimed this is required as part of the settlement. He stated that Gail Fuller was helping him with this. A motion was made by Alderman Miller and seconded by Alderman Dawson to bring the matter to council. Motion passed by voice vote. There was a discussion on the mayor's efforts to limit the authority of the Parks and Recreation Director. A motion was made by Alderman Miller and seconded by Alderman Dawson to bring the matter before Council. Motion passed by voice vote. There was a discussion about a Spartan law, more lawn mower that had been purchased by Mr. ID and then brought to H and H for repair, where it sat for over a year. It turns out it was still under warranty at the time and should have been taken to a Spartan dealer for repair under warranty. Now it is unlikely. The warranty will be honored. A motion was made by Alderman Wendler and seconded by Alderman booth to bring the matter before Council. Motion passed by voice vote. There was a discussion about distributing amenity cards to property owners who have paid their amenity fee. This car would allow free and discounted Parks and Rec services. Parks and Recreation Director Dan Robinson spoke on several topics. He gave an update on the fire damage and insurance. He stated that the cart storage building could be repurposed as a smaller building built primarily from usable materials from the burnt building. This would save money. He also expressed the need for a safe, a safe in the pro shop and an additional Pro Shop stock. Alderman Dawson expressed very strongly that having the director meet with the public was absolutely a good thing. Mr. Robinson mentioned the desire to put handicap swings at the library and veterans park. He hoped that these could be funded from freed up funds. There was a brief discussion about the box on lawsuit. Dan is still waiting on attorneys. The status of the restaurant the community center was brought up looking at contract options and waiting for advertising for bids to be complete.

Bob Gehring spoke on behalf of the planning committee, they are looking at options for further trails and improvements such as restrooms. He identified an 8020 grant, which would involve an investment from the city of \$5,000 a motion was made by Alderman booth and seconded by Alderman Raines to bring the matter before Council. Motion passed by voice vote. There was a discussion about the parks bank account, which was created several years ago for veterans park. The park is in need of repairs, and involved parties would like to be able to use the money in that account for this purpose. A motion was made by Alderman Dawson and seconded by Alderman Raines to consider the matter at the council meeting. Motion passed by voice vote. Alderman Raines brought up the idea of allowing property owners to use their properties for short term camping. There was much discussion pros and cons. Raul Johnston mentioned that zoning code would need to be changed your ime gave an update on the stocking of the Golden shiners in the lakes. Alderman Dawson stated that he no longer believed that the city should be giving free use of the community center to fishing and Sportsman's club talk around Alderman helicer reminded people about the dogwood today's festivals on April 12, Alderman Dawson motion to adjourn the meeting, seconded by Alderman booth motion passed by voice vote. Meeting adjourned at 8:25pm,






