The meeting began with a roll call and the approval of previous meeting minutes. The council debated the hiring of Dan Robinson as Parks Superintendent and Alan Bathwick as Golf Course Superintendent, which failed. Ordinances were discussed, including one to limit the mayor's spending, another to require committee meetings in the council chambers, and several to remove members from various committees. The meeting concluded with public comments and a motion to commend Raul Johnston for upholding zoning laws.

- [] Correct the agenda to properly reflect the order of the ordinances related to removing individuals from committees.

- Unknown Speaker calls the meeting to order and conducts a roll call, confirming the presence of Alderman Nancy, Alderman Miller, Alderwoman Hooker, Alderman Booth, Alderman Draper, and Mayor Delair.
- Mayor Delair leads the Pledge of Allegiance and a prayer for healing and unity for the city.
- RT Vanderpas reads the minutes from the previous city council meetings on April 28 and March 24, 2025, including motions to accept minutes and treasurer's reports.
- Public comments include Superintendent Fred Walker discussing a millage approval for classroom expansion and Raul Johnson raising procedural issues at the zoning committee meetings.

Committee Reports and Public Comments

- RT Vanderpas reports on committee reports, including motions to accept them and a discussion on procedural issues at the zoning committee meetings.
- Gail Fuller speaks about her support for the mayor and her contributions to the planning committee.
- Carol Spencer writes a letter opposing several proposed ordinances.

- Discussions on stocking the pro shop at Turkey Mountain and funds in the park funds account lead to motions and approvals.
- A presentation on sprinkler heads at the golf course leads to a motion to approve payment for replacement sprinkler heads.

New Business and Resolutions

- Resolution 2025-23 is read, giving permission for the planning committee to pursue a bike trail 8020 grant, and a motion is made to approve it.
- Ordinance 2025-03 is read, directing the mayor to give the city Facebook credentials to the recorded treasurer, and a motion to suspend the rules and read it by title only is made.
- Ordinance 2025-04 regarding water fee mitigation is read, and a motion to approve the resolution changing the payment schedule for council members is made.
- Ordinance 2025-06 is read, involving granting purchase authority of up to \$5,000 within budget for the Parks and Recreation Director, and a motion to suspend the rules and read it by title only is made.

Vetoes and Citizen Statements

- Mayor Delair vetoes Ordinance 2025-03, stating that the city can create a new Facebook page without changing the live feed setup.
- RT Vanderpas responds to the veto, explaining the difficulties in creating a new Facebook page.
- Mayor Delair vetoes Ordinance 2025-06, stating that the temporary Parks and Recreation Director should not have the ability to spend money without direct supervision.

• Citizen statements include Mitzi Ballman supporting Eric Gratz and Gail Fuller on the planning committee and Ceil Shorr opposing the city council's agenda.

Finance Report and Committee Reports

- RT Vanderpas discusses the finance report, highlighting concerns about revenue versus expenses and a hidden \$159,000 insurance check.
- Committee reports include animal control, public library, public works, recycling, building committee, code enforcement, fire department, and airport.
- A motion is made to accept the committee reports, and it is approved by voice vote.
- Discussions on the need for a new Facebook page and the challenges faced in creating one continue.

Ordinances and Motions (Continued)

- Ordinance 2025-04 regarding water fee mitigation is read again, and a motion to approve it is made.
- Ordinance 2025-08 is read, involving library security and access control, and a motion to approve it is made.
- Ordinance 2025-09 is read, limiting the spending of the mayor, and a motion to approve it is made.
- Ordinance 2025-16 is read, requiring all city committees to hold their meetings in the council chambers, and a motion to approve it is made.

New Business and Resolutions (Continued)

- Motions are made to hire Dan Robinson as the parks superintendent and Alan Bathwick as the golf course superintendent, but both fail to pass.
- Ordinance 2025-11 is read, directing the mayor that he is not a voting member on city committees, and a motion to approve it is made.
- Ordinance 2025-12 and 2025-13 are read, removing Eric Gratz and Gail Fuller from the planning committee, and motions to approve them are made.
- Ordinance 2025-14 and 2025-15 are read, removing Rick Broderick from the building committee and the zoning adjustments committee, and motions to approve them are made.

Public Comments and Closing

- Gail Fuller announces a community event at Veterans Park on June 14, inviting everyone to attend.
- Cindy Parson questions the council about the financials and the removal of volunteers from committees.

- Raul Johnston addresses the council regarding his integrity and the decision on a variance request, requesting commendation for upholding the law.
- The meeting is adjourned after a motion to approve the minutes and a discussion on the procurement process.

Meeting Minutes from the city council meeting, April 28 2025 Mayor Delair called the meeting to order at 6:01pm roll call was taken. All council members were present. The mayor, recorded treasurer and the city attorney were also present. All stood for the Pledge of Allegiance and Ruben Rangel reformed, performed the invocation, prayer the meeting. Minutes from the city council meeting from March 24 2025 were read by recorded treasurer, vanderpass. Motion to accept the minutes was made by Alderman Miller and seconded by Alderman Draper. Minutes were approved by voice vote. Motion to accept Treasury's report was made by Alderman Miller and

seconded by Alderman Raines. The report was approved on voice vote. Committee reports, motion to accept committee reports was made by Alderman Dawson and seconded by Alderman Yancey. The report was approved on voice vote. Public comments. Superintendent for ICC Fred Walker spoke about a millage approval on the ballot for the May 13 election involves curricular classroom expansion. If the measure is approved, the school district will receive 40% match from the state. Individual property taxes will not go up. Raul Johnson spoke about procedural issues at the zoning committee meetings. A discussion ensued as to whether the mayor was authorized to vote at committee meetings other than finance, according to the Municipal League per Brad CIPP, the mayor is not authorized to vote at these committees. Pat Gill spoke as a supporter of the mayor and asked that the community try harder to get along. Gail fuller spoke at length about what she has done helping the mayor with the assessments still owed. She also spoke about the planning committee accomplishments thus far. Carol Spencer wrote a letter about her opposition to many of the proposed. to call the meeting to order. Ordinances, old business attorney Brad Sipe asked the Council for some direction in pursuing the box Hall Marina lawsuit. He stated that he had not received any documentation from the attorneys of record. A motion allowing mister SIPE to obtain documentation on the lawsuit in order to possibly join the suit was made by Alderman Miller, seconded by Alderman Draper. The measure passed on a roll call vote. Alderman booth abstained. There was a discussion on the tipping fee being charged on water bill, after advice from the city attorney, a motion was made by Alderman Miller, seconded by Alderman Draper, to have water department cease charging the tipping fee and credit customers back. Motion passed by voice vote. A motion was made by Alderman Miller, seconded by Alderman booth, to provide \$5,000 from Parks and Recreation to provide pods on Crown lake as a two year trial motion passed by voice vote. There was a lengthy discussion about stocking the pro shop at Turkey mountain. Director Dan Robinson spoke about obstacles and purchase minimums, a motion to amend the pro shop budget from 4000 to 15,000 with a required itemized list submitted before purchase was made by Alderman Miller and seconded by Alderman Vickers. Motion passed unanimously by roll call vote. There was a discussion about funds in the park funds account, a motion was made by Alderman Miller and seconded by Alderman Dawson to allow use of all but \$100 of these funds for needed improvements at veterans park, measure passed by voice vote. There was a discussion about approving payment for replacement sprinkler heads at golf course, Interim Superintendent Alan brathwa did a presentation on the sprinkler heads. The mayor said he would sign the check after the name of the building was changed from Mr. Id to city of Horseshoe Bend, new business resolution 2025 dash 23 was read by recorded treasurer. It gives permission for the planning committee to pursue a bike trail. 8020 grant. A motion was made by Alderman Miller, seconded by Alderman Dawson to approve motion passed by voice vote. Alderman Draper and others in the audience had contrary opinions during the heated discussions. Alderman booth excused himself for the meeting 9:05pm, ordinance 2025, 16 was read by the recorded treasurer for the first time. It requires that all committee meetings be held in council chambers. When Miss Broderick's position was eliminated, she promised to give the log in credentials to me through the mayor. To date, both she and the mayor have refused to provide this information. This Facebook page is very important to the city. It is a means for posting important information for the residents about city government, safety information, polling locations, emergency shelter locations, as well as live streaming and recording of important council meetings. I am a computer expert, and if I can do it, nobody can do it, and it's nothing to do with me. It's Facebook is suspending it immediately, probably because the names are similar.
