ADDITIONAL WALKS outside the designated days of the week, such as those days that exceed the agreed monthly number, are possible at least **48h** before their commencement, and are calculated and settled outside the contract via **TWINT**

Payments should be made in advance for entire month at Hundesitter account number: **CH 5700 2762 7611 7515 40 U**

Exclusion of liability:

According to Art. 56 of the Swiss Code of Obligations (CO), the owner of an animal is in principle liable for the damage caused by the animal. The owner within the meaning of the law is the person who exercises actual control over the animal. The dog owner is also liable for his so-called assistants, for example those who walk his animal.

Liability insurance:

It is therefore important that your dog is covered by liability insurance. As proof, please enclose a copy of your liability insurance with this contract, or certify with an additional initial next to this paragraph in the form of a certificate that you have such insurance, without attaching a copy thereof.

Diseases and vaccination:

The dog owner undertakes that his dog has no contagious diseases. The dog sitter must be truthfully informed about any illnesses. The dog should be vaccinated according to its age.

Cancellations:

If either party has the opportunity, the date and hour of the walk can be changed without any fee, at least 48 hours before its start, if this time would be shorter +15CHF will be charged from the party willing to make this change.

Cancellation of the whole contract can be carried out with a minimum period of two moth's notice, otherwise the party terminating the contract shall bear the full cost of two months of care.

Behaviour of the dog:

PLACE/DATE

The dog owner assures the dog sitter to have answered all questions about the dog correctly and holistically. Any potential danger, previous misbehaviour and in particular third-party damage to the dog must be communicated.

Communication:

WhatsApp/Telephone communication between dog owner and dog sitter.

Photos:

Hundesitter may take photos/videos and use them in his social media/website.
