India finds and treats its 'Missing Million' TB cases

Ahmedabad: Since the launch of the new National Strategic Plan (2017-25), there has been a 38% increase in TB case notifications to the government - from 17.36 lakhs in 2017 to 23.98 lakhs in 2019, informed Mr. Vikas Sheel, Joint Secretary, Ministry of Health and Family Welfare, Government of India during a media sensitization workshop on TB in New Delhi. He further added that the government has been

successful in closing the notification gap (between estimated incidence and notified cases), referred earlier as the 'missing million', to less than 3 lakhs, through greater engagement with private sector health care providers. Mr. Sheel added, "The TB program has come a long way in the last few years and the increased number of notifications is an important step in the elimination of the disease from the country. (19-10)
