Lake Chaparral does have a leash law. The board does follow the bylaws and covenants and a \$25 fine will be issued when we can we can identify the dogs owner that is the extent of our legal authority this issue is not just centralized in Lake Chaparral but all through out Linn County who is absent of an animal control We are aware of the advice that is issued out buy local law enforcement. Citizens approaching the county of these issues may make more of a head way than with local police. The board will be willing to hear concerns and frustrations of the loose dogs and will continue to issue fines we will encourage the community to fill out POA nuisance forms at the office and attend the commissioner meetings as well. At this time there will be no other comments of this matter. Moving on to new business we will talk about the status of the office.

After further—investigation we have seen the dogs at Cindy K. she has let them in and out of her house and even has them pinned up on her property so that is where the fines will now be sent to. I personally just sent her a letter with the fines.
